III. Discussion regarding the Board of Education Special Meeting (School Facilities/Campus Revitalization) Summary

The committee discussed the current draft of the "Bricks and Mortar" newsletter, which serves as a public recap of recent Board of Education (BOE) meetings regarding school facilities. Keep communication concise, high-level, and readable (avoid overly technical detail).

Balance transparency with avoiding confusion or misinterpretation. Edits discussed were to improve organization/flow (chronological structure, clearly

distinguish traditional renovation" ("little r") vs. "renovate as new.", avoid presenting uncertain cost estimates (e.g., \$51M) as definitive, use verified historical figures (2017 estimates) where appropriate, ensure tone remains neutral and non-advocacy-based.

- IV. Discussion on website updates/changes with regard to the school facilities/campus revitalization project
The committee discussed the potential for creating a "Get the Facts" style document or consolidating previous "Bricks and Mortar" updates into a more concise format on the district website. Possible developing a BOE-controlled, neutral "facts" or Q&A document.
