Notice is hereby given that on **Tuesday, August 6, 2024** the Board of Trustees of the New Deal Independent School District will hold a New Deal ISD - Regular School Board Meeting at **6:30 PM**, at the at the New Deal ISD - Board Room, 401 S. Auburn Ave., New Deal, Texas 79350. The subjects to be discussed are listed on the agenda, which is attached to and made a part of this Notice.

If, during the course of the meeting covered by this Notice, the Board of Trustees should determine that a closed or executive meeting or session of the Board of Trustees is required, then such closed or executive meeting or session as authorized by the Texas Open Meetings Act, Texas Government Code Section 551.001 et seq., (the "Act") will be held by the School Board at the date, hour, and place given in this Notice or as soon after the commencement of the meeting covered by this Notice as the School Board may determine at its discretion. The Board of Trustees may meet in such closed or executive meeting or session concerning any and all purposes permitted by the Act, including, but not limited to the following sections and purposes:

Texas Government Code Section:

- 551.071 Private consultation with the board's attorney.
- 551.072 Discussing purchase, exchange, lease, or value of real property.
- 551.073 Discussing negotiated contracts for prospective gifts or donations.
- 551.074 Discussing personnel or to hear complaints against personnel.
- 551.076 Considering the deployment, specific occasions for, or implementation of, security personnel or devices.
- 551.082 Considering discipline of a public school child, or complaint or charge against an employee brought by another employee.
- 551.0821 Discussing students if personally identifiable information about the student will necessarily be revealed by the discussion.
- 551.083 Considering the standards, guidelines, terms, or conditions the board will follow, or will instruct its representatives to follow, in consultation with representatives of employee groups.
- 551.084 Excluding witnesses from a hearing.
- 551.087 Discussing commercial or financial information received from a business prospect the district seeks to have locate, stay, or expand in or near the district and with which the district is conducting economic development negotiations or to consider an offer of a financial or other incentive to such a business prospect.

Should any final action, final decision, or final vote be required in the opinion of the School Board with regard to any matter considered in such closed or executive meeting or session, then the final action, final decision, or final vote shall be either:

- (a) In the open meeting covered by the Notice after the School Board reconvenes in open meeting; or
- (b) At a subsequent open meeting of the School Board upon proper Notice thereof, as the School Board shall determine.

The meeting will be held in compliance with Texas Government Code Section 551.001 et seq. The meeting is also being conducted in accordance with the Americans With Disabilities Act [42 U.S.C. 12101 (1991)]. The facility where the meeting is to be held is wheelchair accessible, and handicapped parking is available.
