RESOLUTION CANVASSING RETURNS  
OF VOTES OF SCHOOL DISTRICT SPECIAL ELECTION  
HELD ON NOVEMBER 4, 2025

BE IT RESOLVED by the School Board (the "Board") of Independent School District No. 2609 (Win-E-Mac) (the "District"), as follows:

1. It is hereby found, determined and declared that the special election of the voters of this District held on November 4, 2025, was in all respects duly and legally called and held.

2.. As specified in the attached Abstract and Return of Votes Case, a total of 473 voters of the District voted at said election on the question of the Approval of School District Referendum Revenue Authorization (Question 1), of which 273 voted in favor and 200 voted against the same.

3. Question 1, having received the approval of at least a majority of such votes, is hereby declared to have passed.

4. The school district clerk is hereby directed to certify the results of the special election to the County Auditors of Polk County and Red Lake County.

5. The school district clerk is further directed to notify the Commissioner of Education of the results of the special election and to provide the certified vote totals for the ballot question in written form within 15 days after the results of the election have been certified by the Board.
