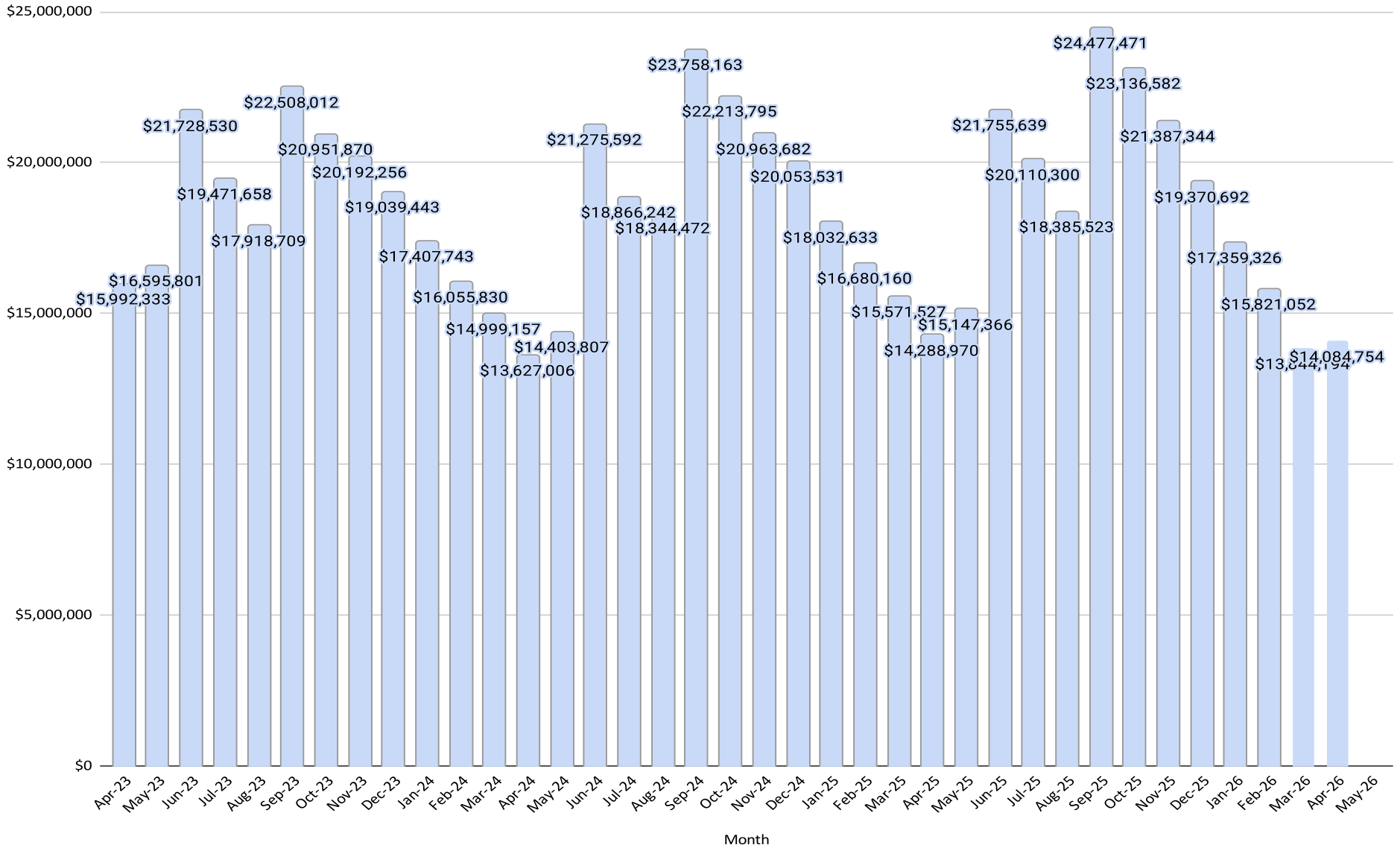

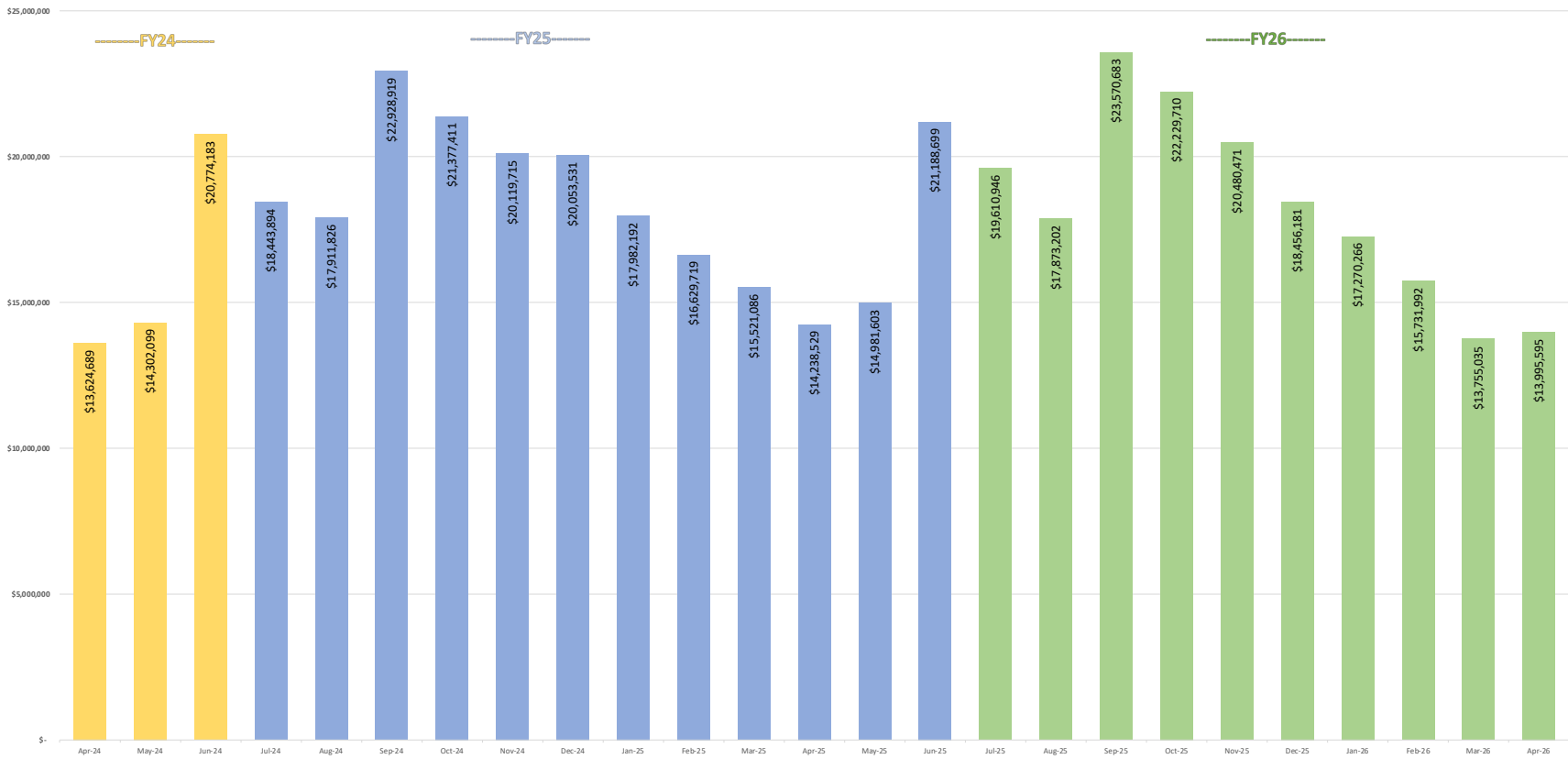

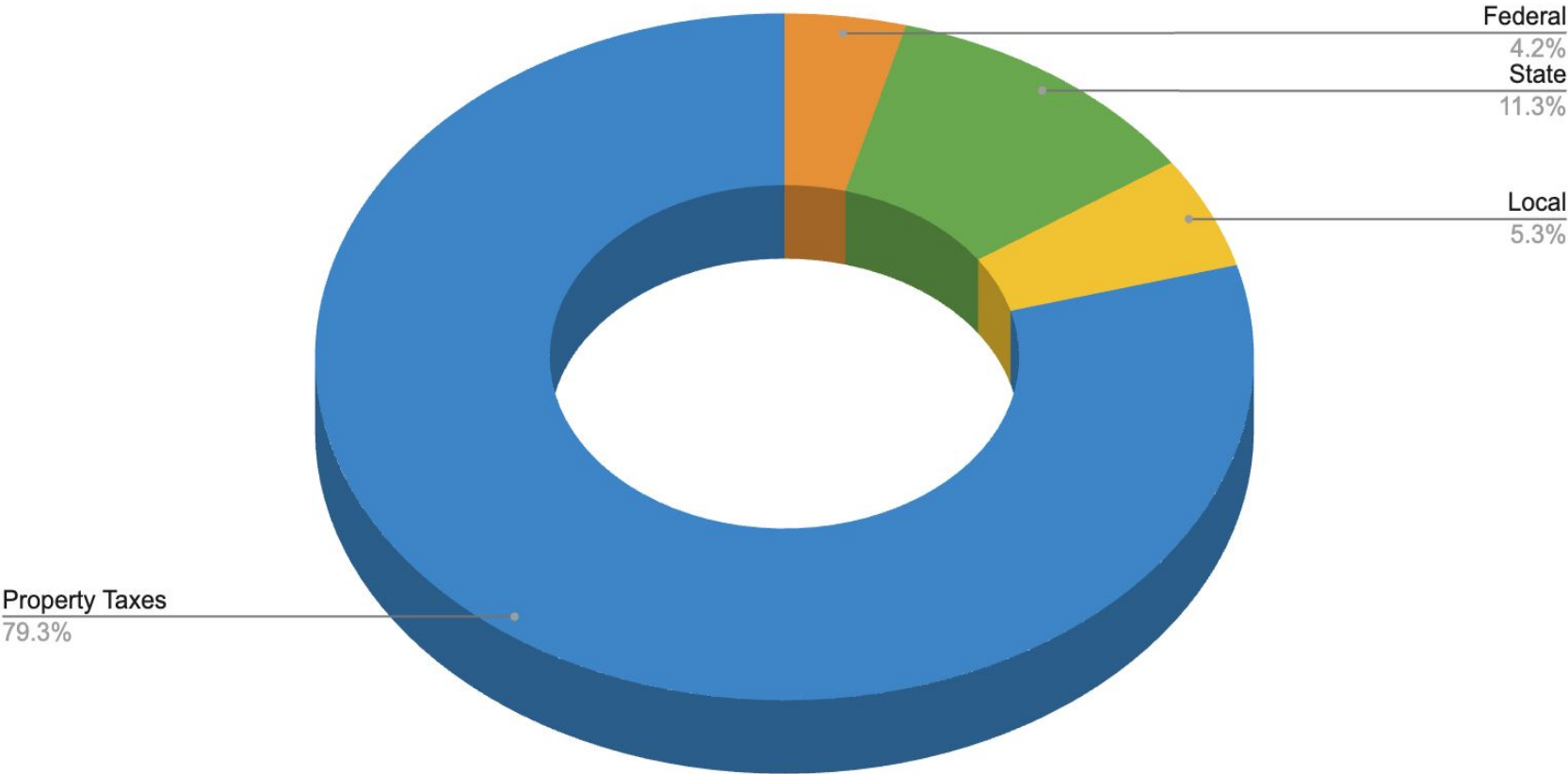

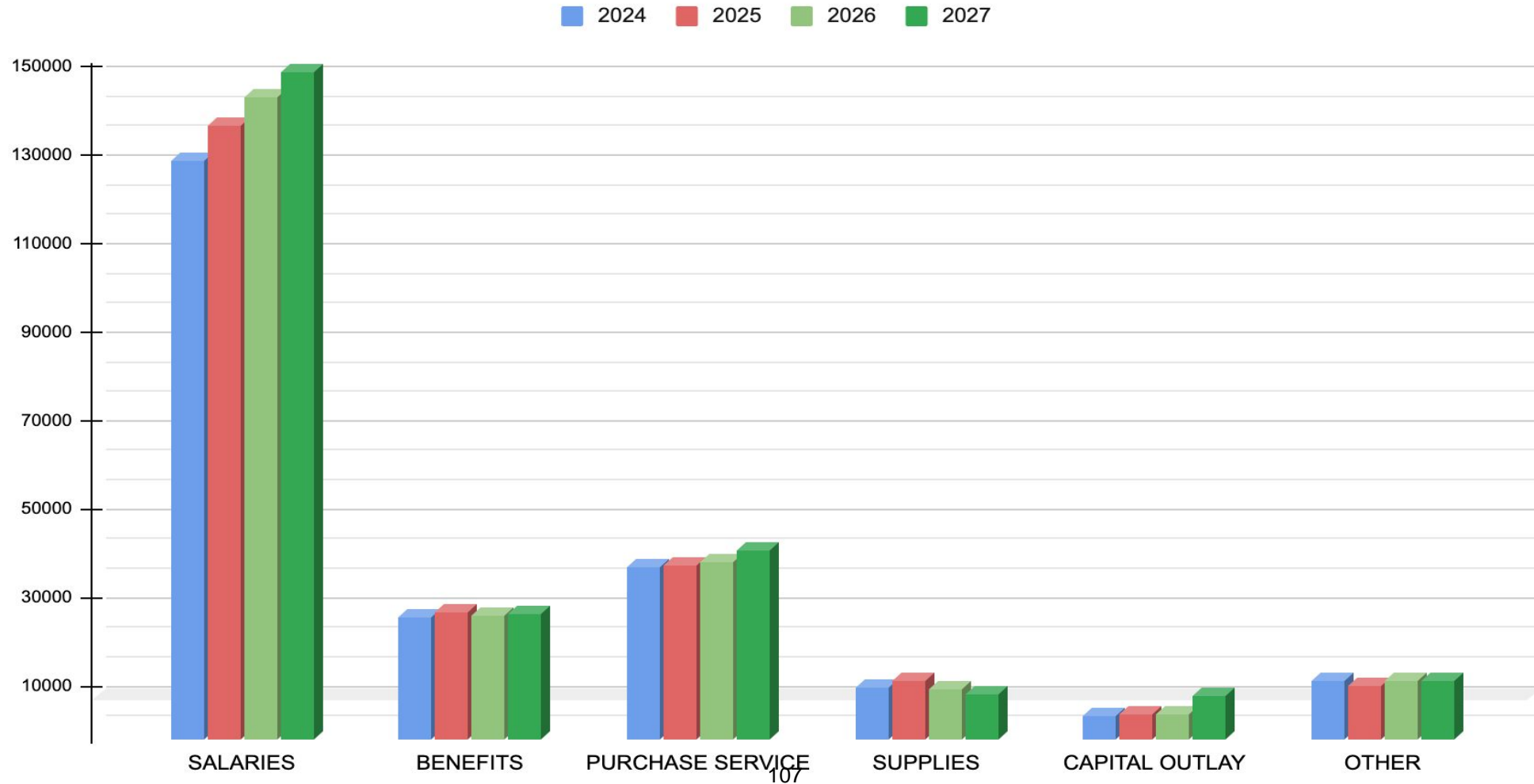

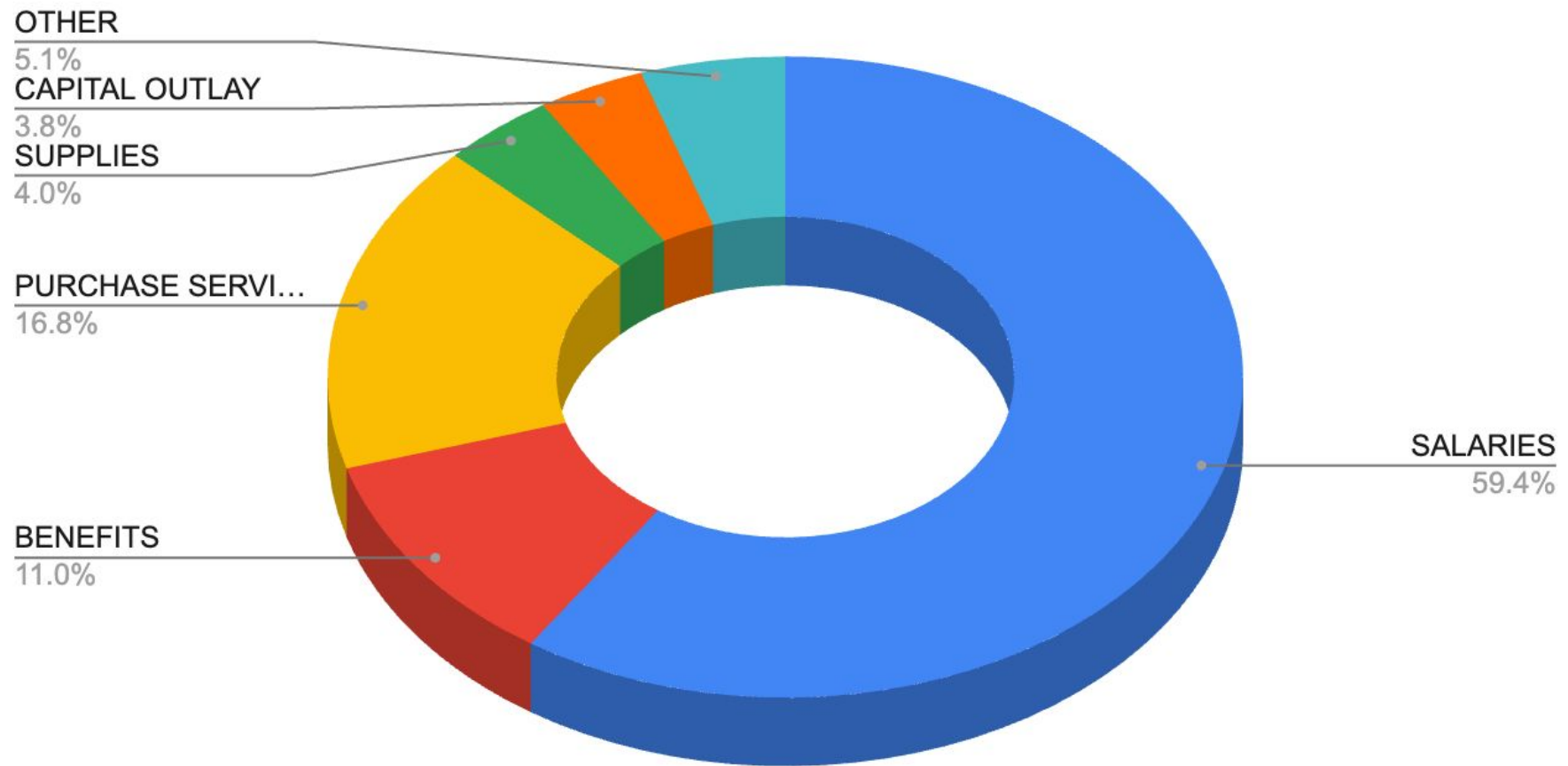

**SUBJECT:** Breakfast and Lunch Fees

**BACKGROUND:** Darien 61 has not increased meal fees in two years, despite significant increases in labor and food costs. Currently, a fully paid breakfast is \$2.85 and a fully paid lunch is \$4.00. Consequently, the food program is operating at a deficit. While nearby districts charge up to \$3.15 for breakfast and \$5.00 for lunch, our proposed increases aim to mitigate rising costs rather than generate a surplus.

We have analyzed the bids and the qualifications of the bidders and recommend that the contract for the Pavement Improvements project be awarded to the lowest responsible, responsive bidder, Briggs Paving. Their total base bid proposal is for \$ 209,800.00. This includes allowance monies in the amount of \$15,000.00 which will be returned to the school district if not used at the end of the project.

Contractors were also asked to provide pricing for one alternate. Briggs Paving provided the following prices:

1. Amount to be subtracted to the Base Bid to remove all scope related to the existing and new building signage. (- \$19,750.00). We recommend not accepting this alternate.

Studio GC recommends the acceptance of the total bid proposal for a total contract amount of \$ 209,800.00. This bid is in alignment, and we recommend the Board of Education take action to award the contract at the next available Board meeting.

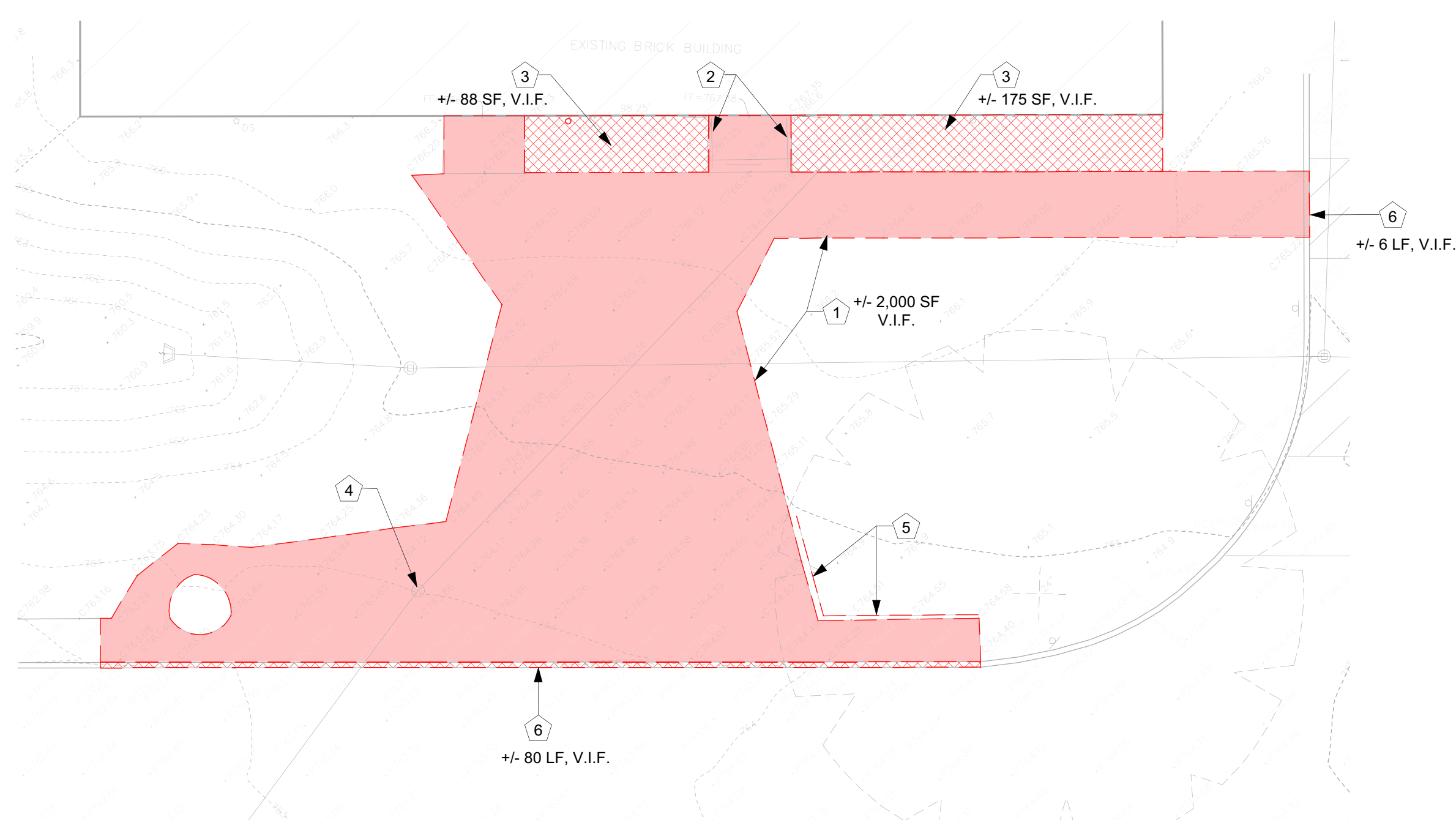

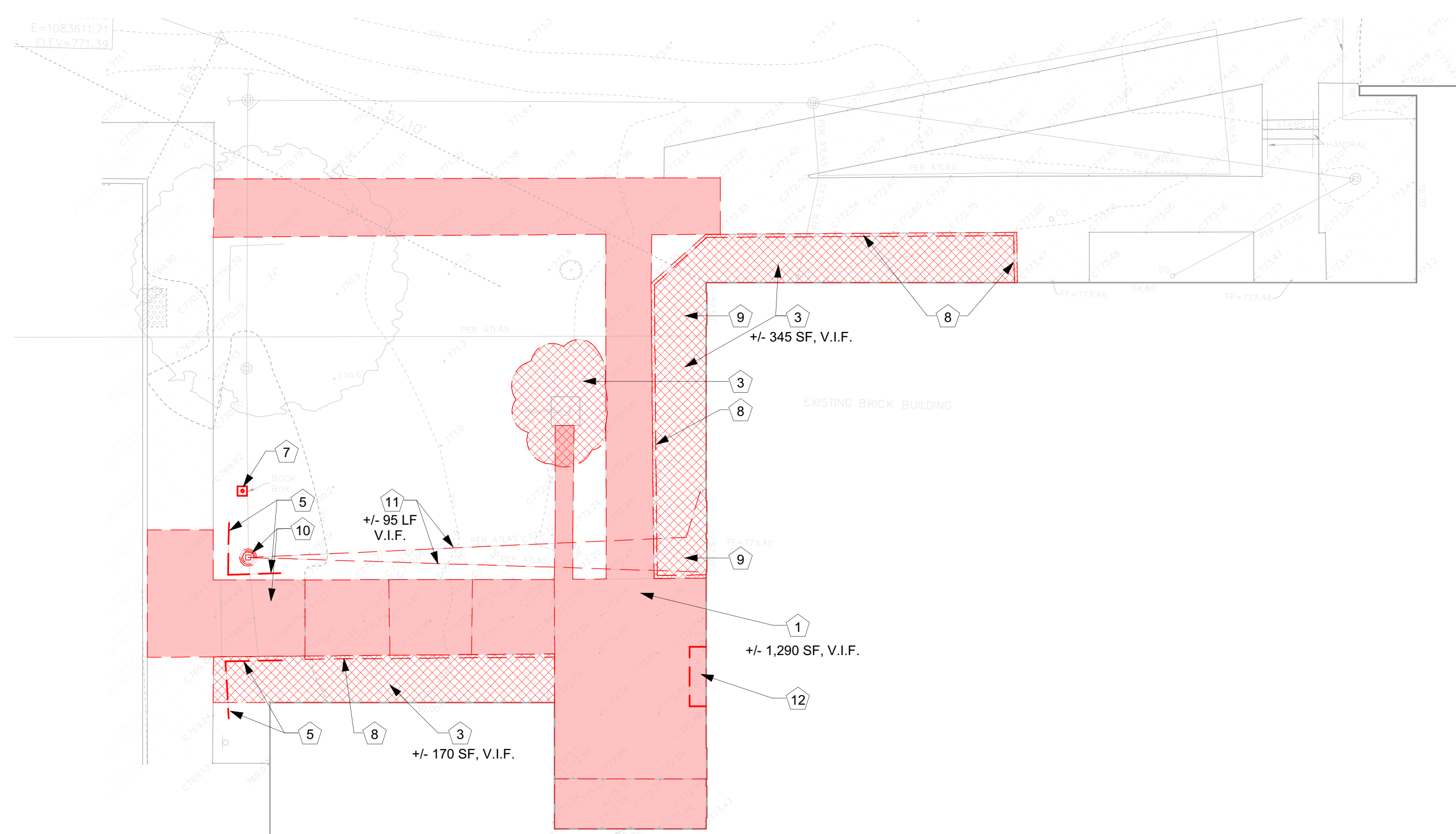




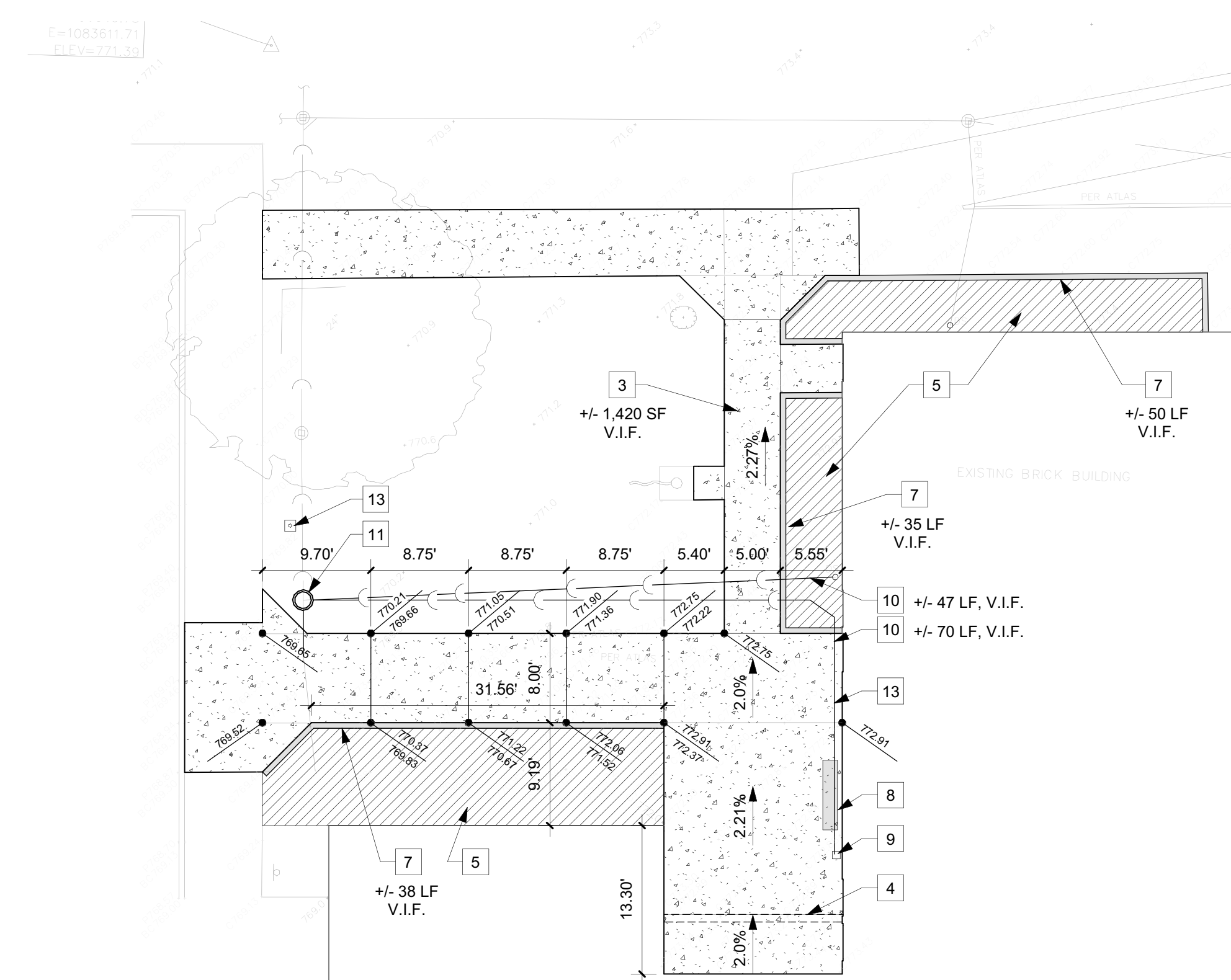
1 PARTIAL DEMOLITION SITE PLAN - SOUTH
