Proposed Timeline

August 27- List of possible schools involved presented to Board.

August- Parents and city notified of potential boundary change.

September- Process presented to School Community Council members.

October 8- Initial boundary options presented to the Board for review.

October- Patron feedback gathered via surveys.

October- Open houses held at schools.

November 12- Summary of patron feedback presented to Board. New options and survey created and sent out if necessary.

November 26- New boundaries tentatively approved by Board.

January 14- Boundary officially approved by Board .

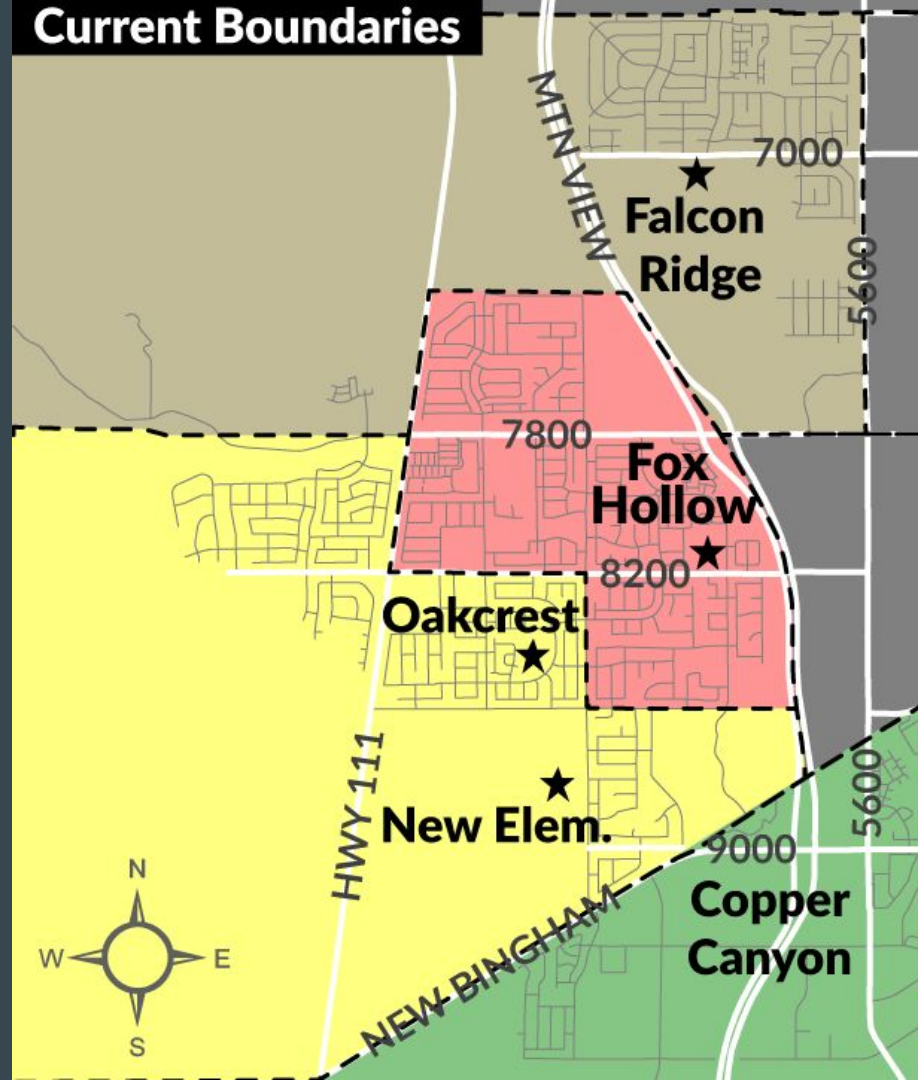
Priorities Considered in Developing Boundary Options

1. Create longer-lasting boundaries
2. Allow room for growth
3. Avoid crossing busy roads
4. Align feeder systems
5. Follow natural boundaries
6. Balance enrollment size
7. Reduce busing
8. Follow city boundaries

Boundary Considerations

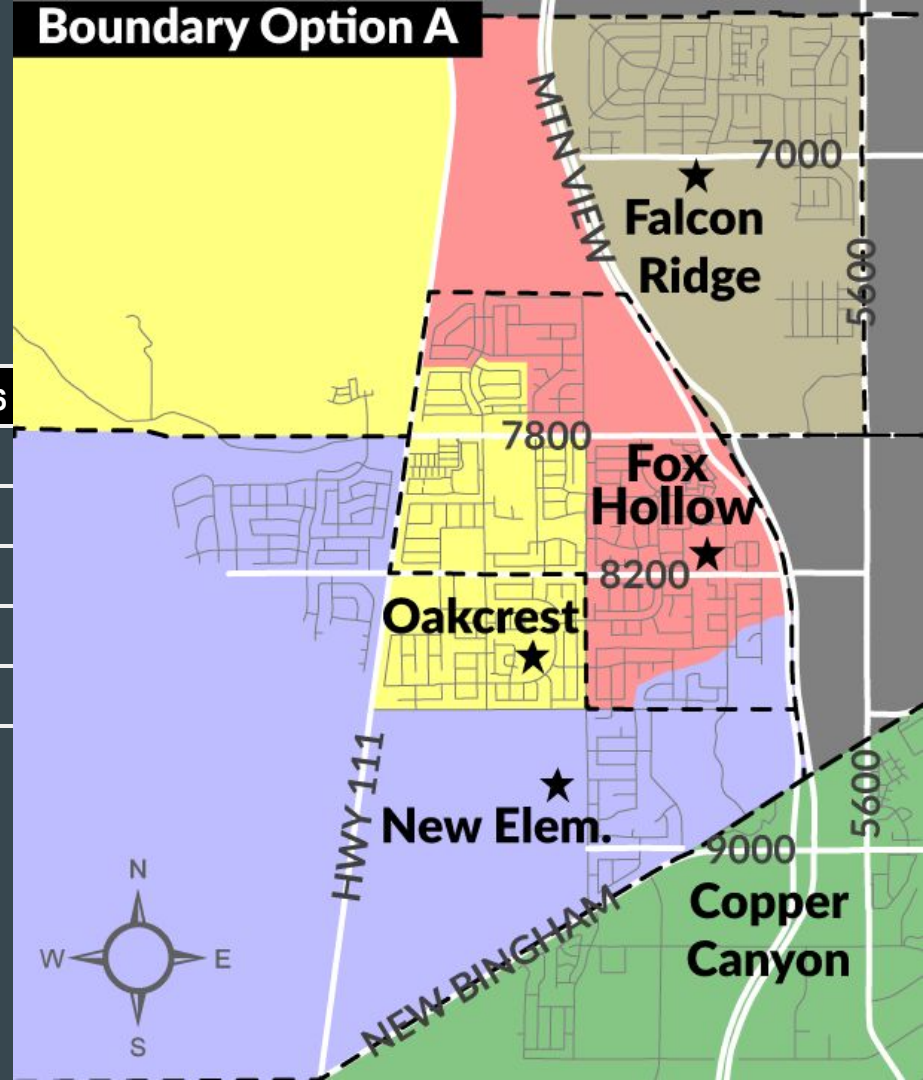
- Many busy roads and highways in this area.
- Numbers include DLI and permit estimates.
- Schools are located relatively close to one another.
- This move would allow Fox Hollow to move to a traditional calendar.
- Falcon Ridge changes are only to currently unoccupied areas.
- Copper Canyon, no change.
 - Low enrollment
 - Avoids crossing New Bingham
 - Future boundary options could include other neighboring schools

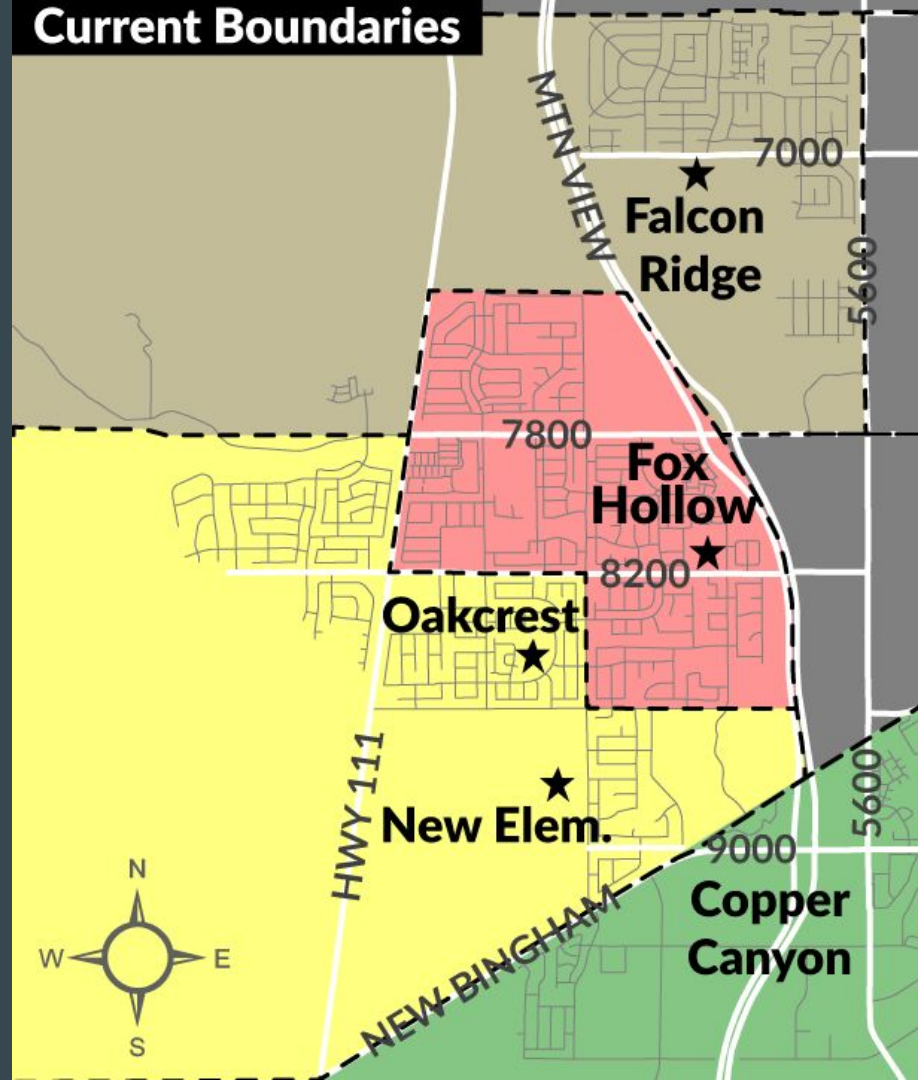

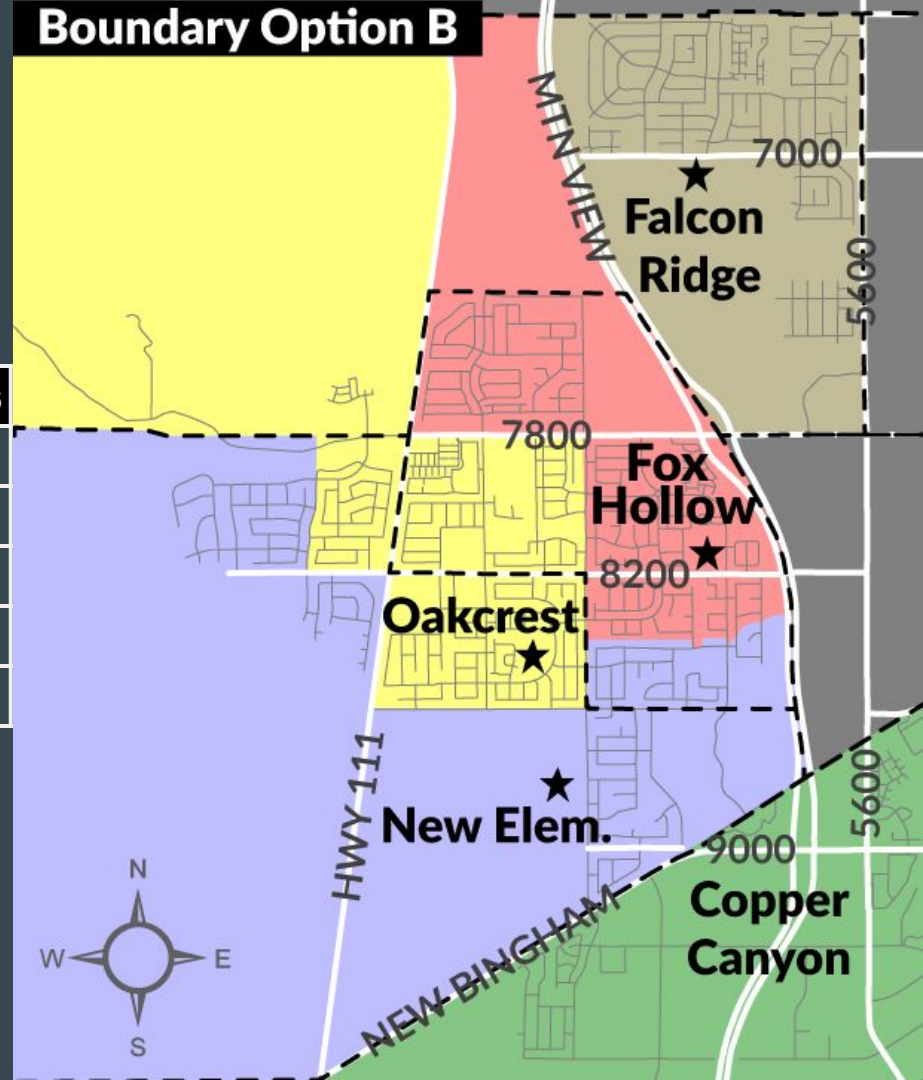

Overview

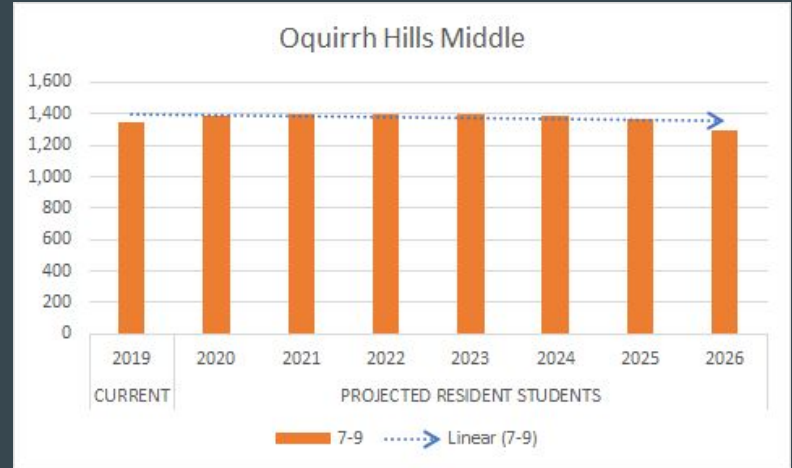
- Board requested to study options for middle schools in the southeast area of the district.
 - Specifically, Oquirrh Hills Middle School's ability to accommodate anticipated enrollment.
- We have met with the principals to discuss housing and projected enrollment.
- Recommendation for southeast area middle school boundaries.

Current enrollment: **1,306**

Current capacity including portables: **1,456**

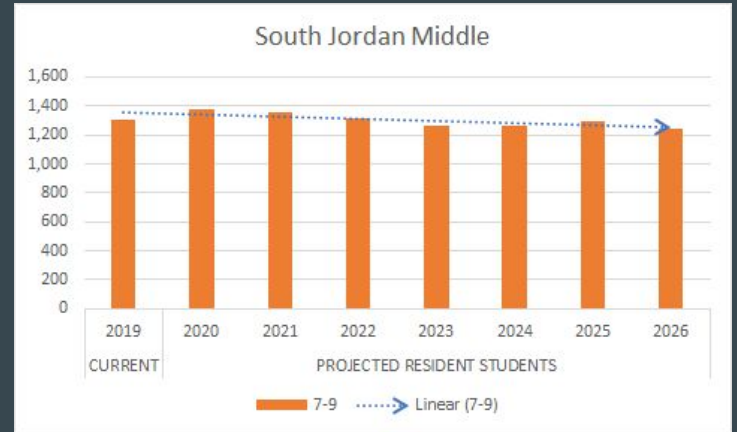

- Current capacities are capable of sustaining projections.

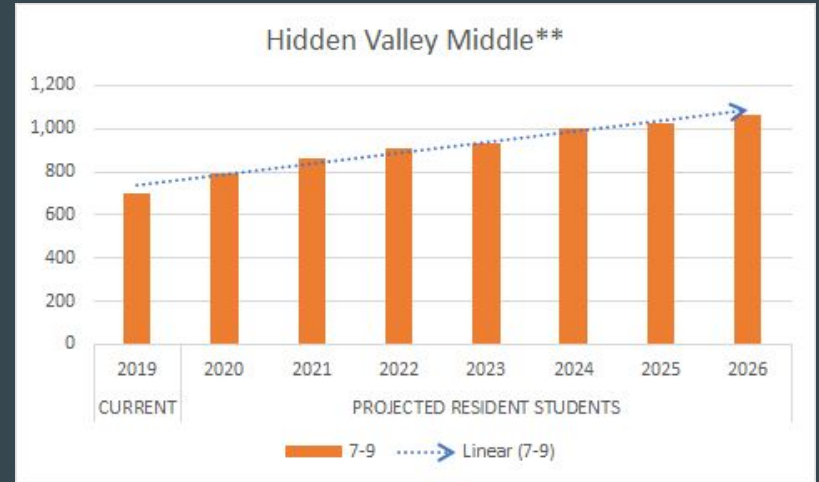

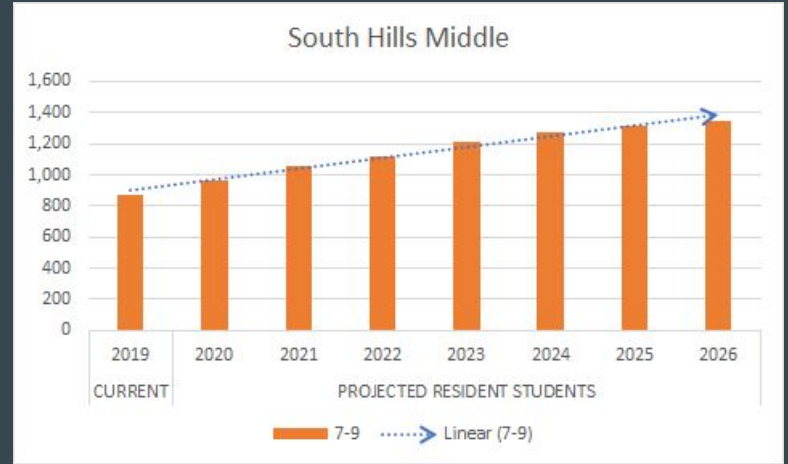

- Current permits: 112 (29 DLI)

- Students have the opportunity to develop the skills and knowledge that lead to a love of education as life-long learners.
 - Evidenced by positive attendance records
 - Academic evidence through high proficiency levels on assessments
- Students develop emotional intelligence and resiliency through character education and training.
 - Evidenced by number of school counselor visits/referrals
- Students develop an educational self-reliance and responsibility for learning.
 - Evidenced by numbers of missing assignments
 - Academic grades
- Levels of at-risk students indicators are decreased through school interventions
 - Evidence of declining number of students with at-risk indicators
- Students advance to high school with full credits in line for graduation.
 - Evidenced by the decreasing number of students who are credit-deficient at the end of 9th grade.
- Students score at or above proficiency level on state assessments and school-based common assessments.
 - Evidence of student growth from year to year
 - Evidence of high achievement levels
 - Academic grades
- Students learning English as a second language demonstrate progress in English language development.
 - Evidenced by increased levels on the WIDA assessment
- Students are provided with opportunities and experiences that expose them to a variety of content areas, including STEM, music, art, physical education, leadership, etc.
 - Evidenced by elective class enrollment
 - Extra-curricular activity participation numbers.
- Students gain an understanding of and demonstrate positive citizenship.
 - Evidenced by citizenship grade
 - Numbers and percentages of discipline referrals and suspensions.
