What is T-Mobile Friday Night 5G Lights?

 - 1,000 schools win \$5,000 through weekly sweepstakes
- Important Dates
 - Application due September 18th
 - Public voting runs from October 8-25

- Application:
 - We will need to show photos of the areas that need upgrades
 - 700 words on
 - Why our school needs an upgrade
 - What makes our Friday nights special
 - How the upgrade would impact our community
- Hold a Virtual Meeting with the following to explain the contest and to ask them to share our content on Instagram and Facebook:
 - Football Boosters
 - Football Coaches
 - Cheer Coach
 - Cheer Boosters
 - Band Directors
 - QMPO
 - Local Businesses that sponsor football
 - Football, Band and Cheer Parents
- Send an email to the QCSD community explaining the contest and encouraging participation - the more shares, the more likely we'll win
- Include information about the contest in our weekly newsletter, QCSD website and QCHS website

At Alumni Field:

- Gronk Augmented Reality - We will need to "Snap a selfie with Gronk" and share our Gronk content on social and tag @TMobile, along with #FN5GL and #Entry
 - Posters will be posted throughout the football field to encourage guests to participate
- PA Announcements at the Games - we'll need to make at least one or two announcements at each game. A social media reel and story of the announcement with snippets from the game will be posted on social along with the appropriate tags and hashtags

Social Media Plan:
