A RESOLUTION CANVASSING THE RETURNS AND DECLARING THE RESULTS OF A BOND ELECTION; AND OTHER MATTERS IN CONNECTION THEREWITH

WHEREAS, the Board of Trustees (the *Board*) of the Medina Valley Independent School District (the *District*) ordered an election to be held on May 7, 2022 (the *Election*) for the purpose of determining whether the qualified voters of the District would authorize the District’s issuance of general obligation bonds; and

WHEREAS, the Board has reviewed and investigated all matters pertaining to the Election, including the ordering, notices, election officers, holding, and returns thereof; and

WHEREAS, the Board has diligently inquired into the poll lists and the official election returns that were duly and lawfully made to the Board by the judges and clerks holding and conducting the Election; and

WHEREAS, from these returns, this Board hereby finds that the following votes were cast in the Election by qualified voters of the District:

PROPOSITION A

THE ISSUANCE OF \$383,215,400 OF BONDS BY THE MEDINA VALLEY INDEPENDENT SCHOOL DISTRICT FOR SCHOOL FACILITIES, AND THE LEVYING OF A TAX IN PAYMENT THEREOF. THIS IS A PROPERTY TAX INCREASE.

NOW, THEREFORE, IT IS RESOLVED BY THE BOARD OF TRUSTEES OF THE MEDINA VALLEY INDEPENDENT SCHOOL DISTRICT THAT:

SECTION 1: The Board officially finds, determines, and declares that the Election was properly ordered, that proper legal notice of the Election was given, that proper election officers were appointed prior to the Election, that the Election was legally held, that all qualified voters of the District were permitted to vote at the Election, that returns of the results of the Election had been made and delivered, and that the Board has canvassed such returns, all in accordance with the laws of the State of Texas and of the United States of America, and the order calling the Election.

SECTION 2: A MAJORITY of the qualified voters of the District voting in the Election, having voted AGAINST Proposition A, the Board hereby finds and determines that this Proposition failed at the Election.

SECTION 3: A MAJORITY of the qualified voters of the District voting in the Election, having voted AGAINST Proposition B, the Board hereby finds and determines that this Proposition failed at the Election.

SECTION 4: The recitals contained in the preamble hereof are hereby found to be true, and such recitals are hereby made a part of this Resolution for all purposes and are adopted as a part of the judgment and findings of the Board.

SECTION 5: All orders and resolutions, or parts thereof, which are in conflict or inconsistent with any provision of this Resolution are hereby repealed to the extent of such conflict,

and the provisions of this Resolution shall be and remain controlling as to the matters resolved herein.

SECTION 6: This Resolution shall be construed and enforced in accordance with the laws of the State of Texas and the United States of America.

SECTION 7: If any provision of this Resolution or the application thereof to any person or circumstance shall be held to be invalid, the remainder of this Resolution and the application of such provision to other persons and circumstances shall nevertheless be valid, and the Board hereby declares that this Resolution would have been enacted without such invalid provision.

SECTION 8: It is officially found, determined, and declared that the meeting at which this Resolution is adopted was open to the public and public notice of the time, place, and subject matter of the public business to be considered at such meeting, including this Resolution, was given, all as required by Chapter 551, as amended, Texas Government Code.

SECTION 9: This Resolution shall be in force and effect from and after its final passage and it is so resolved.

RESOLUTION CANVASSING RETURNS OF VOTES OF MEDINA VALLEY INDEPENDENT SCHOOL DISTRICT'S GENERAL ELECTION ON MAY 7, 2022

BE IT RESOLVED by the Medina Valley Independent School District as follows:

Medina Valley Independent School District Single Member District #3 Board Member Election

1. It is hereby found, determined and declared that the general election of the voters of the district held on May 7, 2022, was in all respects duly and legally called and held.
2. As specified in the attached Medina County Returns of Votes Cast, a total of 452 votes cast at said election for one position; Single Member District #3 Board Member for a three year term on the Medina Valley Independent School District's Board of Trustees. Matthew Castiglione received 278 votes, Darren Calvert received 174 votes.
3. As specified in the attached Bexar County Returns of Votes Cast, a total of 140 votes cast at said election for one position; Single Member District #3 Board Member for a three year term on the Medina Valley Independent School District's Board of Trustees. Matthew Castiglione received 44 votes, Darren Calvert received 96 votes.
4. Candidate Matthew Castiglione having received the highest number of votes, is duly elected for the Single Member District #3 three year term beginning after being sworn in.
5. The school board canvassing authority is hereby authorized to certify the results of the election in Medina County in which the school district is located in whole or in part.

Medina Valley Independent School District Single Member District #4 Board Member Election

1. It is hereby found, determined and declared that the general election of the voters of the district held on May 7, 2022, was in all respects duly and legally called and held.
2. As specified in the attached Medina County Returns of Votes Cast, a total of 328 votes cast at said election for one position; Single Member District #4 Board Member for a three year term on the Medina Valley Independent School District's Board of Trustees. Phyllis Santleben received 95 votes, Donnitta Seay received 64 votes, David Lopez Orozco received 40 votes, and Jennilea Campbell received 129 votes.
3. Candidate Jennilea Campbell having received the highest number of votes, is duly elected for the Single Member District #4 three year term beginning after being sworn in.
4. The school board canvassing authority is hereby authorized to certify the results of the election in Medina County in which the school district is located in whole or in part.
