RESOLUTION CANVASSING RETURNS OF VOTES OF MEDINA VALLEY INDEPENDENT SCHOOL DISTRICT'S GENERAL ELECTION ON MAY 2, 2026.

BE IT RESOLVED by the Medina Valley Independent School District as follows:

Medina Valley Independent School District two At-Large Board Members Elections. Single Member District #5 received zero applications.

1. It is hereby found, determined and declared that the general election of the voters of the district held on May 2, 2026, was in all respects duly and legally called and held.
2. As specified in the attached Medina County Returns of Votes Cast, a total of 694 votes cast at said general election for the two At-Large Board Members for a three year term each on the Medina Valley Independent School District's Board of Trustees. Nathan Fillinger received 247 votes, Blane Nash received 231 votes, Andrew Carawan received 101 votes and Toby Castillo Walters received 115 votes.
3. As specified in the attached Bexar County Returns of Votes Cast, a total of 195 votes cast at said general election for the two At-Large Board Members for a three year term each on the Medina Valley Independent School District's Board of Trustees. Nathan Fillinger received 51 votes, Blane Nash received 43 votes, Andrew Carawan received 39 votes, and Toby Castillo Walters received 62 votes.
4. Candidate Nathan Fillinger (298 votes) having received the highest number of votes, is duly elected for One At-Large Board Member position with a three year terms beginning after being sworn in. Candidate Blane Nash (274) having received the second highest number of votes, is also duly elected for One At-Large Board Member position with a three year terms beginning after being sworn in.
5. The school board canvassing authority is hereby authorized to certify the results of the election in Medina County in which the school district is located in whole or in part.

The Board officially finds, determines, and declares that the Election was properly ordered, that proper legal notice of the Election was given, that proper election officers were appointed prior to the Election, that the Election was legally held, that all qualified voters of the District were permitted to vote at the Election, that returns of the results of the Election had been made and delivered, and that the Board has canvassed such returns, all in accordance with the laws of the State of Texas and of the United States of America, and the order calling the Election.

It is officially found, determined, and declared that the meeting at which this Resolution is adopted was open to the public and public notice of the time, place, and subject matter of the public business to be considered at such meeting, including this Resolution, was given, all as required by Chapter 551, as amended, Texas Government Code.

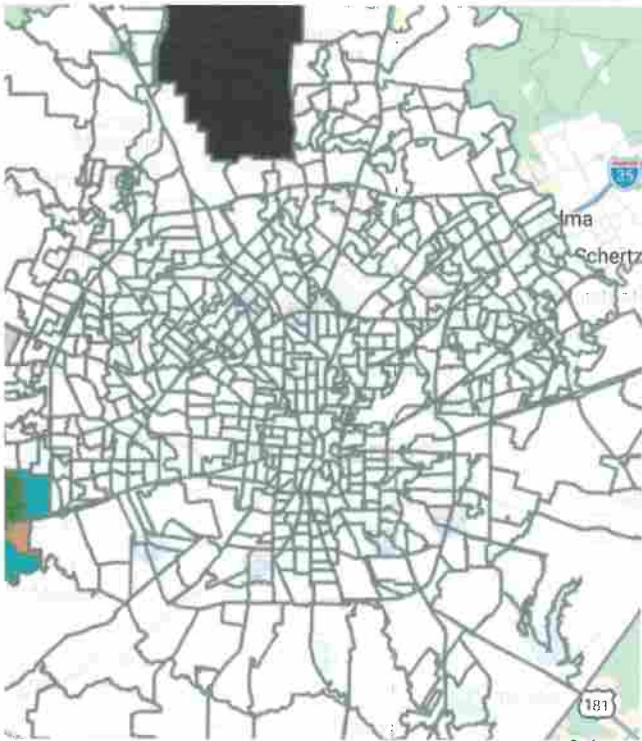

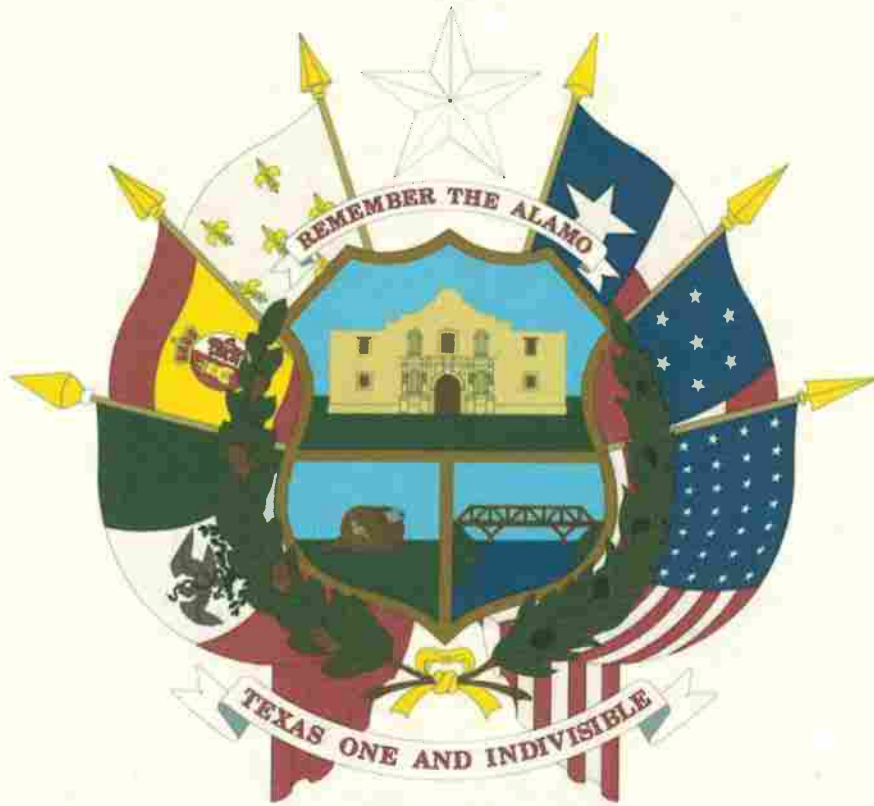

Agenda Item Memorandum

Agenda item: Consider Approval of Method to fill the Vacancy for SMD #5

Background Information:

Board Policy, BBC (Legal)

When a vacancy occurs the remaining board members may fill the vacancy by appointment until the next trustee election, or may order a special election to fill the vacancy. The vacancy shall be filled not later than the 180th day after the date the vacancy occurs.

Education Code 11.060

If a vacancy occurs on the board of trustees of an independent school district, the remaining trustees may fill the vacancy by appointment until the next trustee election.

Consideration:

If a vacancy occurs on the Board of Trustees, the Board can choose to fill the vacancy by appointment or by calling a Special Election. The MVISD Board of Trustees has filled previous vacancies by appointment. A Special Election would cost approximately \$30,000 and there would be no guarantees of receiving applicants.

Proposed Process:

The District would release an advertisement on behalf of the Board of Trustees seeking candidates for appointment to the Single Member District #5 Position for 1 year, until the May 2027 General Election Canvass. Any person who is a qualified voter, has been a resident of Texas for the previous year, and a resident of the Single Member District #5 for the previous six months may be considered for the position.

The District can utilize social media, parent square and the website to advertise the vacancy. Applications can be made available on the website, can be emailed out upon request and received in person at Central Office. A 30 day window to advertise and receive applications can open on May 15, 2026, closing on June 15, 2026. After the window closes and application verifications are completed the Board of Trustees can Call a Special Meeting a few days later. Interviews can be conducted and a selection made at the Special Meeting. The Board could potentially swear in the new Board Member at the July 22nd Board Meeting. Thus completing the entire process within the 180 days as required.

Agenda item: Consider award of RFCSP 26-002 for the Ladera Elementary Portable Infrastructure Project.

Background Information

District staff and Pfluger Architects worked together in preparing an RFCSP for the Ladera Portable infrastructure project. The proposing companies were to be evaluated on relevant experience, project management ability, subcontractor, and price/financial stability.

Administrative Consideration

The District accepted bids for this RFCSP on May 07, 2026 where 3 bids were submitted. Base Bids ranged from \$510,000.00 to \$713,527.00 District Staff and Pfluger Architects have reviewed and ranked the proposals based on the information provided by the contractors using the published selection criteria.

After reviewing and checking references the ranking is as follows:
