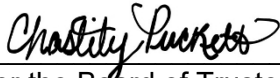

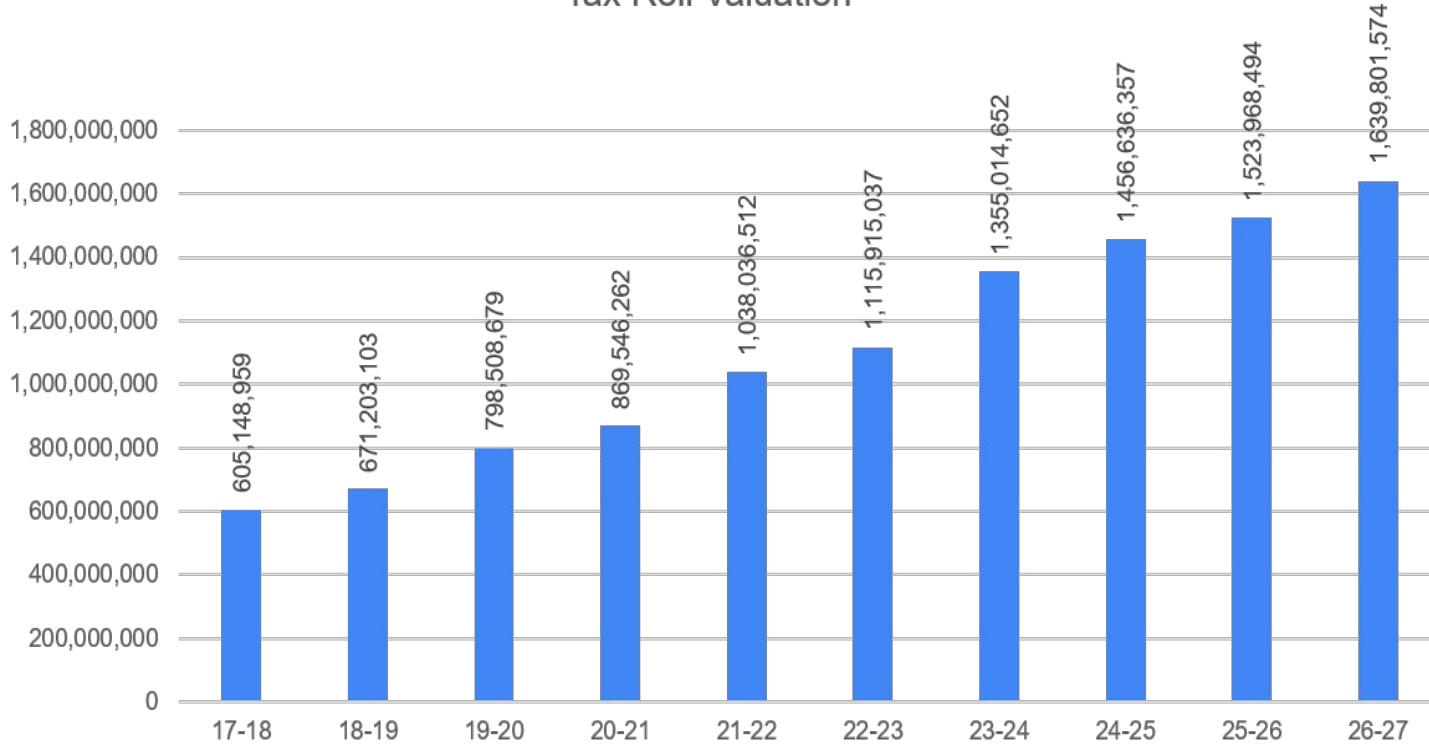

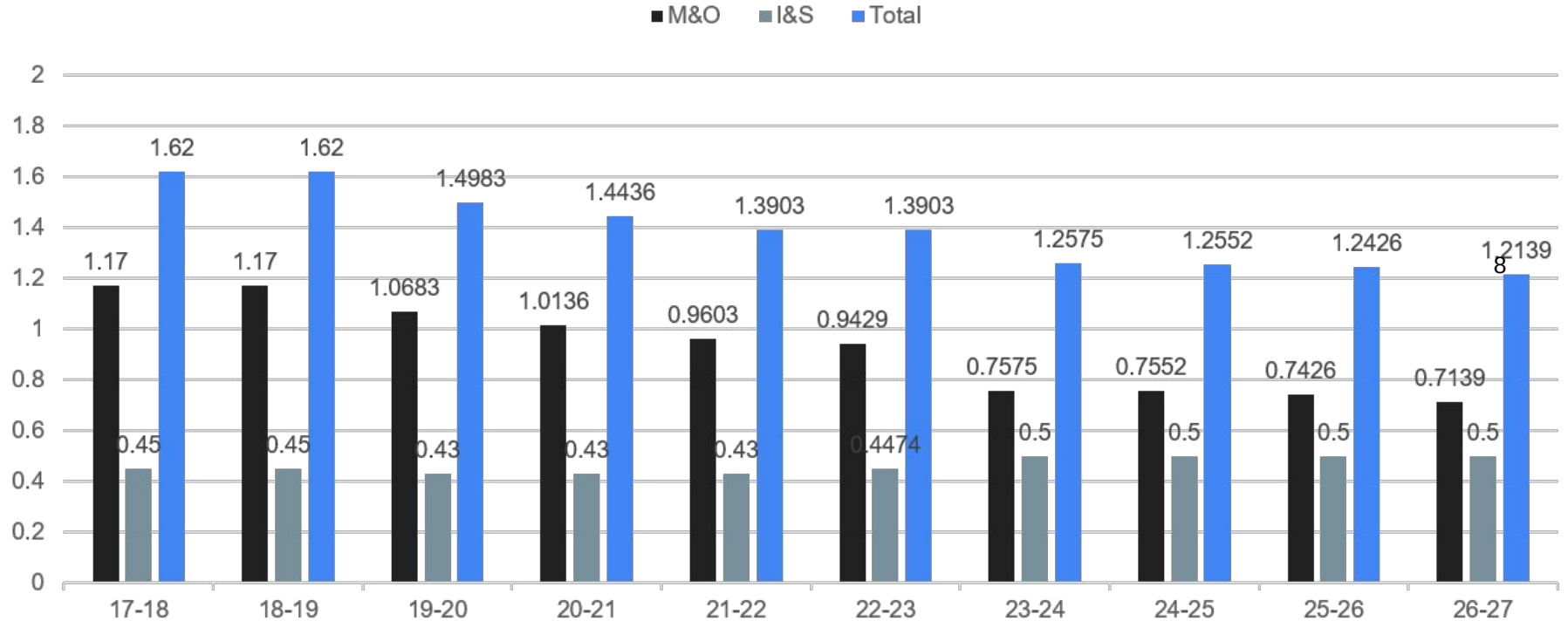
Proposed Tax Rates

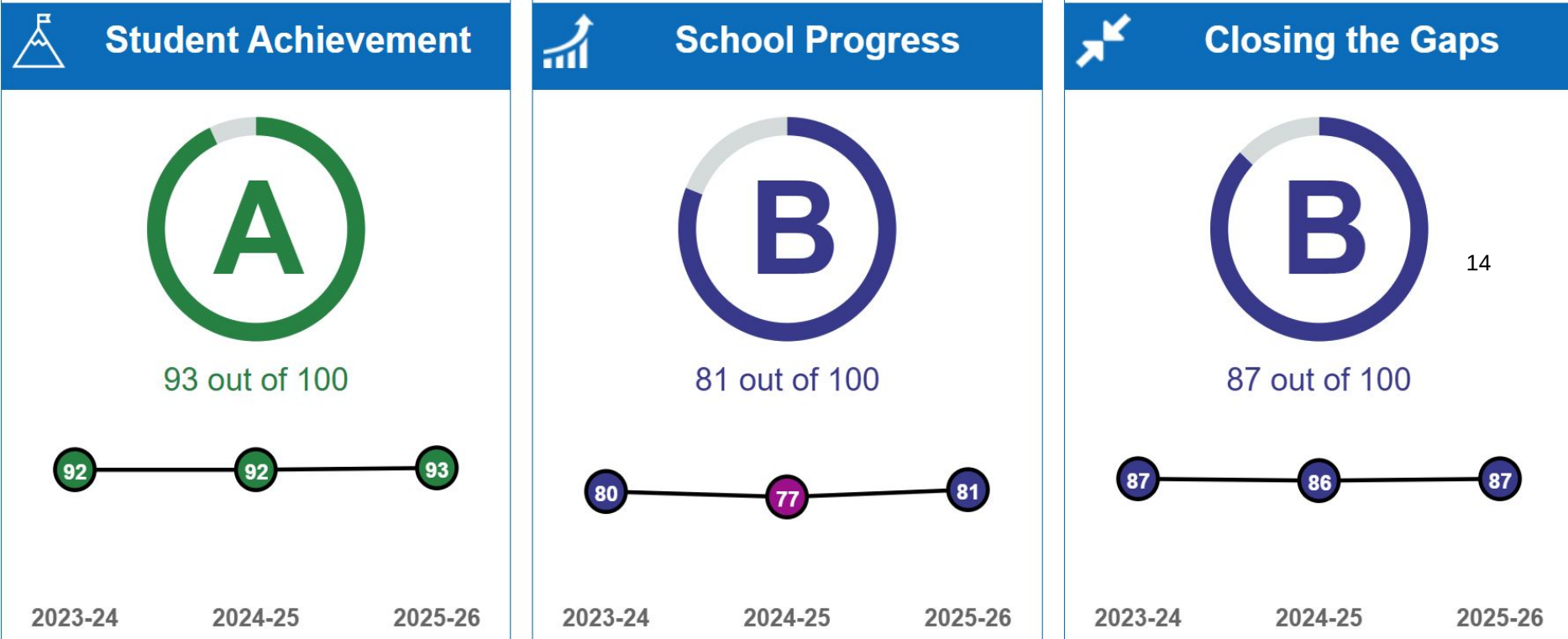

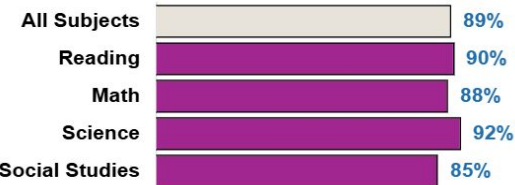

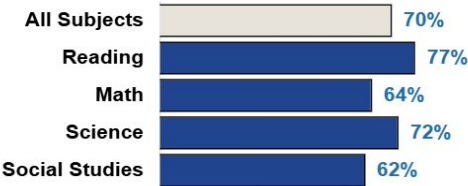


Percentage of Students Approaching Grade Level or Above



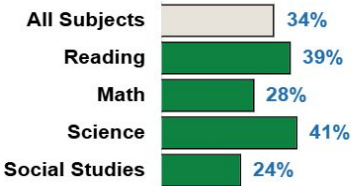

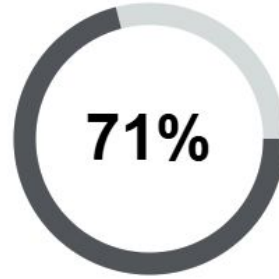

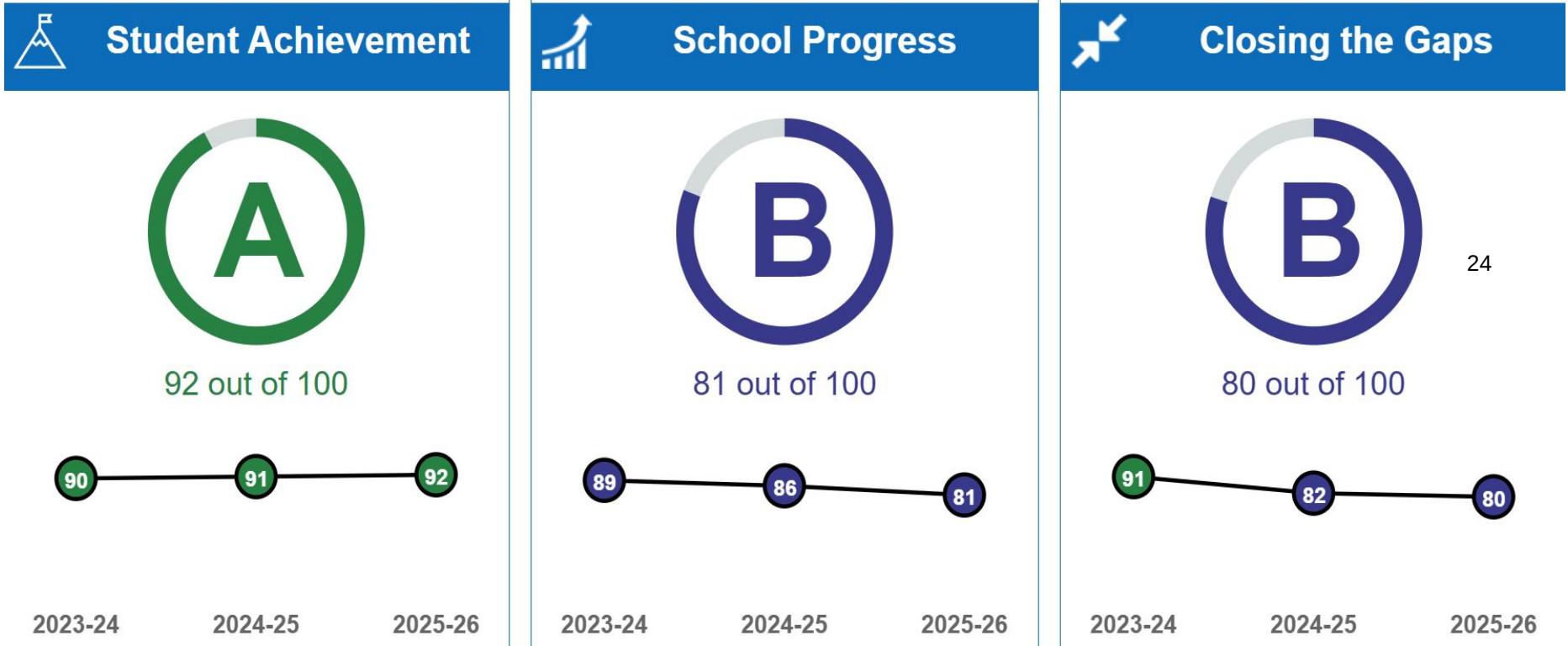

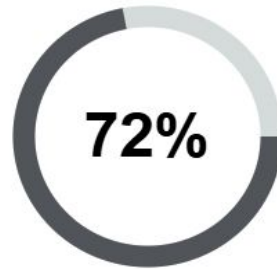
