**RESOLUTION**

**A RESOLUTION CALLING FOR AND ESTABLISHING THE PROCEDURES FOR A RUNOFF ELECTION FOR MAYOR OF THE TOWN OF HORIZON CITY; DESIGNATING THE DATE OF SAID ELECTION FOR JUNE 10, 2023; DESIGNATING POLLING PLACES; DESIGNATING EARLY VOTING HOURS AND PLACES; PROVIDING FOR POSTING AND PUBLICATION OF NOTICE FOR SAID ELECTION; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, pursuant to Sec. 2.021 of the Election Code of the State of Texas, it is provided that if no candidate for a particular office receives the vote necessary to be elected in an election requiring a majority vote, a runoff election for that office is required; and

**WHEREAS**, a canvassing of the returns and declaring the results of a regular City Municipal Election held on May 6, 2023, was approved by the Town Council on May 16, 2023; and

**WHEREAS**, the canvass determined that, in the race for Mayor no candidate received a majority of the votes cast; and

**WHEREAS**, the two candidates receiving the highest number of votes for the office of Mayor were Johnny “Doc” Duran and Andres “Andy” Renteria.

**NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF HORIZON CITY, TEXAS:**

**SECTION 1**                   The recitals contained in the preamble hereof are hereby found to be true, and such recitals are hereby adopted and made a part of this Resolution for all purposes.

**SECTION 2**                   In accordance with and pursuant to the provisions and requirements of the laws of the State of Texas, a Runoff Election is hereby ordered to be held on June 10, 2023, for the purpose of electing a Mayor. Voting information may be found on the Town’s website at <https://www.horizoncity.org/elections/>.

**SECTION 3**                   The Clerk for Early Voting shall be the Elections Administrator for El Paso County pursuant to the Election Services Contract between the Town and the County. Early Voting by personal appearance will be conducted each weekday at the early voting polling places designated by the El Paso County Elections Administrator and approved by the El Paso County Commissioners Court., between the hours of 8:00 a.m. and 5:00 p.m. beginning on May 30, 2023, and ending on June 6, 2023.

- SECTION 4** Applications for ballot by mail shall be mailed to the Early Voting Clerk at:
- El Paso County Elections Department  
500 E. San Antonio Ave., Suite #314  
El Paso, Texas 79901.
- SECTION 5** Applications for ballot by mail must be received by mail no later than the close of business on May 30, 2023.
- SECTION 6** For election day voting, the City hereby designates the election precincts and polling places designated by the El Paso County Elections Administrator, and approved by the El Paso County Commissioners Court, for such election day voting.
- SECTION 7** The runoff election shall be held in accordance with the Election Code of this State and only resident qualified voters of the Town shall be eligible to vote at the election.
- SECTION 8** The Mayor shall give notice of this election in accordance with the terms and provisions of Sections 4.004, 83.010, 85.004, and 85.007 of the Election Code, and all necessary orders and writs for the elections shall be issued by the proper authority. Returns of the elections shall be made to the Town Council immediately after the closing of the polls.
- SECTION 9** Pursuant to the Election Code and the applicable Election Services Contract, the El Paso County Elections Administrator shall be appointed as Custodian of Election Records.
- SECTION 10** The Town intends for El Paso County Elections Administrator to conduct such runoff election for the Town pursuant to the Election Code and the terms of the Election Services Contract executed between the Town and the County. The Town Council hereby appoints, for the term of such single election, the presiding election judge(s) and alternate election judge(s) as being those designated by the El Paso County Elections Administrator.
- SECTION 11** The results of the elections shall be certified, canvassed, and returned in the form and manner prescribed by the laws of the State of Texas and Ordinances of the Town of Horizon City.
- SECTION 12** If any section, subsection, sentence, clause or phrase of this resolution is for any reason held to be unconstitutional, such holding shall not affect the validity of the remaining portions of this Resolution.
- SECTION 13** This resolution shall take effect and be in full force immediately upon passage and approval.
