**RESOLUTION CANVASSING RETURNS OF VOTES OF
SCHOOL DISTRICT SPECIAL ELECTION**

BE IT RESOLVED by the School Board of Independent School District No. 200, State of Minnesota, as follows:

1. It is hereby found, determined, and declared that the special election of the voters of this school district held on November 4th, 2025, was in all respects duly and legally called and held.

2. As specified in the attached Abstract and Return of Votes Cast, a total of 2,711 voters of the district voted at said special election on the election to fill the school board vacancy of one school board member whose term will expire on the first Monday in January 2029 the special election as follows:

- Elaine Mikel-Mulder - 1,631
- Simone Rendon - 864
- Marty Weber - 208
- Write - In - 7

3. Elaine Mikel-Mulder, having received the highest number of votes, has been elected to fill the remaining term beginning on the first Monday in January 2026 and expiring on the first Monday in January, 2029.

4. The clerk is hereby directed to certify the results of the election to the county auditor of each county in which the school district is located in whole or in part.
