School Safety Committee Meeting Minutes January 29, 2025

A Bristol Board of Education School Safety Committee meeting was held on January 29, 2025, in the BoE Auditorium and via the Zoom meeting platform.

PRESENT: Committee members: Lori Osenkowski, Russell Anderson, Maria Simmons

ALSO PRESENT: Commissioners: Shelby Pons, Jill Fitzsimons-Bula, also, Iris White, and Stephen Cabelus.

1. Call to Order:

The meeting was called to order at 6:00 P.M.

2. Approval of Minutes:

On a motion by Commissioner Simmons and seconded by Commissioner Anderson the November 13, 2024, regular meeting minutes were approved.

3. Public Comment:

There was no public comment this evening.

4. Approval 2025-2026 Meeting Schedule:

- Safety Audits at BEHS and BCHS - currently waiting for quotes for cameras and emergency alert systems.
- Two new staff members for CHMS and GHS - currently no open vacancies.
- ALICE Training Sessions - Two sessions completed and will be offering another training session in February 2025.

- He attended a Capital Region Emergency Planning Committee meeting.
6. **Discussion - Hand-held security wands in schools:**
Principal Mike Higgins from BEHS spoke on this topic. He feels it would be a positive addition to the detection of vapes along with the already installed vape sensors in the bathrooms. They have seen an increase in THC vapes. The policy committee will hold a special meeting before the BOE meeting on February 5th to approve a Hand Held Security Wand Policy. If it is approved in the Special meeting it will then go forward to the BOE meeting for full board approval. Once the policy is approved there can be a proper rollout to all staff and parents and begin use of the wands.
 7. **Discussion - Determine recurring items to be included on every School Safety Committee agenda:**
Steve is going to meet with Iris and they will put together a general list of topics as a guideline of what not to discuss and present them to the committee.
 8. **Discussion - Bylaw 9132 - School Safety Committee:**
A discussion on the Bylaws took place and this will be a continuing discussion as to the changes and updates take place of this newly created committee.
