**BACKGROUND:**

Attached are the enrollment figures as of October 1, 2023. Mrs. Batchelder will answer any questions.

**STATUS:**

In prior BOE enrollment reports, the enrollment report grouped all students into one category labeled "Outside Placement/Private Placement (SPED)". Beginning in September 2016, the Out Placement/Private Placement (SPED) line was separated into two categories:

1. *Out of District Placement-Special Education students*
2. *Private Placement Special Education students*


**Out of District - Special Education:** Those students who are placed at a Connecticut State Department of Education (CSDE) approved private special education program as recommended by a planning and placement team (PPT) as part of a student's individualized education program (IEP). Additionally, this category may include a family who moves into Windsor with a child who has a disability who has already been placed in a private special education program and/or children who are placed in Windsor foster home(s) by the Department of Children and Families (DCF) and are already enrolled in a private special education program.

**Private Placement - Special Education:** Those students who have been identified special education through the planning and placement team (PPT) process that have been parentally placed at a non-public school located in Windsor (i.e., St. Gabriel, Trinity Christian, Madina Academy, Praise Power & Prayer, etc.).

1. Call to Order, Pledge to the Flag, Moment of Silence

The meeting was called to order at 7:02 pm with the Pledge to the Flag and a Moment of Silence. Also in attendance was Superintendent of Schools Dr. Terrell Hill, Director of Business Services and Human Resources Danielle Batchelder, Assistant Superintendent for Instructional Services Dr. Noha Abdel-Hady, and Student Representative Timothy Hoagland.

2. Recognitions/Acknowledgements

a. Introduction of New BOE Student Representative, Timothy Hoagland

Dr. Hill introduced the fall semester BOE Student Representative Timothy Hoagland. Mr. Hoagland has shown leadership skills and empathy for his fellow students. He has already accumulated more credits than necessary for graduation while participating in golf and other activities at WHS. He is known to be the type of student anyone would want to represent their organization.

b. Introduction of Windsor's Educator of the Year, Kathleen Stoll

Principal Mihalko of Poquonock Elementary School introduced Windsor's Educator of the Year, Kathleen Stoll. Ms. Stoll has been employed by Windsor Public Schools for many years, beginning at Oliver Ellsworth and most recently at Poquonock. She participates in many school activities as well as community events. She is an avid supporter of Alex's Lemonade Stand.

c. Introduction of Windsor's Paraeducator of the Year, Sandra Bailey

Principal Parker introduced Windsor Paraeducator of the Year, Sandra Bailey. Ms. Bailey works tirelessly to help all students succeed. She began a non-profit scholarship fund for her home country of Jamaica and fundraises within the community. She is proud of the students she works with and is mindful of the things that make everyone unique.

d. Introduction of New Administrators

Ms. Batchelder introduced the Acting Principal of JFK Elementary School, Mr. Dana Gagne, Primary Special Education Supervisor for Oliver Ellsworth and Poquonock, Ms. Karen Lawson, Arts and Humanities Supervisor at WHS, Dr. M.J. Martinez, and Assistant Principal of Clover Street School, Mr. Matthew Spector.

### 3. Audience to Visitors

Sally Grossman, 34 Remington Road - She spoke in support of the LGBTQ+ community in the school district.

Parker Grossman-Schoner, 34 Remington Road - He said that children are not born to hate and that we need to make sure that adults aren't teaching children to hate.

Bonnie Waterhouse, 5 Kari Court - She is attending as a representative of Voices Against Lyme Disease. She invited the BOE and community to attend a viewing of the documentary *The Monster Inside Me* at Windsor Public Library on October 14, 2023 at 1:00 PM.

Kathryn Parker, 166 West Street - She spoke as a representative of WEF regarding item 7.g. She spoke in response to Mr. Panos' comments in June asking for more open-mindedness. She asked why this was the first grant up for discussion in the last 20 years and who actually needs to be open-minded, the community or the board.

Margaret Essex, 95 Lighthouse Hill Road - She said that the mission of WEF and the board is to support students, but in questioning the grant there is a lack of support for all students. She asked the board to consider what their actual issues are with the grant are.

George Slate, 74 Ethan Drive - He said he initially came to the meeting to invite students to consider how the town would be represented for it's 400th anniversary, as an oppressor of minorities or the first English settlement. He also brought a representative from a remediation company regarding the mold at Oliver Ellsworth. He sent an email to the board with the contact information from this company.

Ms. Klase left the room at 7:39 PM and returned at 7:43 PM.

Rebecca Jacobsen, 50 Lighthouse Hill Road - She said that she felt the aim of questioning the WEF grant was to further alienate marginalized students. She said that some board members seemed to have no interest in learning about others, only wanting to gain political points, and not to pretend the concern is in the best interest of the students.

Alexandra Torres, 78 Robin Road - On behalf of Geanellys Negron, she played a recording of Ms. Negron's statement. Ms. Negron requested that the board show respect for the LGBTQ+ community and to understand that the GSA is a safe space allowing students to speak up and out. She said that their feelings matter.

Leela DeLucia, 27 Donna Lane - She said that, regarding item 7.g., the board's purpose has been brought into question. There has been rhetoric and bigotry in the guise of saving kids. She said the board had been invited to attend GSA meetings, but have not attended.

Daniell Hynes, 49 Farmstead Lane - Regarding the WEF grant, she said it is intended to enhance educating students and encourage inclusion. She asked why they are ostracizing students when the grant supports mental-wellbeing.

Lia Negron, 382 Ridgewood Road - On behalf of Andrea Chudzik, a teacher at WHS, stated that the board seems to have a lack of awareness about the LGBTQ+ community and is discriminating against them by limiting their existence to sex and promoting negative stereotypes.

Move to extend Audience to Visitors by 30 minutes. This motion, made by Mr. Leonard Lockhart and seconded by Mr. Paul Panos, Passed.

Ace Ricker, 41 Vine Court, New Britain - He spoke as an openly multi-racial transgender man, in support of the WEF grant. He said that the board is denying students the opportunity to grow and know themselves. They need a safe space as home is not always safe.

James Madison, 8 Fitzmaurice Circle - He said he is in support of consenting adults having whatever kind of relationship they choose, but that he has concerns that the transgender community can compromise kids and sports. He said that heterosexual males could take advantage of the "transgender" label.

Alberto Cifuentes Jr., Representative of Q Plus/GSA - He spoke in support of GSA and the WEF grant. He said that GSA gives positive role-models, workshops, and networking to students who are harassed daily. He believes this grant enhances educational opportunities.

The next speakers attended virtually.

Adam Gutcheon, 19 Mechanic Street - He said that he was the first openly gay community member to serve on the BOE and Town Council. At that time, he had been accused of being a groomer and whether it was appropriate to serve as an elected official. He said the LGBTQ community is not well represented. He suggested the community vote accordingly in November.

Karen Mendoza, 721 Kennedy Road - She said she had originally planned to speak as an OE parent, but said she is now concerned that kids in the LGBTQ community may not be welcome and she is proud to have kids among the LGBTQ group. She did speak about the cracks in communication between the board and Town Council regarding the OE issues.

Dayle Blue, 31 Allen Street - She spoke as an educator at JFK. She said that the students there are changing and need places to belong. She said that everyone needs to open their eyes and minds to anyone who is different.

Lucy Goins, 9 Sage Park Road - Ms. Daly, the stenographer, read Ms. Goins written statement. Ms. Goins wrote she is glad there is an opportunity for the district middle schoolers to have a group that is welcoming and supportive. She said she is bothered that there is an agenda item that discusses blocking a group like this.

Gage Jacobsen, 50 Lighthouse Hill Road - He said that the GSA would allow him to know who is safe to talk to. He took offense at Mr. Madison's statement about transgender individuals.

The last speaker was present in the room.

Dr. Carmen Melecio, 137 Carroll Street, Springfield, MA - She works with children in the LGBTQ+ community at First Church in Windsor. She said there needs to be an understanding that people aren't different. She shared an allegory about community and baking a cake.

He said that it is a sensitive topic that shouldn't mix middle and high school age students.

At this time, Mr. Panos made a motion which ultimately was called out of order. His motion generally was that grant funds should not be used to facilitate relationships between middle school and high school students.

Mr. Panos, Ms. Canter, and Mr. Halek spoke out against the acceptance of the grants for the purposes of connecting younger and older students.

The remaining board members shared their disappointment that this was a continued topic of conversation. They made points about home not being safe for some students, how other organizations at school are age-mixed, and Windsor's rank of 2nd in the state for suicides.

Dr. Hill invited Dr. Monica Brase, WHS teacher and the grant writer, to address the topic.

Dr. Brase thanked the supporters in Audience to Visitors and stated that according to GLAAD (Gay and Lesbian Alliance Against Defamation), the law states that students have a right to learn and access to materials regardless of objecting schools or parents and the 1984 Federal Equal Access Act, which states that all groups must be treated equally or it may constitute a civil rights discrimination violation. She said that the republicans are concerned about a very select group comingling.

With this information, Mr. Furie stated that the motion is out of order due to possible litigation. He said this matter has been satisfied.

8. Superintendent's Report

a. School Opening Comments

Dr. Hill spoke about convocation on August 22, 2023, when former Connecticut Department of Education head Dr. Sergie spoke. He thanked the Windsor Historical Society for hosting the New Teacher Orientation. This was the 2nd Annual Block Party at WHS on August 24, 2023. He thanked Ms. Morales and Ms. Phelps for their participation. He also thanked event sponsors who donated backpacks and supplies. The first day of school and Calling All Men was on August 28, 2023. He welcomed Mary Cristofaro, who was hired as Director of Pupil and Special Education, with a start date of October 1, 2023. The next Coffee Talk will be held on September 26 at 10 AM. Registration may be done on the district website.

He stated that September 18-24 is National Adult Education and Family Literacy Week. Mayor Trinks presented a proclamation recognizing it on September 19, 2023, with the staff and students of the Windsor Adult Education program

at LPW. Governor Lamont will present a proclamation announcing its recognition at the state capitol on September 20, 2023. Ms. Aguirre-Ernest will represent Windsor's adult education and WPS.

b. Staffing Update for Opening of 2023-2024 School Year

**Art: Printmaking**

**1713 Honors**

**0.5 credit. Prerequisite: None.** Students will explore various printmaking media and techniques such as linoleum cut, etching, and monotype along with color theory and composition. This course uses materials and tools that require mature and responsible handling. Preparation of paper and plates, the printing process and pulling of single prints and editions are required. Each unit consists of Research, Design Development, Problem solving/Construction and Critical Analysis/Reflection. This course is highly recommended for students interested in developing a printmaking portfolio for AP Art & Design or pursuing a career in any major field of art. This course may earn Fine Art credit.

**CS 2 ECE Introduction to Computing for Engineers**

**Course # High Honors**

**1.0 Credit. Prerequisite: Computer Science 1 or instructor approval.** This course introduces students to computing logic, algorithmic thinking, computing processes, a programming language and computing environment. Knowledge obtained in this course enables use of the computer as an instrument to solve computing problems. Representative problems from science, mathematics, and engineering will be solved. This course counts as a STEM elective or any elective credit for graduation requirements. This course aligns to UCONN's CSE 1010.

► **ENGLISH**

**ECE Intro to Academic Writing**

**1.0 credit. Open to 12th.**

In this full-year course, students will refine their writing skills in preparation for collegiate and professional writing by engaging in a number of composition practices that include the analysis of written, textual, and visual/audio mediums. Critical thinking and discourse are important aspects to the course. Students will learn strategies that will help them in the development of ideas, rhetoric, and through the writing process. This UConn/ECE course aligns with ENGL 1004.

## ► MATH

### Transitional Math                      1253 College

**1.0 Credit. Prerequisite: Identification as an English Language Learner.** This course provides students with the opportunity to acquire proficiency in English reading, writing, listening and speaking skills while developing key foundational mathematical ideas and basic math content (numeracy) necessary for entry into grade-level mathematics classes. Individual and small group instruction is provided. This course may be repeated for credit.

### ECE Math for Business & Economics

#### Course # High Honors

**0.5 Credit. Prerequisite: Pre-Calculus.** This course extends students' knowledge of linear equations and inequalities, matrices, systems of linear equations, and linear programming. Other topics include sets, counting, probability and statistics; mathematics of finance; and applications to business and economics. This course is an alternative to Calculus for college-bound students interested in business and economics. This course aligns to UCONN's MATH 1070Q

### CS 2 ECE Introduction to Computing for Engineers

#### Course # High Honors

**1.0 Credit. Prerequisite: Computer Science 1 or instructor approval.** This course introduces students to computing logic, algorithmic thinking, computing processes, a programming language and computing environment. Knowledge obtained in this course enables use of the computer as an instrument to solve computing problems. Representative problems from science, mathematics, and engineering will be solved. ECE General Chemistry I & II  
Lab

Course # High Honors

#### Course # High Honors

**2.0 Credit. Open to grades 11 and 12. Prerequisite: Algebra 2 honors or concurrent.** It is recommended that students receive an average of a B or higher in Honor Algebra 1, Honors or High Honors Geometry, and Honors or AP Biology. This course is designed to provide a foundation for more advanced courses in chemistry. The first semester covers atomic theory,

laws and theories concerning the physical and chemical behavior of gases, liquids, solids, and solutions. First semester lab explores quantitative measurements illustrating the laws of chemical combination. The second semester covers equilibrium, thermodynamics, nuclear chemistry, and kinetics. Properties of some of the more familiar elements and their compounds. Second semester lab explores equilibrium in solutions and reactions of the common cations and anions in the laboratory component. This course aligns to UCONN's CHEM 1127Q and CHEM1128Q.

### ► **SOCIAL STUDIES AND HISTORY**

#### **ECE American Studies**

**2.0 credit. Open to 11th.**

American Studies provides students the opportunity to explore what it means to be American as both a historian and a literary scholar. Throughout this course, students will investigate concepts such as the American identity, democratic ideals, the tensions between the individual and American society, diverse perspectives on the American dream, and active citizenship. Through the marriage of historical documents and literature, students will develop a deeper understanding of, and appreciation for, those people, events, institutions and turning points that have shaped American history and that continue to influence the nation and students' lives today. Students will come to understand the American experience in a way that respects and acknowledges the various cultural perspectives as they examine fiction, visuals, political movements, literature, film, and historical texts.

The UConn/ECE course aligns with the AMST 1201 course offered at the University of Connecticut entitled "Seminar in American Studies" and is taught by one English and one Social Studies faculty member for two class periods. This course fulfills the state U.S. History requirement. Students earn 2.0 credits with 1.0 credit each towards graduation for English and Social Studies.

In addition, they will learn about the different types of suspension systems in Cars, Trucks, and SUV's. The vehicle's HVAC and Cooling System. Students will learn about all different types of engines. They will be able to strip them down piece by piece and be able to identify and explain how each part works and its purpose inside of the engine.

The choir performs in the evening winter and spring concerts, in-school concerts as well as at various local events within the community, and participates in an adjudication music festival in the spring. Participation in all concerts is mandatory and counts as an assessment towards each student’s grade; however, participation in the adjudicated music festival is strongly recommended.

**Course Description Change- Concert Choir 1821 College.** Add “NOT OFFERED 2024-2025.”

**Course Description Change- Gospel Choir** 1814 Honors

1.0 credit. Gospel Choir is available for all singers on all levels and is designed to provide the student with an in-depth and concentrated experience in singing traditional and contemporary gospel music as well as Negro spirituals and acapella compositions. Emphasis will be placed on learning proper vocal, breathing, and movement techniques within the gospel realm, solo

singing, basic music literacy, and basic rehearsal and performance procedures. Students will be assisted in college auditions as well as community solo performances as appropriate. -Students who play keyboard/piano, drum set, guitar, bass, or any other instruments are encouraged to join. – Instrumentalists must be able to demonstrate a high level of skill and ability to play by ear and/or be able to read music. In addition to the evening winter and spring concerts, and in-school concerts, the choir performs frequently at various community events throughout the State of Connecticut and participates in an adjudication music festival in the spring. Participation in all concerts is mandatory and counts as an assessment towards each student's grade; however, participation in the adjudicated music festival is strongly recommended.

**Course Description Change- String Orchestra** 1841 Honors

1.0 credit. Open to grades 9-12. Prerequisite: Previous experience on a string instrument or permission of the instructor. The String Orchestra is a performing ensemble that provides the opportunity for string players to continue their development of musicianship skills, and aural and technical facility through a large repertoire of string orchestra literature (primarily Levels 3 and 4) and technical studies of a wide stylistic and cultural variety. Students also prepare for two Solo/Small Ensemble Recitals to improve their individual musical skills and prepare for optional CT & New England Festival participation. We combine with Symphonic Band and/or Choir members on occasion to perform full orchestra literature. Student involvement in concert and performance activities will be part of the grading process for this course. Periodically there are special events, rehearsals or concerts during non-school hours. Participation in such activities is an essential extension of the requirements. Rehearsals include student run sectionals, small ensembles and individual practice time to prepare for assessments. Literature is selected by both teacher and students.

**Course Description Change- Music Theory 1** 1809 Honors

1.0 credit. Open to grades 9-12. This course is designed to enhance music skills and basic music fundamentals. The essential aspects of melody, harmony, rhythm, and form are studied. Throughout the course of the year students will study basic notation, scales, key signatures, intervals, triads, cadences, non-chord tones, form, part-writing and analysis of a score. Aural dictation and ear training are also an integral part of the course and will be taught throughout the year. Individual creativity is nurtured through both rhythmic and melodic composition. This course is highly recommended for students who are currently in or who have had experience in a musical ensemble.

Course topics include fluids; thermodynamics; electric force, field, and potential; electric circuits; magnetism and electromagnetic induction; and quantum, atomic, and nuclear physics. The laboratory work includes investigating phenomena and fundamental training in precise measurements. Students are required to take the AP Exam in Physics at no cost. This course aligns to UCONN's PHYS 1202Q.

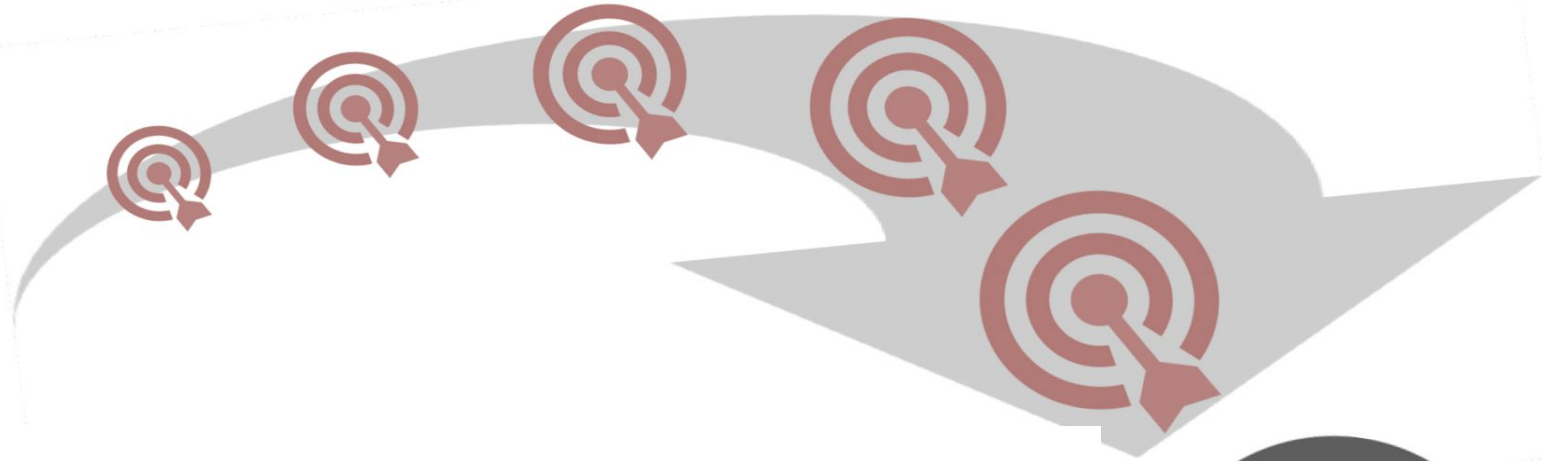

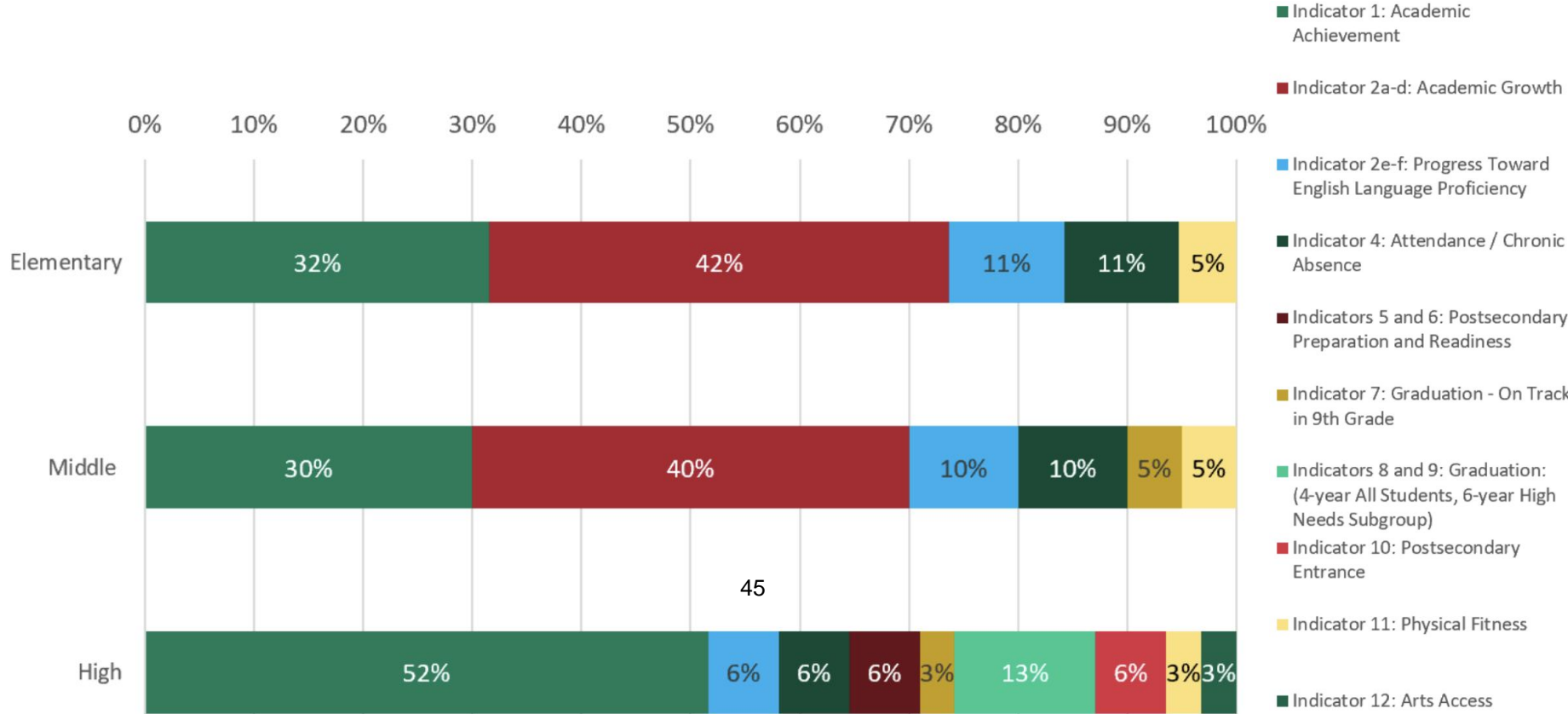

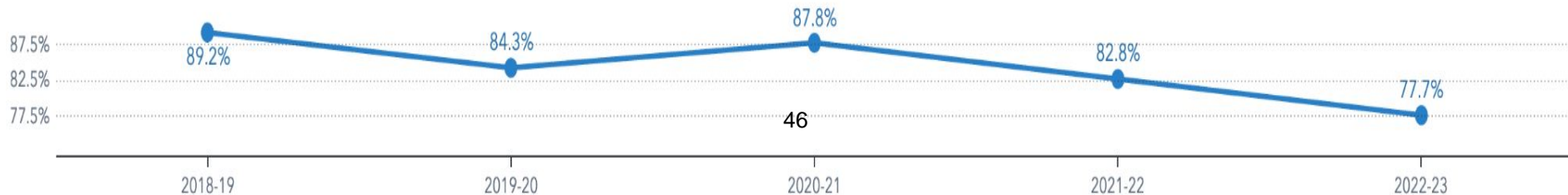


# Indicator 7: On Track to High School Graduation 9th Grade

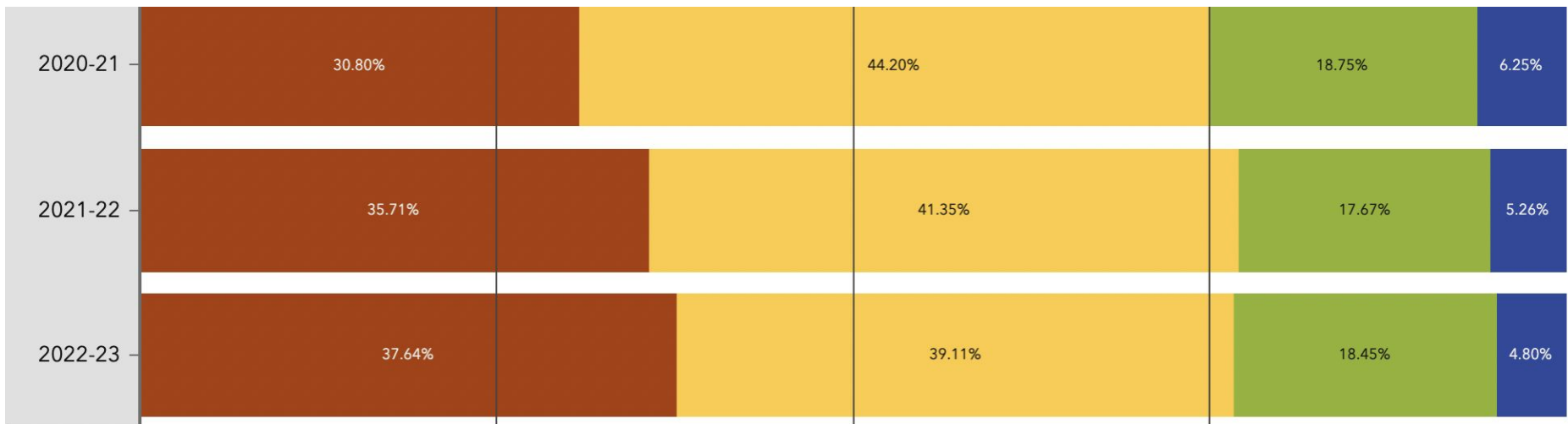

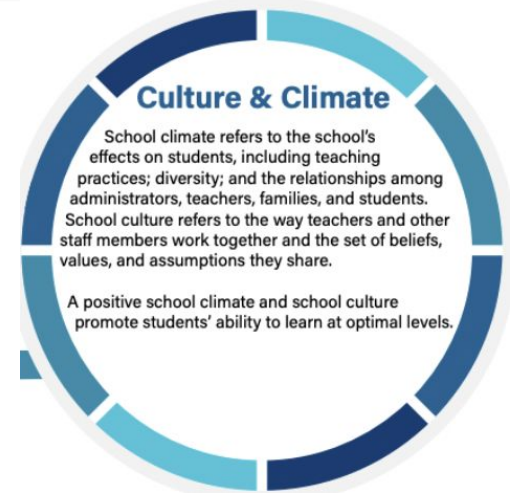

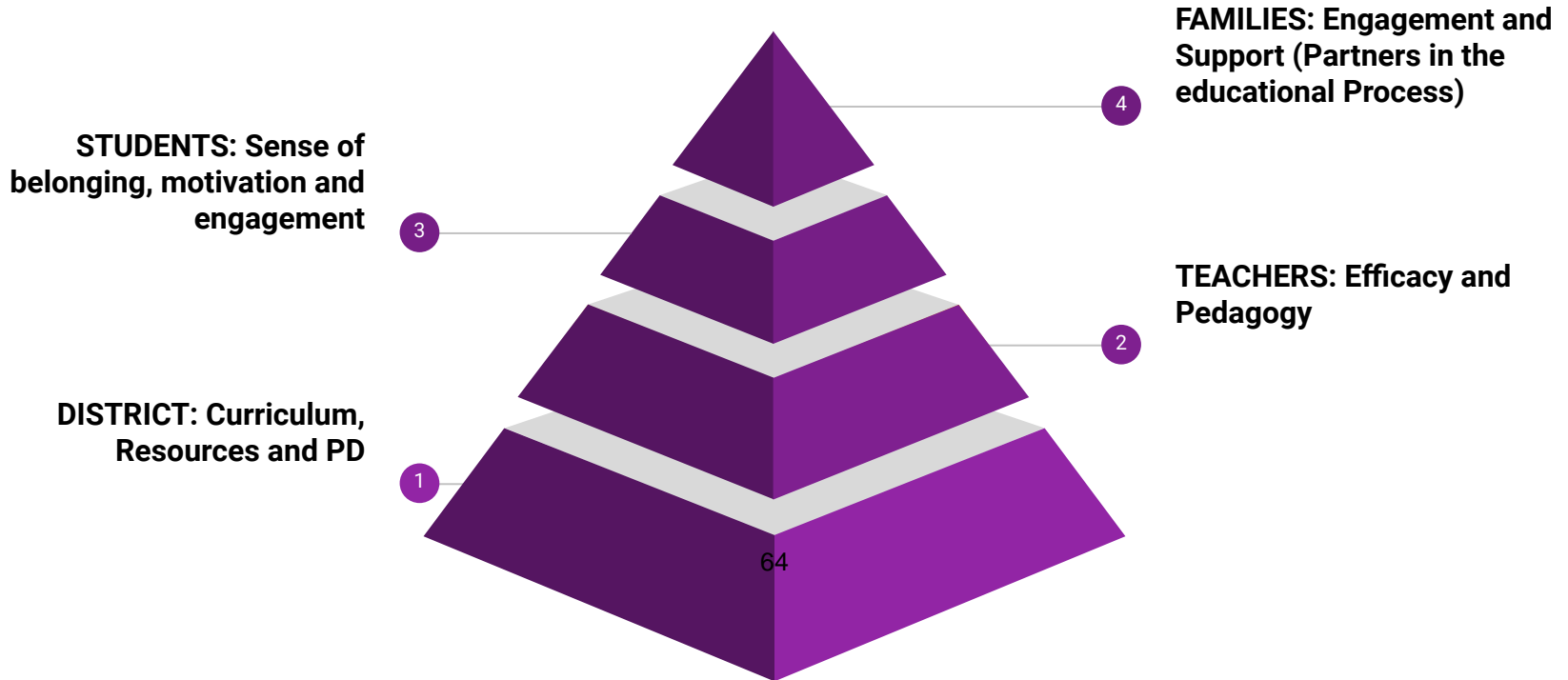

- Communicate with families and share resources that can be used at home to support students

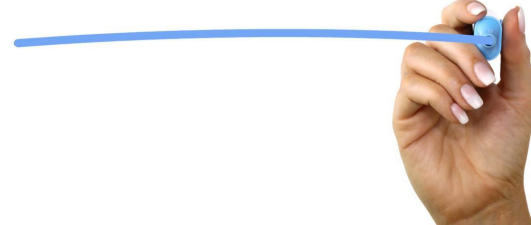
