**RESOLUTION AUTHORIZING ISSUANCE OF CERTIFICATES
OF GENERAL & SPECIAL ELECTIONS AND DIRECTING
SCHOOL DISTRICT CLERK TO PERFORM OTHER ELECTION
RELATED DUTIES**

WHEREAS, the board has canvassed the general election for school board members held on November 4, 2014.

NOW THEREFORE, BE IT RESOLVED by the School Board of Independent School District No. 477, State of Minnesota, as follows:

1. The chair and clerk are hereby authorized to execute certificates of election on behalf of the school board of Independent School District No. 477 to the following candidates:

- a. Deb Ulm (4 year)*
- b. Craig L Johnson (4 year)*
- c. Eric D Minks (4 year)*

*who have received a sufficiently large number of votes to be elected to fill vacancies on the board caused by expiration of term on the first Tuesday in January next following the election, based on the results of the canvass.

**who has received a sufficiently large number of votes to be elected to fill the vacancy in the term of school board member expiring January 5, 2015.

2. The certificate of election shall be in substantially the form attached hereto.

3. After the time for contesting the election has passed and the candidate has filed all campaign financial reports required by Minnesota Statutes, Chapter 211A, the clerk of the school board is hereby directed to deliver the certificates to the persons entitled thereto personally or by certified mail.

4. The clerk is hereby directed to enclose with the certificate a form of acceptance of office and oath of office in substantially the form attached hereto.
