Letter to legislators re: District 191 Platform & specific legislation

Dear Legislator:

On behalf of the Burnsville-Eagan-Savage School District 191 community, thank you for taking the time to meet with members of our Board of Education during MSBA Day on the Hill this year. We appreciate your commitment to hearing from us and your commitment to continuing Minnesota's excellent public education system.

We wanted to take this opportunity to share a little information about District 191, and to highlight some specific legislation that aligns with our 2025 Legislative Platform, which focuses on providing full funding for mandates and essential services, removing barriers so all students can succeed, and creating safe school environments.

Like many districts, we're facing pressures on our budget for 2025-26. This includes:

- A total projected budget deficit of \$11 million, if we were to keep services flat;
- Cross subsidies of \$11 million for special education and English learner services;
- Summer unemployment benefits cost of \$100,000, and;
- Expected loss of \$2 million in Compensatory Revenue related to under-reporting of families who would qualify for educational benefits.

There are a number of bills currently being considered by the state Legislature that would address these and other issues in our Legislative Platform. We encourage you to support the following bills:

- HF 515 (Bakeberg) and SF 1086 (Duckworth) to increase the general education basic formula allowance by an additional 3% per year;
- HF 31 (Youakim) and SF 1357 (Kunesh) addressing compensatory revenue and increasing funding for school unemployment aid;
- HF 51 (Virnig) and SF 1198 (Hauschild) authorizing roof projects as part of long-term facilities maintenance, and;
- HF 409 (Myers) increasing Local Optional Revenue levy allowance.

Thank you again for your time and for your work on behalf of Minnesota's students.
