**RESOLUTION CANVASSING RETURNS OF VOTES OF  
SCHOOL DISTRICT ELECTION**

Member \_\_\_\_\_ introduced the following resolution and called for its adoption:

***BE IT RESOLVED by the School Board of Independent School District No. 720, Shakopee Public Schools, State of Minnesota as follows:***

- 1. It is hereby found, determined, and declared that the special election of the voters held on November 4, 2025, was in all respects duly and legally called and Held.*
- 2. As specified in the certified polling place summary statement completed after the polls closed on November 4, 2025, 30,878 persons were registered to vote as of 7:00AM on that day.*
- 3. As specified in the attached Abstract and Return of Votes Cast, at said election a total of 5059 voters of the district voted on School District Ballot Question One, relating to the operating levy authorization, of which 3193 voted in favor, 1855 voted against the same, and there were eleven (11) completely blank or defective ballots relating to this question.*
- 4. Said proposition for Question One, having received the approval of at least a majority of such votes, is hereby declared to have carried.*
- 5. As specified in the attached Abstract and Return of Votes Cast, at said election a total of 5059 voters of the district voted on School District Ballot Question Two, relating to the operating levy authorization, of which 3115 voted in favor, 1925 voted against the same, and there were nineteen (19) completely blank or defective ballots relating to this question.*
- 6. Said proposition for Question Two, having received the approval of at least a majority of such votes, is hereby declared to have carried.*
- 7. The School District clerk is hereby directed to certify the results of the election to the county auditors of each county in which the School District is located in whole or in part.*

*The clerk is also directed to report the results of the election to the Commissioner of Education within fifteen (15) days of the date hereof.*
