NDSBA Convention on October 9th & 10th was held with many topics discussed: Law Seminar: Special Education & Disability Discrimination, Managing Claims & Complaints, ND Insurance Reserve Fund updates, Tips for Public Schools, Top Issues School Boards are Facing in SY25-26, Legislative Updates.

Committee Updates:

Student Council Update:

The Student Council has been hard at work planning and supporting a variety of school activities. They recently opened the concession stand, which will now be available during all home games. Members are also coordinating homecoming activities and preparing for Red Ribbon Week, including daily dress-up themes and awareness events.

In addition, the council is developing a new school newsletter to share important updates and student highlights. Looking ahead, they are planning a Halloween Dance to bring students together for a fun and festive celebration.

Safety Committee:

The Safety Committee continues to meet every other Monday in Ms. Mitchell's classroom to review and address safety concerns across the school. Recent discussions focused on strengthening building security, improving communication systems, and scheduling upcoming evacuation and lockdown drills. October is Fire Prevention Month, and the Fire Department will visit on October 7 to present fire safety information to Pod A students.

Wellness Committee:

The Wellness Committee continues to support a healthy and safe school environment. The October menu has been approved, and families should note a small change: the salad bar will now be offered once a week. Public Health Nursing will also be on site October 8 to administer flu vaccines for staff—an important step in staying healthy during flu season. With Halloween approaching, we encourage everyone to keep safety in mind by choosing well-lit trick-or-treating areas, wearing visible costumes, and checking treats before eating them. Let's make this season both fun and safe for all!

PLCs:

Our Professional Learning Communities (PLCs) have been working hard this fall to strengthen instruction and provide support for all students. Some grade-level teams created a data wall to track progress and guide instruction, while also reviewing skills that Tier 2 and

Tier 3 students need more support in to form targeted intervention groups. Teachers are using FastBridge data, classroom work, and observations to identify student strengths and challenges, set proficiency goals, and plan small-group instruction.

The PLCs also discussed upcoming community activities, such as possible pumpkin patch visits to local farms. In addition, teams explored new tools and resources, including Saxon adaptations, IXL, and planning for the future implementation of Canvas and NAAVY to streamline curriculum, lesson plans, and assessments. Through this collaborative work, our staff continues to build a responsive, data-driven learning environment for every student.

School Improvement Team (SIT):

The School Improvement Team recently participated in a school accreditation training in preparation for our upcoming engagement review. Several lead members from Cognia were in attendance to provide guidance and support. During the training, all SIT members gained access to the Cognia portal and worked collaboratively on strategies, assurances, summaries, planning, artifacts, and a thorough review of the standards. Using the Cognia Padlet, the team evaluated our school's performance across various standards—an invaluable learning experience that has strengthened our readiness for this spring's review. Currently, the team is also completing a required Cognia course to ensure full preparedness for the upcoming engagement review.

The Chief Financial Officer and Business Manager have the following report:

- The Business Manager classes will be starting again in November for the CFO, Business Manager and Business Manager Technician to attend those courses.
- All the budgets have been approved by the School Board and have been put into Software Unlimited.
- All the claims from last year are made. We will be starting on this year's claims.
- We have put in the 2023-24 Title claims and the last CLSD claim. CLSD is done now, and the Belcourt School District will no longer have that budget.
- We attended the North Dakota School Board conference in Bismarck last week.

Construction and Renovation Activities (TMCS Business Manager):

Federal Government Shutdown (short term) Status on Belcourt School District:

- Most Federal Formula funding is protected: Many of the BSD#7 core federal education programs, such as Title I, II-A and IV and the Individuals with Disabilities Education Act (IDEA), are "forward-funded."
- This means the money for the 2025–26 school year was already appropriated by Congress in 2024 and will continue to be disbursed by State of North Dakota.
- Federal Department of Education technical assistance is paused: The furlough of nearly 90% of U.S. Department of Education staff means that our BSD#7 will not have access to technical support and policy guidance. Fortunately, ND DPI remain open with full staff ready to offer assistance and guidance.
- Federal Department of Education Recent Layoffs: The Education Department had about 4,100 employees last January 1, 2025, per various news media reports; After layoffs in spring 2025 and the new layoffs, the DOE would be down to fewer than 2,000 employees. Again, the majority of federal funding received by BSD#7 as a public school is passed through the state, who provides oversight and guidance already.

- National School Lunch Program (NSLP): Federal reimbursements for school meal programs may be delayed if the shutdown continues. The U.S. Department of Agriculture (USDA) has previously indicated it has enough funding on hand to continue reimbursements for approximately three months.
- NIEA Letter: The National Indian Education Association (NIEA), together with a coalition of national and Tribal organizations, has issued an inter-organizational letter to the Office of Management and Budget and the U.S. Department of Education calling for an immediate cancellation of Reductions in Force (RIFs) affecting staff in the Office of Indian Education (OIE), Impact Aid, and other Native-serving programs.

Future Federal Funding affecting BSD#7:

- Title I 2024-2025 allocation was \$3,532,217 and carryover formula 2023-2024 is \$283,961.55; combined for a 2025-2026 Title I budget of \$3,418,953. There would be a \$1.6 million dollar cut to the 2025-2026 Title I allocation due to the change in allocation method used by state of ND. However, the Title I cut was mitigated as a result of ample carry over for 2025-2026.
- Title I budget current year 2025-2026 allocation is \$1,920,454 and carryover formula 2024-2025 is \$1,498,499; combined for a 2025-2026 Title I budget of \$3,418,953.
- Primary concern in our Federal budget area will be the cut to Title I as we will need to adjust from a \$3.42 million budget to an estimated \$2.2 million budget; which alone results in a \$1.2 million cut to our Title I for the 2026-2027 school year. In addition...
- For the 2026–2027 school year, federal funding for public schools is highly uncertain and will likely decrease, with a significant shift of responsibility to the states. The outlook depends heavily on the final budget compromise between the Trump administration, the House of Representatives, and the Senate.

2025-2026 District Wide Budget:

- The 2025–2026 BSD#7 school-wide budget approved by school board on October 14, 2026.
- The school wide budget includes General Fund 01, Food Service Fund 05 and Student Activities Fund 06.
- The 2024-2025 school wide budget was \$55,570,224,
- The 2025-2026 school wide budget was approved at \$61,800,108 which consists of:
 - The normal operational budget of \$52,112,428; plus
 - Bus Garage Construction (current) budget of \$4,755,680; and
 - the Alternative Programs Building Construction (current) budget at \$4,932,000.

Bus Schedules:

· Two Route Bus Schedule –

--1st route Elementary School with release at 2:30 pm; and

--2nd route Middle School with release at 3:20 pm and High School with release at 3:35 pm.

--Accommodations are in place for Elem students who ride home with older siblings in HS or MS.

--After School Late Bus Schedule – 2025-2026 Pick-up times are as follows: Elementary: 5:00 pm, Middle School: 5:15 pm and High School: 5:30 pm.

2025-2026 Bus Fleet:

- Our combined fleet is intended to be 24 route buses and 5 special education buses.
- However, we are currently running 22 regular routes and 5 special education routes, and...
- Two BIE bus driver positions remain in limbo until federal budget is final.

2025 Construction/Renovation Projects (Projects in motion currently):

1. Alternative School Facility (TMHS & TMMS) – Jiran Architects have been hired. Construction contract awarded to TF Powers as Prime and General Contractor; Electrical sub-contractor is BJ Electric and Mechanical sub-contractor is GD Mechanical. Project cost is estimated to be \$5 million. Project is well underway with 80% of the earthwork complete and footing form are being prepared for a concrete pour. The project is taking place north of the Middle School. The asphalt and soil beneath building footprint has been removed and replaced with appropriate fill. Anticipated completion by October 2026.
2. Bus Barn – Jiran Architects have been hired. Construction contract awarded to Industrial Contract Services (ICS) General Contractor, electrical contract awarded to Blue Lightening and mechanical contract awarded to Lunseth Plumbing and Heating. Project cost is estimated to be \$5.3 million. Project is well underway with 80% of the earthwork complete and footing poured. Anticipated completion by January 2026.
3. Elementary Playground Basketball Court and Canopy – Process has begun; completion projected by (weather permitting) end of October 2025, with exception of rubberized basketball court surfacing to be complete by spring 2026. Another canopy will be erected at the south side of the playground which will have electrical power and computer cabling to accommodate four electrical outlets, camera surveillance and wi-fi, which will also accommodate needs for an outdoor classroom.
4. TMHS Locker Room Renovation. The TMHS Locker Room Renovation Project is currently 90% complete. The project includes renovations to four locker areas, the two for boys and two for girls. Major upgrades include the replacement of old cage-style lockers with 84 new stadium-style lockers across all locker areas, and the installation of new rubberized flooring throughout the locker spaces. Additional improvements completed:
 - New white LED lighting installed in all locker rooms, including bathroom and shower areas
 - Installation of new hand dryers
 - Upcoming installation of new bathroom stall separators
 - Replacement of plumbing fixture hardware
 - Ceiling sheetrock repairs as needed

- Fresh paint on all paintable surfaces.

Information Technology has the following report:

- The TCP (TimeClock Plus) implementation is still underway. We are continuing with system configuration, testing, and staff coordination with TCP and Accounting. Efforts are focused on ensuring accurate time tracking and ease of use for all employees.
- Belcourt School District was recently awarded a Cybersecurity Grant. As part of this initiative, we will begin reviewing and ordering equipment to support a full network infrastructure refresh. This will improve security, reliability, and performance across all campuses.
- Daily technology support remains a priority. We continue to respond to student and staff needs, including troubleshooting devices, managing network access, performing password resets, and supporting essential software systems.
- We are also actively involved in ongoing local campus construction projects. Our department is working closely with contractors and administration to install and configure networking infrastructure, such as fiber runs, switch installations, and access points, in alignment with construction timelines and educational needs.

Turtle Mountain High School and Career and Technical Education have the following to report:

- As we reached the midpoint of the quarter, our teachers demonstrated exceptional dedication and teamwork during mid-quarter conferences. Each educator took time to connect with families, discuss student progress, and celebrate the growth happening in classrooms across Turtle Mountain Community High School. A highlight of this cycle was the intentional effort our staff made to strengthen home-school communication. Teachers personally reached out to every one of their HOOP students' families, making positive phone calls, sharing encouraging updates, and ensuring parents felt informed and valued partners in their child's success.
- These conversations not only reinforced trust but also helped identify ways to support students academically, socially, and emotionally as we move into the next part of the

quarter. The collective effort truly reflects our commitment to relationship-building and to the belief that every student thrives when home and school work hand in hand.

- As we approach the end of the first quarter, we are concluding our initial data cycle, an essential part of our MTSS framework. This process lies at the heart of how we support every student, from those requiring intensive Tier 3 interventions to our highest performing tier 1, advanced, college-bound learners.
- Academically, TMCHS successfully transitioned to the ND A+ State Summative Assessment, which fully aligns with North Dakota's updated content standards. Though results cannot be directly compared to the previous NDSA due to new benchmarks and testing design, the shift offers a more accurate picture of student learning and growth.
- English Language Arts (ELA): Students performed closer to proficiency than in previous assessments, with a noticeable reduction in the number of students testing in the Novice range. Performance levels are now comparable to state averages, showing that literacy initiatives and targeted supports are taking hold.
- Mathematics: Data indicates continued improvement, with fewer students scoring in Level 1 (below expectations) and more in Level 2 (nearing expectations) on the ND A+ Interim 1. This upward shift points to growing confidence in math skills and stronger alignment to instruction.
- Science: While scores show more students in the Novice category this year, this trend reflects the adjustment to new, more rigorous content standards. TMCHS teachers are already responding with focused interventions and curriculum alignment to ensure steady gains in upcoming testing cycles.

Attendance Matters: Progress Worth Celebrating!

- TMCHS continues to make great strides in improving student attendance this year. Compared to last year, we've seen a 2% increase in overall attendance, a reflection of our staff's dedication, consistent communication with families, and targeted student supports. One key area of focus has been reducing first-hour tardies, as those early minutes set the tone for the day. Through intentional interventions, positive reinforcement, and accountability checks, we successfully cut first-hour tardies by nearly 50% in just one week! These improvements show that when we work together, students, families, and staff, we can create lasting habits that build responsibility, readiness, and pride in being a Brave.

Special Education Report:

- *ISEP Reviews* - Belcourt Public Schools recently participated in the Bureau of Indian Education (BIE) Indian School Equalization Program (ISEP) Review. This review is an important part of ensuring our programs meet federal requirements and provide high-quality, equitable services for all students with disabilities. The process included reviewing student records, instructional practices, compliance documentation, and interviews with staff. We appreciate everyone's collaboration and preparation throughout the review. These efforts help us continue improving our services, maintaining accountability, and ensuring that every student receives the support they need to succeed.
- *Child Find & MTSS* - Turtle Mountain Community Schools are committed to identifying and supporting every learner's needs through our Child Find and MTSS processes.

Child Find is a continuous process used to locate, identify, and evaluate children who may have disabilities and need special education services. This includes students from birth through age 21—whether enrolled in public school, private school, or homeschooled. Staff play a vital role in this process by recognizing early signs that a child may be struggling and ensuring concerns are documented and communicated to the appropriate team members.

- MTSS provides the structure for early identification and intervention. Through tiered levels of academic and behavioral support, our teams can address learning or behavioral challenges proactively, often before a special education referral is needed. Regular data collection, progress monitoring, and team collaboration help ensure that every student receives the right level of support at the right time.
- We encourage all staff to remain engaged in the MTSS process, document interventions, and collaborate with specialists to ensure students' needs are met. When concerns persist despite multiple tiers of support, a referral for special education evaluation may be appropriate, and our Child Find procedures help ensure that happens efficiently and with care.
- Together, these systems work to ensure no child falls through the cracks and that every student has equitable access to the support they need to succeed. Thank you for your ongoing commitment to student success, collaboration, and early intervention. If you have any questions or concerns regarding a student, please contact your school's MTSS team, which is comprised of highly educated staff of diverse backgrounds.
- *Staffing* - Like many districts across the state and nation, we are currently short-staffed in several areas of special education. We are grateful for the patience, teamwork, and flexibility shown by our staff as we continue to serve students with dedication and care. Many of our schools are actively seeking additional special education teachers. Athletic Directors Report:

Turtle Mountain Community Schools athletic programs are finishing up fall programs. The high school cross country, and girls' golf programs along with elementary girls' basketball, elementary football, middle school football, youth soccer, youth cross country, and middle school cross country are all finished for the year. Over 400 students have signed up for fall and winter sports programming this year K-12. The more opportunities we can provide, the more we contribute to our academic success, attendance, and overall eligibility and leadership experiences. Programs still in action are high school and middle school volleyball, youth softball, and this week will close out our football programming.

Our high school volleyball team has been experiencing some exciting competition as they moved to regional play separating, respectively, from the Western Dakota Association in that sport. With that, our program has been seeing some success and exciting competitive play. Currently, the program is in 6th position with a 2-3 record. The Volleyball team will have some very important games down the stretch to hopefully make a play-off regional run.

The football season didn't go as well as expected but there are some key takeaways, number one, coach Desjarlais has had the same number of kids come out and stay in the program all year which is great as you all know, football is a game of numbers. You need numbers for practicing and scrimmaging so that we get a good look when scouting other teams and when running schemes (you need at least 22 players to do that). We have also had consecutive weeks where all 43 players are staying eligible, which contributes to our academic excellence programs and attendance initiatives in our schools. It is only a matter of time until the Wins start coming with the details coach Desjarlais and his staff put in.

Our cross-country program did very well this year. This marks the first year, in over a decade, that we have had the participation that we had. Coach Marion has sparked a new interest to many. This was marked with some impressive finishes as a team and individual finishes amongst the races that were ran this year.

Girl's golf was another program that was a highlight with continued growth. The most out for the sport in our tenure. The program has shown much growth in the next few years; we anticipate more growth. With the onset of our new 5 bay golf simulator building, we can only imagine the improvements and growth yet to come from our boys and girls golf programs. TMBCI Fields and BDYWC Construction Update:

The Byron Dorgan Youth Wellness Center is almost completed with their renovations. 7. Renovation of the outside basketball court
8. Possible parking lot extension by MAYO construction either this fall or next spring
