Administration Meeting was held on Monday, March 2nd at 9:00 a.m. The school provided an update on all events and activities happening in their buildings. You will find all their items listed throughout this report.

The 100-297 HS Grant Regular Board Meeting, BSD#7 SB Mtg. and BSD#7 RB Mtg. was held on March 10th with some exciting items up for approval on the agenda as follows:

1. BIE Waiver for 2027 to 2028 - Approved
2. TM Area Career & Technology Center (TMACTC) – Approved: The Turtle Mountain Community Schools are requesting support to pursue a regional Career and Technology Center. The Center would be a satellite structure and include the Rolette County Schools who will be members of the Center. We have invited Rolette, Dunseith, St. John, and Rolla to partner with us in the joint center and have received verbal confirmation from all schools except St. John. All schools that wish to be member schools must have a school board commitment submitted with the proposal for a new center. There is a minimum of 3 schools committing in order to submit the proposal (draft attached) to the ND CTE Department. A school that does not opt in at this time may have an opportunity to join at a later date based upon provisions that will be included in the Joint Powers Agreement (draft attached).

Benefits of the center include significant financial support from the ND Department of Career and Technical Education, shared resources including staff, technology, and training, and exponential access to many varied programs for member school students.

We are requesting support from the Belcourt School District #7 Board of Education in the form of board action with the signature of the President to move forward as a member school and submit the proposal to the ND CTE Department for consideration. This will be of no increased financial commitment to the Belcourt School District #7 or Turtle Mountain Community High School.

Professional Learning and District Improvement:

February was a busy and exciting month across the district. During the first week of February, Turtle Mountain Elementary School hosted a Standards-Based Instruction training led by Laurie Elliott and supported by Claudette Gourneau. This training provided staff with valuable guidance and practical strategies to strengthen instruction, improve classroom practices, and align teaching more closely with North Dakota academic standards.

In addition, our district-wide team attended the final week of North Dakota MTSS training in Jamestown, North Dakota. The team gained new processes, ideas, and strategies that will support our ongoing efforts to improve our district MTSS system and strengthen the way we respond to student academic, behavioral, and social-emotional needs. During the last week of February, Turtle Mountain Community High School also hosted the Standards-Based Instruction training. Staff at both TMES and TMHS were engaged, enthusiastic, and eager to begin implementing the instructional practices introduced during the training.

With the continued support of our district leaders and school leaders, our schools will continue to make progress as we strengthen systems, refine instructional practices, and stay focused on meeting the needs of all students. Overall, February was a productive month marked by professional growth, collaboration, ongoing improvement of our district MTSS system, and stronger instruction across the district.

Federal Programs Officer report and Tiny Turtles Pre School Program report:

Federal Programs:

- Continue to work with Financial Director to ensure the federal program budgets and the BSD accounting budgets are aligned. Continue to work with Financial Director to address claim issues.
- Continue to work with TMCES, TMCMS, TMCHS on program reports, budgets, and compliance issues

- Continue to work with PFE Coordinator to ensure PFE compliance requirements are complete
- Continue to work with school social workers to identify and support homeless and foster care students; we currently have 73 Homeless students 23 students in foster care. Continue to work with Tribal Child Welfare and state agencies to support foster care students. Continue to meet with Homeless Committee on a regular basis.
- Community Care Day was a success; 260 people attended.
- Continue to work with ND DPI, ND DHH, and other state and federal agencies to address program matters/issues
- Continue to work with the St. Ann's School leadership team on Title I, Title II, and Title IV budgets and ensure compliance of PFE activities. Continue to work with St. Ann's Reading Intervention Teacher.
- Approve and process PO's for all federal programs.
- Continue to work with staff schoolwide to provide funding for projects, if funding is available
- Continue to distribute B-HERO newsletter and other publications to all staff

Committee Updates:

Student Council / Student Activities Committee: The Student Council and Student Activities Committee have organized a St. Patrick's Day Dance for students in grades 6–8. Eligibility to attend is based on positive behavior, with students required to have no referrals between March 3 and March 17.

Additionally, the January Class Attendance War winners have been rescheduled and will attend their reward trip to Bottineau Winter Park on March 11.

School Improvement Team (SIT):

During the months of January and February, the School Improvement Team (SIT) continued focused work aligned to our Plan 4 Learning (P4L) goals and ongoing school improvement efforts.

Plan 4 Learning (P4L): The team reviewed mid-year progress toward our Reading, Math, Attendance, and Communication SMART goals. Winter NDA+ and FastBridge benchmark data were analyzed to identify trends, celebrate growth, and determine areas requiring additional support. Continued emphasis was placed on maintaining consistent implementation of the full reading and math instructional blocks across grade levels.

Data Review & Monitoring: Winter benchmark data showed measurable growth in decoding, fluency, comprehension, and math computation in multiple grade levels. Tier 2 interventions remain a priority to strengthen student skills and move students closer to Tier 1 performance levels. Attendance data was also reviewed, as consistent attendance continues to be a key factor impacting academic achievement.

Improvement Planning & Next Steps: Key focus areas identified for continued improvement include:

- Monitoring fidelity of reading and math block implementation
- Strengthening Tier 2 intervention supports
- Continued progress monitoring using winter data
- Exploring scheduling options for additional professional development opportunities

The SIT remains committed to data-driven decision-making and continuous school improvement to positively impact student outcomes at Ojibwa Indian School.

Safety Committee:

The Safety Committee discussed protocols regarding potential ICE presence on campus. Mr. Keplin clarified that ICE is not permitted on the reservation.

The team also discussed implementing automated attendance calls through NASIS to notify parents/guardians when students are absent. This initiative is especially important given ongoing frigid weather conditions, as it will help ensure student safety and timely communication with families.

It was announced that the School Resource Officer (SRO) will be on campus one week each month to assess school climate, build relationships with students and staff, and maintain a visible presence.

Some ERC staff members have been relocated to Pod D. The school is currently awaiting approval to purchase a new camera system, upgraded exterior doors, and an intercom system to strengthen overall campus security infrastructure.

A fire drill was conducted on February 5, 2026. Overall, the drill was successful. Staff were reminded of the appropriate radio channels to use during emergency procedures.

The Chief Financial Officer and Business Manager have the following report:

"Make sure all payroll items are in by Monday at 4:30 pm. We have been getting items late Wednesday and the payroll is already done."

The food audit is nearly complete. The only remaining items are the CN labels, which the Elementary staff are currently in the process of obtaining.

A district-wide meal plan meeting was held to discuss meal plans for all schools. Following that meeting, we will schedule additional meetings with the administrators to discuss an implementation process for hopefully the fall of 2026 school year.

The annual audit is nearing completion, with a submission deadline of March 31, 2026. The auditors have submitted additional questions, and Duane and I are currently working to provide the requested information.

Construction and Renovation Activities (TMCS Business Manager):

- 1. Alternative School Facility (TMHS & TMMS)** – Jiran Architects have been hired. TF Powers as Prime and General Contractor; Electrical sub-contractor is BJ Electric and Mechanical sub-contractor is GD Mechanical. Project cost is estimated to be \$5 million. The project is taking place north of the Middle School. Footings have been poured. The building package arrived by February 13, 2023, at which time erection of structural framing began. Anticipated completion by October 2026.
- 2. Bus Barn** – Jiran Architects have been hired. Contractors: Industrial Contract Services (ICS) General Contractor awarded Blue Lightning Electrical Contractor and Luneth Plumbing and Heating Mechanical Contractor. Project cost is estimated to be \$5.3 million. Major completed work includes the concrete foundation and floor with plumbing and electrical conduit installed temporary electrical power, structural framing, metal roofing, steel erection, insulation, and completion of exterior and interior wall sheeting. Current work includes installation of overhead doors, temporary lighting, electrical conduit, and venting for heating systems. Upcoming work will focus on mechanical heating and exhaust equipment installation, electrical service and distribution systems, and additional conduit for lighting, outlets, communications, and safety systems. Exterior earthwork will be addressed along with planned asphalt paving in summer 2026. Framing and metal panel work are expected to be substantially complete by the end of March 2026, general construction by the end of April 2026, and mechanical and electrical work by May 2026. Asphalt to be bid soon.
- 4. 2023-2024 Annual Audit** - The annual audit field work portion of the audit for the Belcourt School District took place at the Business Office from January 19th through January 23rd, 2026. The auditing firm is Brady Martz out of their Grand Forks office. The final audit report itself will be completed by March 31, 2026, which is the date the audit must be submitted to ND State Auditor and Federal Audit Clearinghouse.

There were no major findings. The audit continues off-site at the Brady Martz offices in Grand Forks. Completion by March 31, 2026

5. **2023-2024 TMHS ISEP Audit** – The on-site BIE ISEP audit occurred March 9, 2026, thru March 12, 2026, at Turtle Mountain High School. The ISEP audit reviews the accuracy and compliance of the school’s Indian School Equalization Program (ISEP) student count and related documentation that determine federal funding allocations. In relation to the business office, the audit ensures that enrollment records, eligibility documentation, budget, procurement, accounting and reporting procedures are properly administered, maintained and aligned with Bureau of Indian Education requirements. The ISEP audit verifies that student counts used for funding are accurate, that federal funds expenditures are properly supported by documentation, and that internal processes meet BIE compliance standards, helping protect the school from funding discrepancies or audit findings. Complete by April 1, 2026.
6. **Title I Monitoring Review** – Conducted by the North Dakota Department of Public Instruction (ND DPI) as a compliance and program review process to ensure that schools receiving Title I federal funds are using those funds properly and meeting all requirements under the Elementary and Secondary Education Act (ESEA). During the review, ND DPI examines program documentation, funding use, student eligibility, parent involvement activities, and staff responsibilities related to Title I services. The purpose is to verify compliance with federal regulations and ensure the program effectively supports students who need additional academic support. BSD#7 received an allocation of Title I funds in the amount of \$1,920,454 for the 2025-26 school year.

ND DPI in its review of business office area assures school uses proper procurement to assure there is no:

- Lack of documented procurement procedures or policy for purchases made with federal funds.
- Failure to obtain multiple quotes or bids for purchases above required micro-purchase thresholds.
- Insufficient documentation on how vendors were selected or how price reasonableness was determined.
- Splitting purchases into smaller amounts to avoid competitive bidding requirements.
- Not maintaining records of contracts, quotes, or procurement decisions.

ND DPI in its review of business office area assures school has:

- Written procurement policies
- Quote/bid documentation for purchases
- Purchase approvals according to procurement policy
- Vendor selection records
- Contracts tied to Title I expenditures requiring a contract with vendor

Turtle Mountain Community High School Report:

This month at Turtle Mountain Community High School, we completed an on-site review of several of our Indian School Equalization Program (ISEP) programs, including Gifted and Talented, Enrollment, Curriculum, and Native Language. As part of this process, TMCHS hosted the Bureau of Indian Education (BIE) audit team, whose members traveled from across the country to spend several days observing classrooms, reviewing school systems, and engaging with staff and students. The Special Education portion of the review will be completed soon.

The review went very well; the auditor had a lot of positive things to say. This recognition reflects the collective commitment of our entire school community. From the dedication of our educators and support staff, to the perseverance of our students, and the partnership of our families, the success of this visit represents a shared accomplishment. The audit process affirmed that the work happening each day at TMCHS is making a meaningful difference and setting a strong example for others to follow. We extend our sincere appreciation to everyone who contributed to making this experience a source of pride for our school and community.

It is also an exciting time for our athletics programs. Our boys' basketball team is currently ranked #1 in Region 3A and will compete tonight in the Region 3 Class A Championship game. Our girls' basketball team also had a successful season, finishing third in the Region 3 Class A tournament. It has been encouraging to see our student-athletes compete at such a high level while representing TMCHS with pride.

In addition, we are currently analyzing dual credit course enrollment data and finalizing fall reporting measures. During the first semester alone, TMCHS students earned more than 1,000 dual credit college credits, reflecting strong participation and commitment to advanced academic opportunities. Our continued partnership with Turtle Mountain Community College has strengthened the school's Tier 1 level of instructional rigor while expanding access to college-level coursework. This collaboration helps students build essential post-secondary skills, confidence, and academic readiness, positioning them for greater success in higher education and career pathways after graduation. TMCHS is deeply grateful for this valued partnership and for the opportunity to work alongside higher education instructors who help provide meaningful, real-world learning experiences for our students.

Turtle Mountain Special Education Report:

Our Special Education teachers are actively preparing students for state assessments (ND A+ Summative and NDAA). They first review each student's Individualized Education Program (IEP) to ensure all required testing accommodations are identified and implemented. These accommodations may include extended time, small-group testing, read-aloud support, or assistive technology. Teachers also help students become familiar with the testing format and tools, including practicing with sample questions and navigating online testing platforms so students feel comfortable with the process before test day.

In addition, special education teachers focus on targeted instruction and skill reinforcement aligned with grade-level standards to support academic readiness. They monitor student progress, teach test-taking strategies, and work collaboratively with general education teachers and testing coordinators to ensure accommodations are provided correctly. This preparation helps reduce student anxiety and ensures students with disabilities have equitable opportunities to demonstrate their knowledge and abilities during state assessments.

Special education school leaders will begin meeting to plan transition meetings for students moving between schools (e.g., Elementary to Middle School, Middle School to High School). These meetings are essential for ensuring a smooth transition and providing continuity of support for students in the upcoming school year. The transition process allows teams to review student needs, accommodations, and services so that receiving schools and teachers are well prepared to support students within the new school setting. These discussions also help staff proactively plan appropriate support and interventions, ensuring students continue to receive the services necessary for their success.

Athletic Directors Report:

The winter sports season is ending. With that, we had some fantastic finishes. One for the ages was having the boys' and girls' regionals held at the Byron Dorgan Youth Wellness Center. There were so many volunteers and people that chipped in to make this a very memorable event for our community. Thank you to all of you that contributed.

As reported from head coach Marcellais, this season was a historic year for the girls wrestling program. At the West Region Tournament, we qualified 15 wrestlers for the NDHSAA State Individual Tournament and finished 5th out of 23 teams.

At the NDHSAA State Individual Tournament, four Braves placed in the top eight:

Aryonna Gourneau – 3rd place (190 lbs)

Cassidy Azure – 4th place (142 lbs)

Aleah Martin – 8th place (170 lbs)

Azhanii Martin – 8th place (250 lbs)

In addition, the team qualified for the State Dual Tournament for the first time in program history and finished in 7th place in the state.

Academically, the program also performed well, with 13 wrestlers earning NDHSAA Academic All-State honors, demonstrating the commitment these athletes bring both on the mat and in the classroom.

As reported by head coach Trottier, the boys' braves wrestling season was very successful. Some milestones of the year were doubling our dual wins. We came in 5th place in our WDA pool, one win away from qualifying for the dual tournament. We increased the number of state participants. We had over 70 more varsity wins than the year before. We brought home a team trophy, which we have not done since 2019. We doubled our numbers of state places. I think our biggest accomplishment, we only lost 6 wrestlers from the beginning of the year, ending the year with almost 40 wrestlers.

We lose 3 seniors. Their leadership will be missed, but we return a good core of sophomores and freshmen. We have lots of potential and planned our summer out to reach that potential. We are starting team lifting in March. We plan on going to NDSU team camp. We plan to host open mats all summer long. We also plan on bringing in different clinicians for summer wrestling camp.

The girls' basketball team finished the conference as the 2nd seed with a conference record of 6 wins and 2 losses and went into the Regional Tournament with high expectations. As reported by Coach Gourneau, the girls' varsity basketball season ended with a loss in the state play-in game against the Watford City Wolves. Although we were disappointed with the result, we had a very successful season overall. We are proud of our players' performance and the teamwork of our coaching staff. Our varsity team finished the season with an impressive record of 17 wins and 7 losses.

This year we had four girls selected as All-Region athletes:

- Akealyes Azure
- Emberlyn Poitra
- Aubree Jeanotte
- Irelei Zerr

Looking back, the progress of the TMCHS Braves girls' basketball program has been significant. The program has grown and improved, which makes us proud. Both coaches and players have committed to our team system, showing dedication on and off the court.

Players demonstrate their commitment by participating in off-season training and working to improve their skills. They also volunteer to help younger players at elementary and junior high levels. We are especially proud that all our players maintained good academic standing throughout the season.

This season has helped players develop a deeper love for basketball. Many want to learn more about the game, train hard in the off-season, and continue improving their skills. Our athletes understand that individual goals must support team goals, and they are willing to work together.

Our success comes from the hard work of both players and coaches. By staying engaged during the off-season, we will help our program grow physically, mentally, and emotionally. We see this season as a success for our girls' basketball team and the entire TMCHS athletic program.

Our goal remains winning the state championship, and we believe our program is on the right path to achieve this.

Our boys' team finished as Conference Champions with a conference record of 6 wins and 1 loss. At the Championship Game, Turtle Mountain was defeated in a back-and-forth battle by the Dunseith Dragons who punched their ticket to the State Tournament. Our boys punched their ticket to the State A Play in Game on Saturday vs. Dickinson Trinity. It was a fantastic finish to this year's Regional games and Regional play in game. We will now ready ourselves for the State A Tournament. Coach McGillis was named "Coach of the Year", and Senior William Breland was named "Senior Athlete of the Year." We had three All Region Selections as follows:

2025-2026 North Dakota Student Engagement Survey (NDSSES), Grades 3-12

The NDSSES provides students with an opportunity to express their level of engagement with school and the school environment. Students' perceptions are key to improving their learning experiences and development, and the results should be used for instructional improvement and guidance for your district's continuous improvement.

Behavioral engagement measures observable actions or participation while at school exhibited by a student's positive conduct, effort, and participation. **Cognitive engagement** measures a student's investment in school and learning. **Emotional engagement** measures a student's feelings toward school, learning, teachers, and peers. Finally, a fourth domain has been added for research purposes. Namely, **school belonging** measures a student's sense of inclusion or exclusion at school.

Results within each engagement domain are reported by type of engagement: **committed**, **compliant**, and **disengaged**. Belonging is identified at **high**, **moderate**, and **low** levels. All domains also have scale scores. For grades 3-6, scores range from 1-4 where 1 is the lowest possible engagement and 4 is the highest possible engagement. For grades 7-12, scores range from 1- 5 where 1 is the lowest possible engagement and 5 is the highest possible engagement.

Descriptions of each domain and engagement levels are included on page 2.

Domains and Engagement Level Descriptions

1. Engagement Domains – The sets of items are grouped into three engagement domains:
 - a. **Behavioral Domain** – A student's behavior or effort in the learning environment.
 - i. Attendance, suspension, participating in school activities, punctuality, etc.
 - b. **Cognitive Domain** – A student's intellectual investment in learning.
 - i. Time on task, homework completion, engaging in class activities, relevance of schoolwork, value of learning, etc.
 - c. **Emotional Domain** – A student's feelings about the classroom and school.
 - i. Enjoying being in school, around classmates, and around educators.
 - d. **School Belonging** – A student's sense of inclusion or exclusion at school.
2. Engagement Types – The ways in which a student responds to the learning at hand:
 - a. **Committed** – Students are attentive to the task, finding personal meaning and value in the task. Committed students may present in the following ways:
 - i. The student is recognized as knowledgeable and typically turns in strong work. They rise above others by consistently high performance. They retain most of what they learn and have a deep conceptual understanding. These students connect with what they learn and apply what they are learning to their life.
 - b. **Compliant** – Students are willing to complete the task because of their desire to follow directions or rules. Compliant students may present in the following ways:
 - i. The student allocates only as many resources as required to get the reward offered or desired. The student is attentive to the task because the student perceives the receipt of some desired extrinsic reward which is conditionally available to those who pay attention to the task and do what is required of them. The student persists with the task only up to the point of ensuring that the desired reward is offered.
 - ii. The student does only those things that must be done and does little or nothing outside the context of direct supervision by the teacher. The student pays minimal attention to the work, is easily distracted, and seeks alternative activities.
 - c. **Disengaged** – Students are non-compliant and choose not to be involved in the learning at hand. Disengaged students may present in the following ways:
 - i. The student does not attend to the work but may not distract others. The student employs strategies to conceal disengagement.
 - ii. The student overtly refuses to comply with the requirement of the task. This refusal may involve cheating, refusing to do the work, or even doing other work in place of what is expected. They may create significant distractions for other students.
3. School Belonging – Students are categorized as showing a high, moderate, or low belonging:
 - a. **High Belonging** – Students feel a strong sense of inclusion at school.
 - b. **Moderate Belonging** – Students do not feel especially socially included or especially socially excluded at school.
 - c. **Low Belonging** – Students feel a strong sense of exclusion at school.
