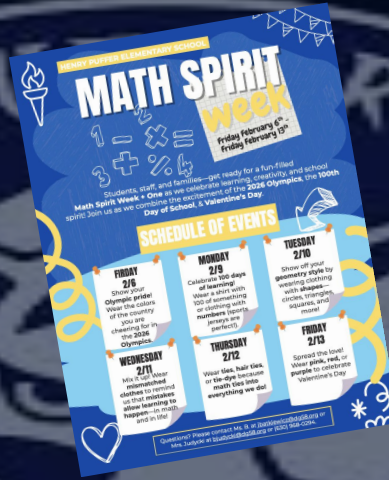

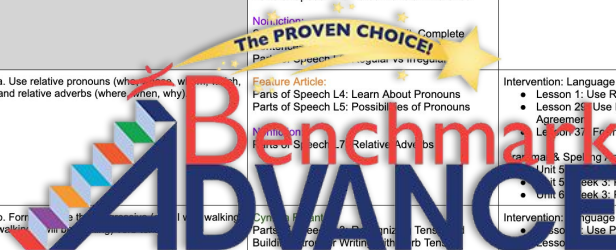
2025-2026 School Improvement Goal #1

- Analyze student work and assessment data to design targeted instruction

- Use Teacher Estimates of Achievement to adjust instructional decisions
- Plan intentional small-group instruction focused on informational text comprehension
- Integrate resources such as Scholastic News and Scope regularly to strengthen informational text practice

By Spring 2026, students will increase their problem-solving proficiency, as measured by ECRA's Propensity Model, with more students meeting or exceeding growth targets in the Operations & Algebraic Thinking domain.

- Integrate deliberate practice into daily math instruction.
- Review Forefront, MAP, and ECRA data during grade-level collaboration to monitor progress and adjust instruction.
- Use backward design consistently, with a targeted focus on problem-solving standards.
- Provide instructional coaching to support planning, data analysis, and modeling of strategies.

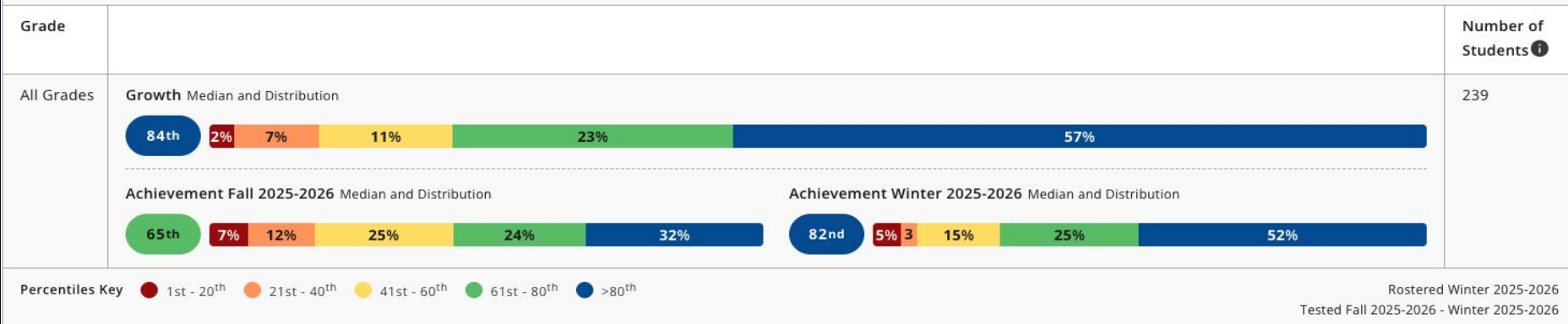


Winter 2026 NWEA MAP Data - Overall

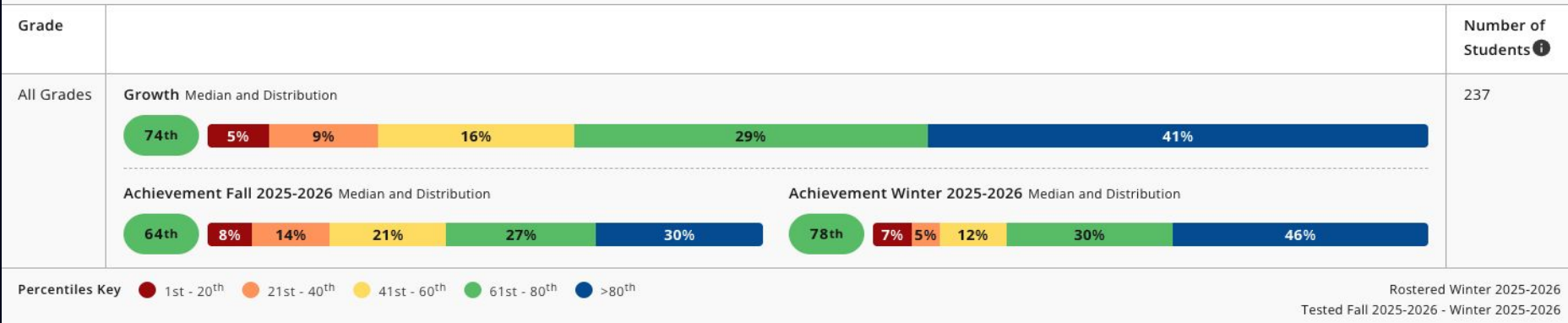

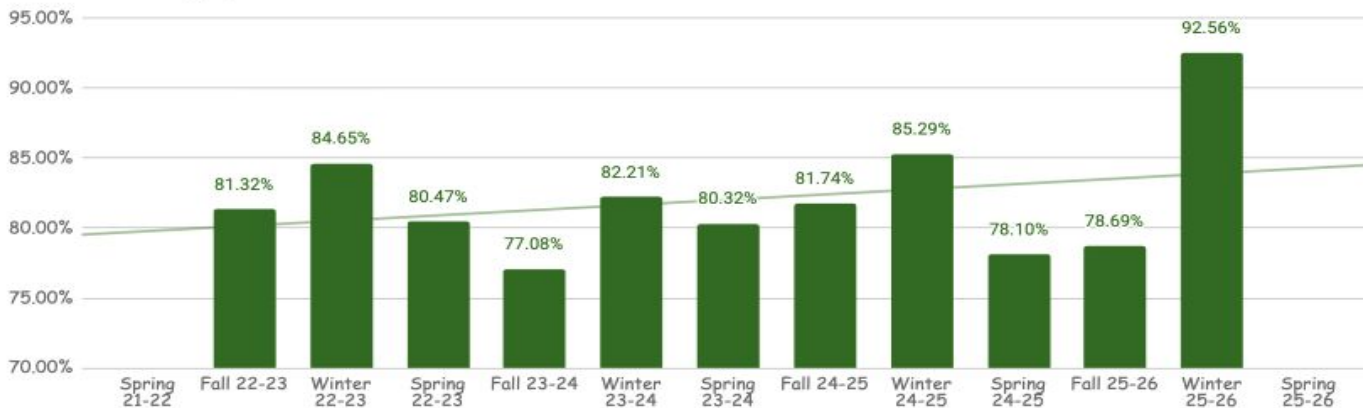

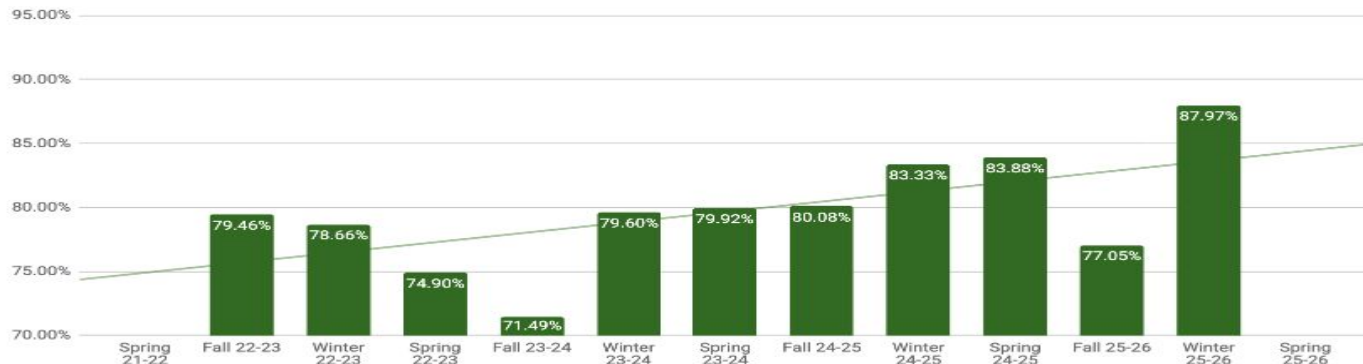


NWEA MAP Data - Trend Over Time

10-year Health Life Safety Inspection Process



School districts in Illinois have been mandated by the State to have each of their schools surveyed for life safety and other issues every 10 years, and to have a report prepared that certifies the buildings are in compliance with applicable codes, or describes the work required to bring its facilities into compliance.

Process and Methodology

- Qualified professionals survey school buildings to determine compliance with the Health Life Safety Code for Public Schools, Part 180. Depending on the age of the school, varying code requirements apply to each building. Any violations found are prioritized in accordance with the following:
 - **A. Urgent:** Items that present an immediate hazard to the safety of students. These violations must be addressed within 1 year. Examples: Structural; egress; fire protection; fire detection.
 - **B. Required:** Items that are necessary for a safe environment, but present less of an immediate hazard to the safety of students. These violations must be addressed within 5 years.
 - **C. Recommended:** Items that do not present any immediate hazard to the students. Examples: Energy conservation; security; repair of school sidewalks, playgrounds, or parking lots; accessibility.

The qualified professionals then prepare a report documenting the violations and recommended actions to be taken to correct the violations, including associated costs. They also update the Safety Reference Plans and Safety Reference Documents for the buildings.

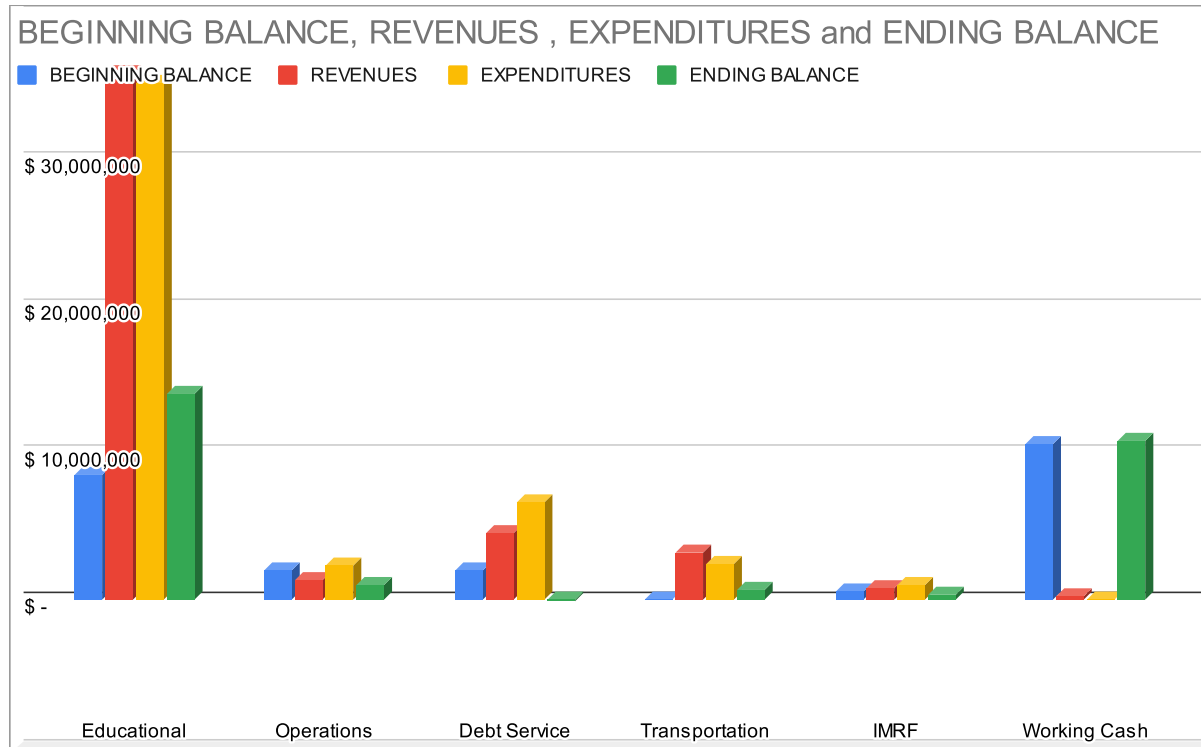

Background Information

- Meetings/Discussions with Kindergarten teachers and administrators for several years; resumed this school year (with strong representation from Kindergarten team and administrative team)
- Goals of setting all students up for success as they enter kindergarten
 - Building a school community when all are present
 - Gathering as much information as possible to ensure class configurations and groupings support our students

- Elementary School Meet-and-greet (one event for K-5)
 - Held a few days prior to the first day of school
 - Supply drop off



Enhancement - Separate Meet & Greet

- Provide a separate opportunity for Kindergarten supply drop-off and initial meeting
- Potentially one day prior to Gr 1-5, 4:00-5:00 pm
- Opportunity for everyone to see the classroom in a less populated environment with focus on Kindergarten
- Opportunity for family reminders about first day experiences



Enhancement - First Days Experience

“Camp Kindergarten” or “Team Kindergarten”

- Build community first, classroom second
- Students will come into school assigned to a “team” rather than a classroom teacher
- Students are grouped randomly (i.e., alphabetically) for the first two days of school
- Students have an opportunity to meet and interact with all of the adults who will support them; staff meet all students as well
- Groups are fluid among students, but experiences are common as they are led by the same adults



Enhancement - First Days Experience

- Emphasis on building a Kindergarten community and becoming a member of the school community and how to be a Kindergarten learner - not on academic/skill assessment
- Provides comfort and consistency in the transition to a new school
- Parents will be informed of their child's classroom teacher after day 2 (Friday)
- Day 3 (Monday) begins classroom communities, where students are grouped by classroom teachers



Prior “Camp Kindergarten” Experience

Whittier School (2018 and 2019) and
Fairmount School (2019)

- Positive responses from staff and families
- Individual questions from families (1-2 per school) centered on logistics/further explanation
- Communication was critical



Next Steps

- Confirm and build-out logistics for both the meet & greet and the initial Kindergarten experience
- Develop communication materials to be shared at Kindergarten Round-Ups, which begin in March
- Collaborate with entire Kindergarten team to ensure consistency of experiences and expectations districtwide
- Implementation in Fall 2026; surveys of families and staff after implementation to reflect on experience and seek potential improvements

RE: 2026-2027 Student Fees

Background: In recent years, the Board of Education has approved increases to student fees largely in line with the consumer price index (CPI). However, the administration is recommending that, in light of the District's financial challenges, the Board of Education get into the routine of doing a periodic adjustment (every five years) that takes into account an analysis of anticipated increases to the costs of the materials and services that these fees are meant to subsidize. Looking at the current trends and projecting into the future, the administration believes that a fee increase is justified based on the known increases of various fee-supported expenditures. These include, but are certainly not limited to, photocopying services, curricular supplies, and software/technology needs. Additionally, the administration is proposing the elimination of a separate fee for heart rate monitors—adding it into the general middle school fee—and proposing the addition of a technology fee for the use of student chromebooks at the middle school level.

Administrative Considerations: The administration is recommending that the Board of Education approve a fee increase in excess of CPI for school year 2026-2027 and then return to the normal CPI increase in 2027-2028. The proposed fee structure is as follows:

Description	Fee
Grades K-5	\$291
Grades 6-7	\$355
Grade 8	\$345

Outdoor Education <i>5th grade only</i>	\$60
Middle School Chromebook Fee <i>6th grade only in 2026-2027</i>	\$100
Transportation (paid)	\$775

The recommendation for elementary fees sees a \$25 increase from \$266 in 2025-2026 to \$291 in 2026-2027. The recommendation for the middle school fee sees an increase of \$35 from \$320 in 2025-2026 to \$355 in 2026-2027. The reason for the \$10 difference between the elementary increase and the middle school increase is heart rate monitors, which students use in their physical education classes. Previously, students were charged a separate one-time fee of \$25 for heart rate monitors when they entered middle school. The new recommendation is for a \$10 annual fee to be rolled into the general fee for all middle school students. As returning 8th graders in 2026-2027 have already paid for their heart rate monitors, they alone will pay a general fee of \$345 which does not include the aforementioned \$10 annual fee.

It should be noted that, in the current year and all years prior, sixth graders paid the elementary rate based on the District’s K-6 instructional model. Starting with the 2026-2027 school year, because of the opening of the additions at Herrick and O’Neill, sixth grade students will now be paying the middle school rate.

Aside from its general fees, the District has other categories of additional fees that it assesses on specific students for a variety of reasons. The outdoor education fee of \$60, which is only paid by 5th grade students, is not changing. The “paid” transportation fee, which is for students who wish to ride the bus but who do not qualify for transportation services under Illinois School Code because they live within 1.5 miles of their school and cross no identified hazards (e.g., the BNSF tracks or a major road like Ogden Avenue) to get there, is seeing an increase of 4.4% to \$775. This is approximately in line with the negotiated cost escalators in the District’s contract with its transportation provider, First Student.

Lastly, the administration is recommending that the Board of Education approve a new technology fee for middle school students. The vision behind this fee is that middle school students will pay \$100 annually for the use of their Chromebook and then get to keep that device when they are promoted to high school (assuming three years of payments). This model mirrors the experiences of high school students in District 99. Only incoming 6th grade students would pay this fee in the 2026-2027 school year. Incoming 7th and 8th grade students would not pay the technology fee, and thus they will not be allowed to keep their devices when they leave District 58. The plan is for all 6th and 7th graders to pay the technology fee in the 2027-2028 school year, and then all 6th, 7th, and 8th graders would pay it starting in 2028-2029.

Related to fees for next year, the administration wants to make the Board of Education and the community aware of a plan to reverse credit card fees back to the user for those who choose to utilize this particular payment method. The administration estimates that the District loses approximately \$30,000 in fee revenue because of the processing fees it pays on credit card transactions. For any family who wishes not to pay these fees, paying by electronic check remains an available option.

The Board of Education and the community should also be aware that, in accordance with Board policy 4:140, the superintendent waives the fees of students who meet certain criteria (qualifying for free lunches, homelessness, etc.).

Recommendation: The recommendation is for the Board of Education to approve the list of fees for the 2026-2027 school year as presented.

RE: Elementary Lunch Program - Equipment Procurement

Background Information

As the District implements a lunch program in the elementary schools, the purchase of additional equipment is necessary.

Administrative Considerations

Planning for the program and spaces was conducted by Wight & Company along with Reitano Design Group. Various adjustments were made for the appropriate equipment, including sizing, to incorporate the layouts into existing school spaces that will be repurposed from their current use. Equipment proposals were obtained through the Sourcewell public cooperative purchasing format via Trimark USA. Utilizing the public cooperative model will help ensure consistency of manufacturers and equipment similarities. Additionally, this procurement delivery format will help to greatly reduce lead time risk(s). Finally, the District is in agreement with the additional details and memos provided by both our construction manager, Bulley & Andrews, along with our referendum Owner's Representative, Huffman Keel Forge.

The total cost will be primarily funded by a \$500,000 state grant secured by Representative Stava-Murray. We are grateful to Representative Stava-Murray for her continued support of District 58 (she also secured funding that helped the District construct new modern playgrounds). The remaining portion of the costs will be covered by interest income from the construction referendum bond sale.

Recommendation

Motion to purchase food service equipment for the elementary schools from Tri-Mark USA, through the Sourcewell public cooperative, as quoted at a cost of \$588,965.00.

Bulley & Andrews has submitted its recommendation for the procurement of kitchen equipment for the Elementary Hot Lunch Program through the Sourcwell cooperative purchasing system (Contract #063022-SES). The selected vendor is TriMark USA. Our team, along with Wight & Co and the District, has reviewed this procurement method and the associated proposal in detail.

We are pleased to confirm that the proposed equipment package is consistent with the design intent established during the middle school phases and will provide each of the eleven elementary schools with a fully functioning warming kitchen. The use of a single-source vendor across all locations will simplify ongoing operations and maintenance for the Buildings and Grounds team. TriMark USA's performance during the middle school phase—where equipment was delivered ahead of schedule—further supports this recommendation.

The **total recommended award is \$588,965.00**, against a budgeted value of **\$639,105**—representing a savings of **\$50,140 (7.8%) under budget**. The competitive pricing achieved through the Sourcwell cooperative system, combined with TriMark's partnership with the referendum construction team throughout this process, further supports the market competitiveness of this delivery format.

We concur with Bulley & Andrews' recommendation to award dated February 3, 2026. The equipment selections, pricing, and installation scope are appropriate for the project. Detailed equipment specifications and individual school pricing are included in Bulley & Andrews' attached proposal. We look forward to reviewing any questions during the upcoming Board meeting.

On behalf of the District, for Elementary School Hot Lunch Program Bulley & Andrews is recommending the purchase of the necessary kitchen equipment through the Sourcewell cooperative purchasing system. B&A, Wight & Co, Huffman Keel Forge and the District have reviewed this procurement method and find it advantageous to the District for this phase of construction

The selected vendor through the Sourcewell program is Tri-Mark USA. The equipment to be provided will include Sinks, Countertops, Racks, Refrigerators, Heated Cabinets, Milk Coolers and other miscellaneous equipment to provide a functioning space. This selection was made based on the following criteria:

- Equipment Consistency: By selecting Tri-Mark USA, all 13 schools would have equipment provided from a single source contractor. This will make continuing O&M simplified for the Buildings and Grounds team for the lifecycle of the equipment.
- Schedule Certainty – Tri-Mark USA has consistently delivered their equipment for Middle Schools ahead of the required schedule.
- Budget Adherence – The provided pricing is in line with the budgeted value of this equipment. Tri-Mark partnered with the referendum construction team throughout this process and is delivering the final package at a value approximately \$50,000 less than initially figured. This fact, along with the competitive pricing structure within the Sourcewell system further supports the market competitiveness of this delivery format.

The total award value being recommended is five hundred eighty-eight thousand, nine hundred sixty-five dollars and zero cents (**\$588,965.00**). The individual breakdown per school is as follows:
