SHAC MEETING MINUTES

March 18, 2025

HISD BOARD ROOM

- Welcome and meeting called to order by Stephanie Gatlin at 12:09 p.m.
- There were no public comments.
- Recap of previous meetings: SHAC overview and by-laws, Northside Health Fair, SHAC QR Code on social media, Excellent Teen Choice, Tucker's Law and TEC 38.040, HISD Lice Policy and Procedure, and a presentation on drugs and consequences by Jana Enloe and Patrick Dooley
- Information Items:
 - Heard an update on the NIS Health Fair held on February 13, 2025
 - Discussed meeting topics for the 2025-2026 school year – no topics suggested during the meeting. Stephanie Gatlin encouraged SHAC members to email her about topics they would like discussed next year.
 - Discussed parent/community outreach which was sparked by the previous SHAC meeting where Jana Enloe and Patrick Dooley discussed what drugs they are seeing on the streets and the consequences in the courtroom. Stephanie Gatlin is in the beginning stages of preparation and hopes to have the outreach this school year or next school year at the latest. The plan is to have law enforcement officers (PD,SO, DPS) and a judge discuss what drugs are in our area, what charges come with different drug offenses, what mental health complications are seen with drug use, and where can someone go for help if they have a drug problem. This presentation would be approximately one hour to 1 ½ hours. In addition to posting on social media, use Remind to let parents know about the outreach.
 - Tucker's Law/TEC 38.040 – Texas DSHS will provide presentations on the dangers of vaping and Tucker's Law to HMS on April 7th, 22nd, and 28th. Currently working with HHS and DSHS to have the same presentations as middle school but it is difficult to schedule due to the amount of DSHS staff that is needed to cover HHS. These presentations may need to be moved to the next school year.
- Discussed SHAC membership for the 2025-2026 school year. Stephanie Gatlin will post the QR code on social media for anyone interested in serving next school year. Stephanie Gatlin encouraged current members to email her names and contact information of anyone they think would interested in serving on SHAC.
