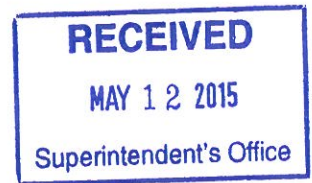

2015-2016 Windsor Teacher of the Year



Michelle Carras is the Windsor Public Schools Teacher of the Year for 2015-2016. A committee of her peers selected her from 41 nominated teachers. She has been a teacher in Windsor Public Schools since 2013 and is currently a Special Education teacher at Windsor High School. She previously taught at the CREC Hartford Juvenile Detention Center and in schools both in and around Albany, NY.

Michelle is a graduate of Marist College where she received her Bachelor of Arts Degree in Special Education/Psychology and a Masters Degree in Educational Psychology. Michelle lives with her family in East Hartford.

The Windsor Public Schools' Teacher of the Year Program recognizes and honors teacher excellence. It does not attempt to select the "best" teacher; rather, to identify, from among Windsor's many outstanding teachers, one teacher to serve as a visible and vocal representative of what is best in the profession. The program celebrates excellence in teaching by recognizing teachers who have inspired a love for learning in their students and who have distinguished themselves in the profession.

Windsor's Teacher of the Year selection process begins in March when teachers are asked to submit written nominations of colleagues. Nominations were received. Those teachers who were nominated then decided whether or not to continue in the process and be interviewed by a panel of colleagues. Following the interview process, a classroom visit takes place on the finalist. Michelle is now working on her State of Connecticut Teacher of the Year application packet.

The Windsor Board of Education announces the teacher of the year at its June meeting. The teacher of the year is invited to the September Board meeting and is formally recognized.

Background:

Music Fundamentals is a survey-style music course that provides students with an introduction to various elements of music. Topics covered include music history, music theory, and hands on performance using drums, piano, and guitar.

Economics is a semester long elective course that examines scarcity, supply and demand, money, credit, and banking, which prepares students to be financially literate after graduation from high school.

Grade 7 Health involves students in a myriad of hands-on activities and covers topics including drugs, alcohol, tobacco and HIV/AIDS.

Grade 8 Health presents a variety of topics to allow students to extend their knowledge of important concepts, specifically those related to drugs, alcohol, tobacco, nicotine, and HIV/AIDS.

The STEAM Guitar Project culminates in a custom-made electric guitar the students build by linking the concepts in STEAM (Science, Technology, Engineering, Art, Math) with manufacturing principles.

Jewelry Design 1 is an introductory design and fabrication course in the functional art/craft of jewelry making using metals as the primary media.

Sculpture is an elective course that permits students to examine their own relationship to three-dimensional space and how we identify with materials. This course applies basic understanding of 3D Design and applies it to a more conceptual level to convey messages and stories in student's work.

Psychology is an introductory course where students study individual behavior and cognition while examining various psychological theories and perspectives. Selected topics of investigation include the principles of learning, personality development and psychological research.

Grade 7 Social Studies World History focuses on the many aspects of the ancient world and its influence on modern time using a variety of inquiry methods.

Multivariable Calculus is an extension of Calculus topics that involve more than one variable. The course includes a study of Green's Theorem, Stokes' Theorem and Gauss' Divergence Theorem.

SUBJECT: Early Childhood Education, Roger Wolcott Building and Smart Start Grant Update
(Possible Action)

BACKGROUND:

Superintendent has recommended that the Board no longer pursue the Roger Wolcott opening for September due to the lack of time administration has to complete the necessary construction, purchasing, and hiring of staff to begin the preschool program.

The SmartStart grant remains approved for four (4) classrooms of preschool (\$300,000) and capital improvement work (\$300,000).

The State of Connecticut has confirmed that Windsor is eligible to file a grant modification and open up two (2) preschool classrooms for the 2015/16 school year. This would reduce the grant allocation to \$150,000. Remaining funds required for preschool operation (paraprofessionals) would be available through the Alliance grant. This would allow the district to service up to 30 additional students in preschool for 2015/16. It is anticipated that one (1) SmartStart classroom would be placed at Oliver Ellsworth and (1) SmartStart classroom would be placed at Poquonock. One (1) half day preschool classroom would be moved from Oliver Ellsworth to Poquonock. As stated previously there are two (2) available classrooms at Poquonock that would now be occupied.

This proposal requires no additional Board of Education general funds.


RECOMMENDATION:

Move the Board of Education rescind their request to have the Town of Windsor make the Roger Wolcott building available for educational purposes for July 1, 2015, that the town provide ECS funds related to the increased preschool enrollment and the \$75,000 for payment of utilities in relation to the operation of Roger Wolcott.

Move the Board of Education to approve the proposal for two (2) additional preschool classroom in the district for the 2015/16 school year to be funded through the SmartStart grant and the Alliance grant.

Move the Board of Education file a grant modification with the State of Connecticut on the SmartStart grant indicating the opening of two (2) preschool classrooms instead of the four (4) applied for and indicating it will not be accessing the capital improvement funds.



Re: Residency Report

This memorandum addresses school residency investigations in Windsor and is in response to a series of questions from the April 28, 2015 Board of Education meeting. Residency investigations involve numerous school district employees and are overseen by the School Residency Officer. The Residency Officer is part of the registration department which is overseen by the district's Director of Business Services.

Important requirements related to residency:

- Burden of proof falls on a family to prove residency, however the school district must be able to point to another district in which the student should be attending school.
- The law favors a student attending school while a determination is made.
- The person with whom the student resides with is not required to obtain legal custody of the student.
- Students may live with other family members or friends as long as the residency is:
 - Permanent (as defined by State of CT);
 - Provided without pay, and
 - Not for the sole purpose of obtaining school accommodations.

It is important to note that the term "investigation" is used broadly in the count detailed in the attached document. An investigation may range from a review of paper records or a discussion with a family in the registration department to surveillance on multiple occasions and discussions with family and others. Time involved could be from 15 minutes to days of work over the course of a year. Each investigation is counted the same in the attached document.

How does the district receive referrals?

Residency referrals become known to the district in a variety of ways such as completion of a district form (attached), anonymous information, employee notification, citizen notification, crossing guards, school security personnel, bus driver, or student/family notification.

What is the process for referrals?

Referrals received are initially reviewed by the school principal. The referrals are then forwarded to the Residency Officer. The following steps are taken by the Residency Officer:

- Review student database information (PowerSchool)
- Review registration information
- Discussion with person initiating referral, if applicable
- Review housing information on file, if applicable

What information is reviewed that may lead to the district initiating an investigation:

In addition to reports questioning residency, the district may initiate an investigation when:

- Mail is returned to the school
- House sale indicates a family is moving
- Phone numbers are not working (not solely the basis for an investigation)

Does the district automatically investigate student attendance based on a Certificate of Residency (C.O.R.)?

No, we do not automatically investigate. C.O.R.'s must be renewed annually and are legal documents. Information provided may lead to an investigation but it is not an automatic investigation.

Consideration for 2015/16 school year

The district currently has \$30,000 allotted for residency investigations. Following finalization of the 2015/16 budget, I would like to recommend the creation of a position titled School Security and Residency Officer which would be modeled after a similar position in Wethersfield Public Schools. This position could bring more consistency to the district's safety efforts by training and supervising the School Safety Monitors and conducting residency investigations. This person could conduct on-going safety audits throughout the school year. The position's work year and daily hours would need to be flexible to fit within the current budget allotment or other funds would need to be identified.

Subject: Budget Transfers

Background:

Board Policy 3160 requires budget transfers to be approved by the Board of Education. Financial reports are provided monthly to the BOE. As we move to close out FY 2015 there is a need for budget transfers. While the June 30th final report of school expenditures will not be submitted until the September Board meeting (Policy 3150), the key area of budget transfers for this fiscal year are indicated below.

Status:

The projections of expenditures for the close of Fiscal Year 2015 indicate that budget transfers are necessary; the largest amounts are for Special Education Out-of-District Tuition, Magnet School Tuition, Pupil Transportation, Substitutes and Tutor Salaries. Other budget transfers will be needed to cover supplies and purchased services.


The line items that will cover the above needs are Benefits, fuel and miscellaneous supply and material accounts from all department budgets.

It should be noted that these transfers are **within** the total approved appropriation from the Town of Windsor for the Fiscal Year. Total expenditures for the fiscal year will **not** exceed the budget appropriation of \$65,220,673.

Recommendation:

The BOE approve the projected line item transfers. In accordance with BOE Policy 3150, a final financial report including line item transfers will be presented at the regular Board of Education meeting in September 2015.

Background: The Windsor School Food Service participates in the National School Lunch Program at each of our school facilities and at St. Gabriel's, CREC's Metropolitan Learning Center and Museum Academy. We also participate in the National School Breakfast Program at our four elementary schools, Sage Park Middle School, Windsor High School and the two CREC schools. We operate the After School Snack Program for our Treehouse Program in Windsor as well as Museum Academy after care program. We operated our third year of the Summer feeding program serving breakfast to our summer school students at John F. Kennedy School and CREC Metropolitan Learning Center serving breakfast and snack. We operated a Summer Food Service Program of lunch and snack at Deerfield Apartment Complex and Goslee Pool during summer break. We are complying with the Healthy Food Certification again this year to send a consistent message to our students in keeping with our wellness policies.


Our annual goal is to operate with a small reserve account to offset unanticipated needs and to increase participation from students and staff in all our programs.

A monthly financial report is presented to the Board of Education. This report includes sales and financial information for the current period.



Amendments to the Town of Windsor, Connecticut Retirement Plan require approval of the Town Council and the Board of Education. The Attached agenda item summary includes the proposed amendments to the pension plan.

Status:

The Town Council will meet on June 15, 2015 to review and approve these amendments.

Recommendation: That the Board of Education approves the following motions:

“Resolved, that effective as of and retroactive to January 1, 2015, the required payroll deduction for eligible Public Safety Dispatchers Bargaining Unit employees shall increase from 4.0% to 4.25%.”

“Resolved that effective as of July 1, 2015, the required payroll deduction for eligible Public Safety Dispatchers Bargaining Unit Employees shall increase from 4.25% to 4.50%.”

“Resolved that effective July 1, 2015, the required payroll deduction for eligible unaffiliated Town of Windsor Employees shall increase from 4.25% to 4.50%.”

Subject: Amendment to the Town of Windsor Retirement Plan

Background

Efforts continue to be taken to mitigate costs associated with the town's defined benefit pension plan. Over the last several years, general government and Board of Education bargaining unit employee groups as well as unaffiliated employee groups have increased their contributions to the defined benefit plan. Additionally, all new eligible hires of both the Town and the Board of Education are participating in defined contribution plans. The defined benefit pension plan is closed to new hires of both the Town (except police) and the Board of Education.

Discussion/Analysis

Effective January 1, 2015, the Public Safety Dispatchers bargaining unit members increased their defined benefit contribution from 4.0% to 4.25% per the approved collective bargaining unit agreement. Effective July 1, 2015, the members of this bargaining unit as well as unaffiliated General Government employees will increase their defined benefit contribution from 4.25% to 4.5%. The Town Council and Board of Education are requested to adopt a resolution to amend the defined benefit pension plan as both bodies are defined as the "Employer" in the plan document.

Financial Impact

It is estimated that the increases as described above will result in approximately \$16,000 of savings to the town. These savings have been incorporated into the proposed FY 2016 operating budget.

Other Board Action

As stated in the pension plan legal document, the "Employer" is defined as the Town of Windsor and the Board of Education. Therefore, both the Town Council and the Board of Education need to adopt the appropriate resolution to implement the plan amendment. The Board of Education will consider the resolution at their meeting on June 17, 2015.

Recommendations

If the Town Council is in agreement, the following motion is recommended for approval:

"RESOLVED that Exhibit I, entitled, 'Seventh Amendment to the Town of Windsor, Connecticut Retirement Plan', is hereby adopted and approved and BE IT FURTHER RESOLVED that the Mayor and Town Manager are hereby authorized and directed to take any actions, and to execute such documents and instruments, as may be necessary or appropriate to carry out the intent of the foregoing resolution."
