### Superintendent's Comments Regarding Proposed Resolution No. 18-0302 March 8, 2018

We are all aware of the nation-wide walk out that will take place March 14, and which is planned by students as a response to the Florida tragedy and in support of safe schools.

March 14 is a non-school day for elementary students, but staff at our middle and high schools are prepared to ensure that students who choose to participate in the walkout, as well as those who do not, are supervised to maintain their safety.

I believe the intention behind Resolution #18-0302 is to shine a light on the rights our students are afforded under Board Policy JFI, *Student Demonstrations and Petitions.* Under that policy, students are permitted to hold demonstrations on school property under the following conditions:

- The demonstration must be scheduled with the building administrator in advance;
- a crowd control plan must be presented;
- The demonstration must not disrupt classroom activities;
- And the demonstration must not present a threat to student or staff safety, or be a hazard to school property.

Creating a positive school climate for all of our students is vital to teaching and learning, and I believe it's important that any board action facilitates this. During the discussion of your proposed resolution, I think it's important for you to consider the potential impact on students who do not wish to participate in a walkout.

As you know, we have students whose emotional health is fragile. Students could be concerned about the implications of not taking part in the walkout, and a myriad of other possibilities.

One of my roles as superintendent is to implement policy. That said, I also serve as the board's advisor regarding our students. I recommend that you examine the possibility that this resolution could have a negative impact on some of our students, which I know you don't intend.

**ACTION REQUESTED** 

### **Background**

The Board received preliminary information about this resolution at the March 1, 2018 meeting.

Gun violence in schools from elementary to post-secondary has become all too common in the United States. Neither Oregon nor 509J is immune.

This resolution is designed to express support for students of 509J who have chosen to express their right to lead for civic change.

There has been no indication that 509J administration would attempt to discourage the planned student action on gun violence, but school districts in other parts of the country have done so. For that reason also, it is worthwhile for the Board to make a formal statement of our support for students' planned actions.

This resolution is consistent with the Board goal that supports hands-on learning – in this instance, civic engagement – as one of the most powerful educational experiences that we can provide our students. Therefore, we deem any voluntary participation in the March 14, 2018, walkout to be part of the district's educational mission.

### Involvement

Participation in this student-led action is voluntary and not in support of any particular legislation.

### Resolution #18-0302 In Support of Student Action to Demand Safety from Gun Violence

### **RECITALS**<sup>1</sup>

- A. The Board of Directors of the Corvallis School District is committed to the success and safety of every student who attends our district's schools. Our goal is for every student to grow and ultimately to graduate, and it is the responsibility of our school district to give each student the opportunity and support to meet this goal.
- B. The Board believes that physical safety and emotional well-being are paramount to foster student success. Therefore, our schools must be safe places for all students, their families, and district staff.
- C. Despite all best efforts, the district's ability to ensure safe places has become increasingly fragile.
  - 1. On May 20, 1998, 4 died and 25 were injured in a shooting at Thurston High School, Springfield, OR.
  - 2. On April 20, 1999, 15 died and 24 were injured in a shooting at Columbine High School, Littleton, CO.
  - 3. On April 16, 2007, 32 died and 17 were injured in a shooting at Virginia Tech University, Blacksburg, VA.
  - 4. On February 14, 2008, 5 died and 17 were injured in a shooting at Northern Illinois University, DeKalb, IL.
  - 5. On February 27, 2012, 3 died and 3 were injured in a shooting at Chardon High School, Chardon, OH.
  - 6. On December 14, 2012, 27 died and 2 were injured in a shooting at Sandy Hook Elementary School in Newtown, CT.
  - 7. On June 10, 2014, 2 died and 1 was injured in a shooting at Reynolds High School, Troutdale, OR.
  - 8. On October 24, 2014, 4 died and 3 were injured in a shooting at Marysville Pilchuck High School, Marysville, WA.
  - 9. On October 1, 2015, 9 died and 9 were injured in a shooting at Umpqua Community College in Roseburg, OR.
  - 10. On December 7, 2017, 2 died in a shooting at Aztec High School, Aztec, NM.

- 11. On January 23, 2018, 2 died and 24 were injured in a shooting at Marshall County High School, Benton, KY.
- 12. On February 14, 2018, 17 died and 14 were injured in a shooting at Marjory Stoneman Douglas High School, Parkland, FL.
- 13. This is not a complete listing of the massacres that have occurred in our Nation's schools.

**THEREFORE, BE IT RESOLVED** that the Board of Directors of the Corvallis 509J School District hereby:

- Recognizes the right of students to take the lead in civic action and encourages them to address social issues that affect them.
- Endorses the student-led participation in the <u>#NationalSchoolWalkout</u> for 17 minutes at 10am across every time zone on March 14, 2018.
- Endorses March for Our Lives Corvallis on March 24, 2018, and encourages participation by the 509J community.
