K-12 Dual Language Immersion Update

NO ACTION REQUIRED

Background

The Corvallis School District Dual Language Immersion (DLI) program has been in existence since 2001. Currently, this program is one of thirteen K-12 dual language programs in the nation. In our district, the goals for DLI students are to become bilingual and biliterate, to reach grade level academic benchmarks and to develop cross cultural awareness and competencies.

In 2017, we sought out the consultation support of Rosa G. Molina, executive director of The Association of Two-Way Bilingual Education (ATDLE). The focus for this work has been the following:

- Realign our K-12 Dual Language program.
- Redefine our K-12 Dual language pathway and update the master plan.
- Offer technical support to school and program administrators and teachers, conduct program walkthroughs, provide professional trainings for administrators and teachers and provide programmatic support for central office staff in the area of dual language education.

Work to Date

In an effort to align and grow our DLI program work completed thus far has included technical support meetings with site and district DL administrators, and teacher trainings in the area of program design and implementation issues as well as administrative support. Kindergarten and first grade at both DL schools have modified their program into a 70/30 program structure.

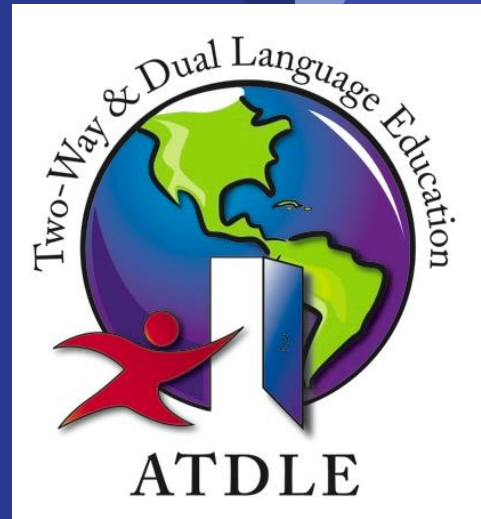
At the secondary level, a program analysis of class offerings was completed, scheduling and program design has been reviewed as well as classroom observations. Follow-up discussions have taken place with administrators and teachers.

Looking Ahead

The long term work and future planning for the K-12 DLI program includes a review of new curriculum for Spanish Language Arts and further refinement of the high school program offerings. An 8th grade placement test will be conducted to ensure correct placement for students in high school. Criteria for Seal of Biliteracy will be instituted at the elementary and middle school levels.

- Development of cross-cultural competencies and understanding

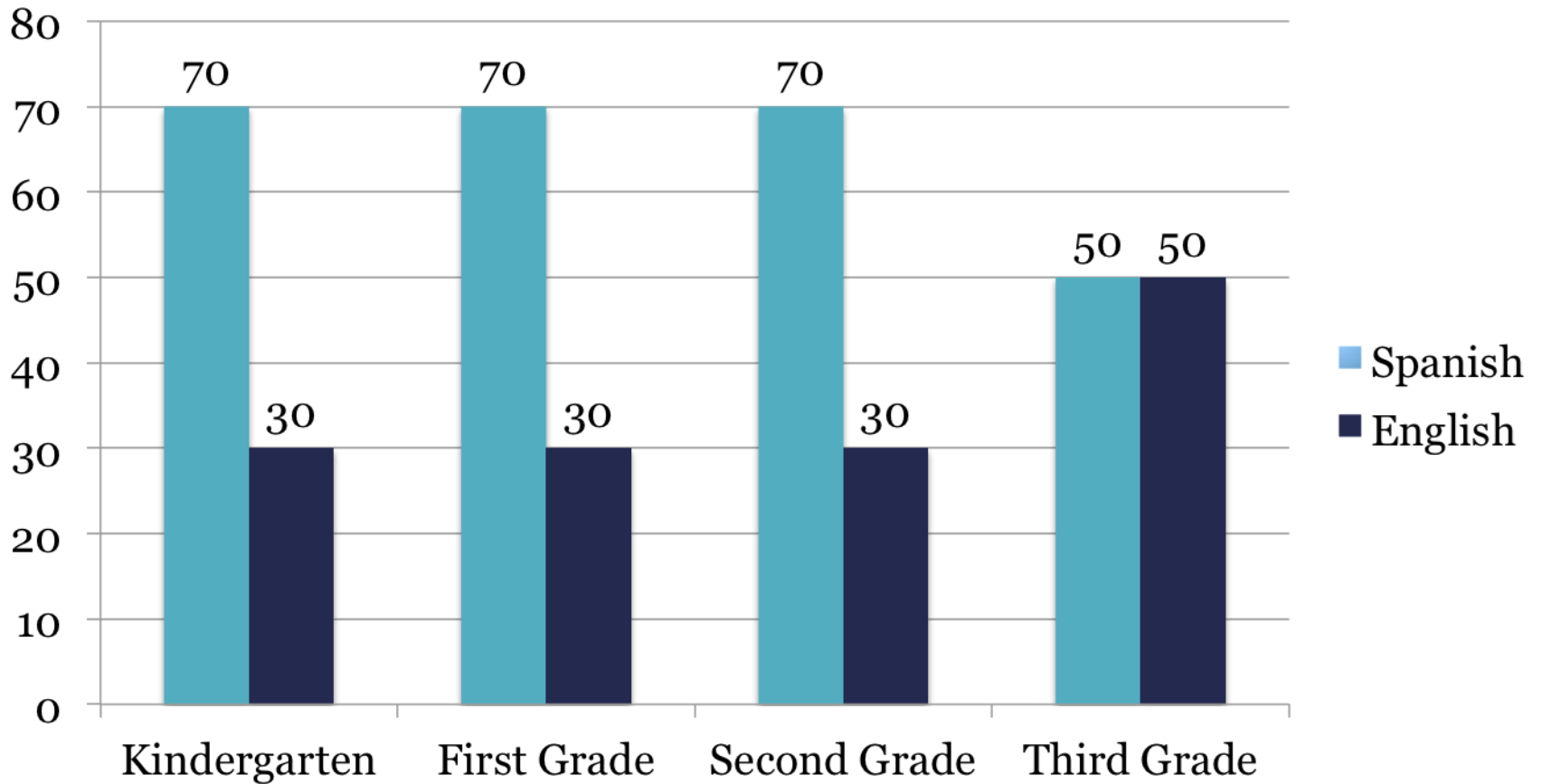

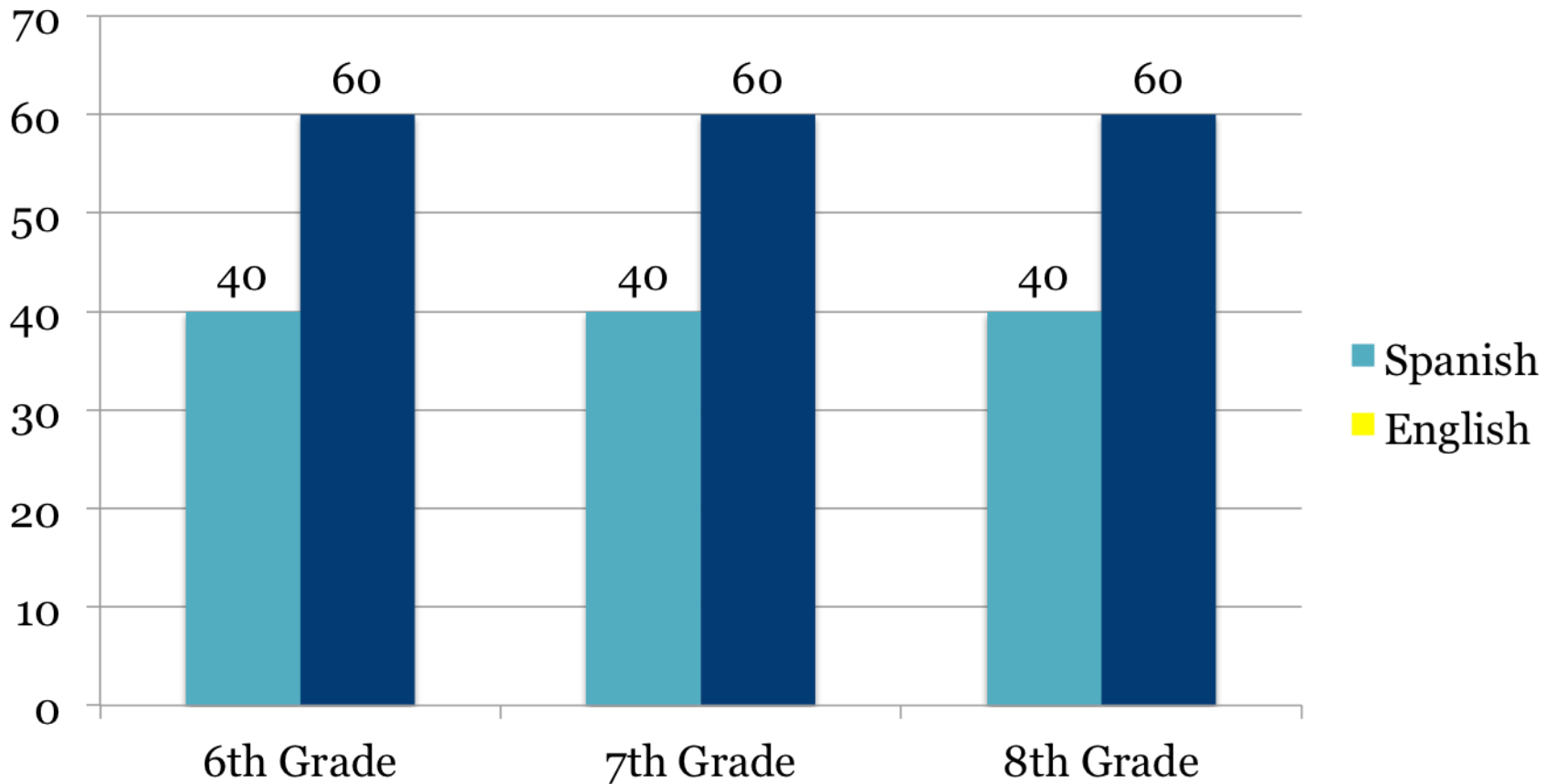
Current Status

- TWBI Program Model for the District defined
 - K-1 teachers are implementing a 70/30 program model to ensure that students are fundamentally sound in their L2 development
 - Teacher buy-in is very strong as students respond positively to their efforts
 - Building teachers' expertise to modify the new model
 - The Middle School program continues to work out its programmatic issues and strengthening the students' proficiency and interest in the target language
 - The High School program continues to collaborate on program design and future planning to increase proficiency in the target language.

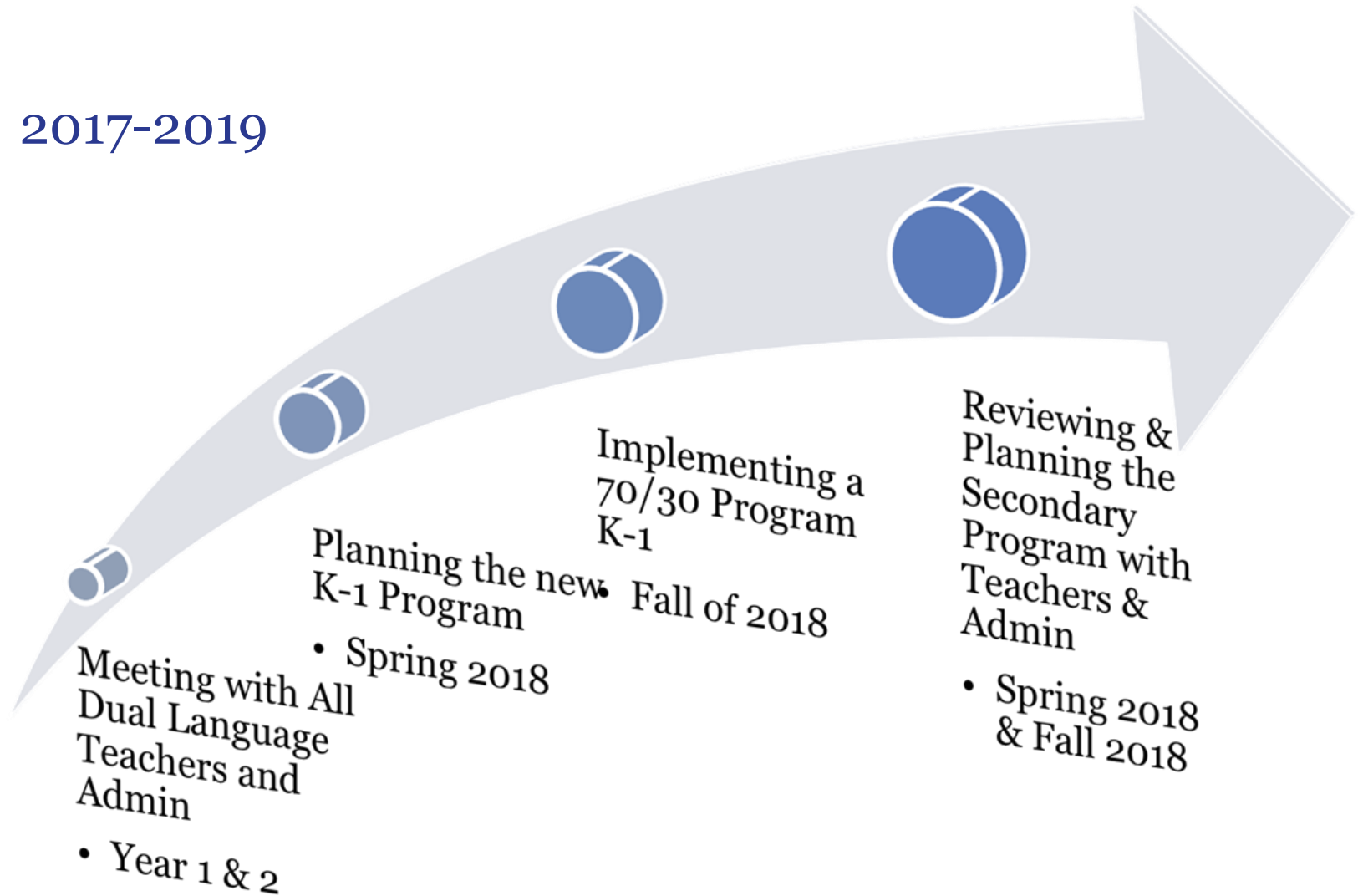

Issues Affecting Full Implementation

- Building a renewed commitment to the implementation of a strong Dual Language program K-12 that is research based and replicable through the grade levels
- Curriculum and Materials in the Target Language for teachers who are struggling to create grade level materials in the target language
- Linguistically balancing the classrooms as a result of a strong recruitment and family outreach plan at each school.
 - For example: 45 Els enrolled at other schools and relegated into English only instruction when they could be advantaged by participating in this Dual Language program at Lincoln and Garfield schools.

- Technical Support Meetings with site and district DLI administrators
- Teacher training in the area of program design and program implementation issues
- Administrative support as the new model is created and implemented
- K-1 modifies their program into a 70/30 program structure

- High School program visits and discussions held with admin & teachers

Looking Ahead...

- Engage teachers in curriculum adoption process for Spanish Language Arts freeing the teachers to plan their instruction vs design curriculum
- H.S. program offerings will be further defined for all incoming 9th graders
- DLI students enter the World Language program structure
- 8th Grade Placement Test to ensure correct placement of students in high school
- Seal of Biliteracy Program is instituted at the elementary, middle and high school levels.

Division 22 Standards

ACTION REQUESTED

Background

We are required by Oregon Administrative Rules (OAR) 581-022-1610 Operating Policies and Procedures to report to the board and the community the district's standing with respect to the Standards for Public Elementary and Secondary Schools as set out in OAR Chapter 581, Division 22. Districts are required to report to the board and community the status on all Division 22 OARs, and must submit the 2018-2019 Assurances form to the Oregon Department of Education by February 15, 2019.

For the 2019 Assurances, school districts are requested by ODE to report on the preceding school year (2017-2018).

1. In 2017-2018 the Corvallis School District complied with all Division 22 OARs except the following:

OAR 581-022-2045 Prevention Education Programs in Drugs and Alcohol

This standard requires the development of a comprehensive plan for alcohol and drug abuse. At this time, we have embedded drug and alcohol instruction into our K-12 health curriculum; however, a section of this rule requires that annual instruction of drug and alcohol prevention for all high school students, grades 9-12. Last year each high school student received instruction during two scheduled health courses. The district is currently working on a plan to move drug and alcohol prevention curriculum to advisory time, which occurs for all students.

2. The Corvallis School District complies with the following Division 22 OARs, but felt additional information is necessary for the board and community:

OAR 581-022-2320 Required Instructional Time

In 2015, legislation was passed requiring 92% of students in the district and at least 80% of all students at each school operated by the district to be scheduled to receive annually minimum hours of instructional time:

Grade 12	966 Hours
Grades 9-11	990 Hours
Grades K-8	900 Hours

Full compliance of this standard is phased in over four years, beginning in 2015-16. In the 2017-2018 school year, at least 90% of all students are required to be scheduled to receive the minimum hours of instructional time.

In 2017-18, 91.2% of students in the Corvallis School District are scheduled to receive the minimum number of hours of instructional time.

- At the elementary level and at Franklin K-8 School, 100% of all students were scheduled to receive 900 instructional hours.
- At Cheldelin and Linus Pauling Middle Schools, 95.6-99.5% of all students were scheduled to receive 900 instructional hours.
- At Corvallis and Crescent Valley High Schools, 58.2-77.8% of all students were scheduled to receive 966-990 instructional hours.

Students at the high school level need 24 credits to graduate. Those students who do not fail a course are on track to earn 28 credits if enrolled in seven periods; therefore, students in grades 10-12 often take less than seven credits and are not scheduled to receive the required instructional hours.

In 2018-2019 the district implemented an eight-period day at the high school level. All 9th grade students meet the required 990 instructional hour requirement and are assigned eight periods each semester. Students in grades 10-12 meet the required 990 instructional hours by being assigned to a study hall period or office/classroom assistant. Every student is provided the opportunity to take a full class load and is required to do so if they are not on track to graduate. The schools utilize this unscheduled student time to offer small content support classes, resulting in continued improvement in district-wide graduation numbers.

We are currently reviewing enrollment and on-track data to evaluate the benefits of this scheduling approach.

OAR 581-022-1640 Instructional Materials Adoption

This standard requires each program and course in grades K-12, on a cycle established by the State Board of Education, to select and provide students with free appropriate instructional and resource materials produced in accordance with the National Instructional Materials Accessibility Standard (NIMAS). In January 2016, the State Board of Education revised the Oregon State Review.

Our plan for 2018-19:

1. We will be adopting/readopting Social Studies Curriculum K-12

Future State Board of Education Instructional Resource Cycle:

2019: World Languages & The Arts (In classes by Fall 2020)

2020: English Language Arts (In classes by Fall 2021)

2021: ELL/ELP (In classes by Fall 2022)

2022: Mathematics (In classes by Fall 2023)

Authorize the district to include up to 30 hours of professional development time, up to 30 hours for parent teacher conferences, and up to 60 hours of recess for students in grades kindergarten through grade 3 for calculation of instructional hours.

Dear Board Members -

I see the 1/17 meeting agenda includes the annual [report and action on the Division 22 Standards](#). I would like to provide some observations, comments and questions.

As I read through the cover memo, I was surprised to see the district still did not meet OAR 581-022-2045 Prevention Education Programs in Drugs and Alcohol in 2017-18. I was even more surprised to see that the explanatory language in the 2019 report is virtually unchanged from the 2017 and 2018 reports on the same subject. And the January 2016 report says, "the district will develop a comprehensive plan in 2016 that includes the items outlined required in this OAR and will presented to the board by June 1, 2016." (Copies of the cover letters for these four reports are attached.)

I believe three years would be sufficient time for CSD to meet this standard, but am open to opposing views. Can you tell me the status of "a plan to move drug and alcohol prevention curriculum to advisory time . . ." ? Hopefully your discussion tomorrow night will address this.

While I understand the [OAR](#) allows for it, I am interested in knowing the rationale from a student achievement perspective for counting parent teacher conference time and professional development time as instructional hours. Is this a common practice in Oregon public schools? A function of finances?

Hopefully the board will receive a report on the eight-period day and how "The schools utilize this unscheduled student time to offer small content support classes, resulting in continued improvement in district-wide graduation numbers." I believe broad student input to this report is essential.

Unfortunately I will once again be out of town when you meet tomorrow and unable to present my comments in person. Maybe one of the board members could introduce them on my behalf and have them added to the meeting record?
