The purpose of the meeting is for Mr. John Eder to provide the Board with a summary of the recently conducted audit. Similar to last year, the audit was completed a bit earlier than usual, so the documents are ready for the September board meeting this year. The audit report will be delivered to you in advance of the meeting on Monday.

Due to specific auditing standards, the audit report contains some noted deficiencies which are considered "material weaknesses;" however, based on discussion with the auditor, these standards are not necessarily practical for school districts. The overall report indicates that we remain in relatively good financial health at this time. Material adjustments were required, and most notably, there were checks cut at the end of June which did not clear in a sufficient time to be considered expenditures for FY12. Therefore, these expenditures needed to be adjusted and will be applied to FY13. The district office will work to fine tune processes in place to help identify potential adjustments throughout the year to help reduce potential adjustments by the auditor. Other than these adjustments, the district had a very clean audit with no major recommendations for change.

No formal action is expected at the special meeting; however the board will be asked to approve the audit report at the regular meeting on September 24.

The tabulated schedule of fixed assets includes data elements describing each asset type and class, location, quantity, Cost of Reproduction New, estimated or actual year of acquisition and acquisition cost, asset life, depreciation calculations and special coding accommodations.

This appraisal includes property classifications of land, site improvements, buildings, furnishings and equipment in varying sub-asset classes.

The valuation determinations reflected in this report are defined as follows:

Cost of Reproduction New is defined as the cost of reproducing a new replica of a property on the basis of current prices with the same or closely similar materials, as of a specific date, at current market prices for labor, cost of freight and installation, contractor's overhead and profit, but without provision for overtime, bonuses and premiums of any kind. The Replacement Insurable Value reflects the adjustment of Reproduction Cost New for those items that are normally excluded by the fire insurance policy. These "Exclusions" comprise the following items: excavation and filling; portions of foundations which are below the under-surface of the lowest floor or are below the surface of the ground; and underground sewage, piping and wiring.

Sound Value is defined as the Cost of Reproduction New less accrued depreciation resulting from observed conditions involving age, utility and remaining serviceable life. Sound Value is often referred to as Actual Cash Value within the insurance industry. Sound Value is reflected in this report in the summary of values only.

Acquisition Cost as reflected in this report is intended to be the original cost of the asset as of the date of the construction or installation. For the purpose of this report the date of acquisition and acquisition cost have either been furnished to the appraiser as representing actual dates of acquisition and costs or have been estimated by the use of computerized reverse-trending techniques applied against the estimate of current reproduction cost.

The costing of land has been based on actual cost data furnished to us. Although capitalized, land costs have not been depreciated. Site improvement costs, both insurable (signs, lighting, fencing, etc.) and uninsurable (roadways, parking lots, sidewalks, etc.) have been developed by appraisal or reflected at actual cost. Site improvements have been capitalized and depreciated as exhaustible assets.

The valuation methodology utilized in this report for building assets involved the cost calculator pricing method in the calculation of the Cost of Reproduction New based upon proprietary indices available to and developed by the Industrial Appraisal Company. In estimating these replacement valuations, additional costs which could be associated with conforming to local building codes, municipal ordinances, federal standards, or other legal restrictions were not considered, nor was any value assigned to the cost of demolition or the removal of destroyed property should a loss occur.

The building account classification comprises general construction, plumbing, sewage, heating, ventilating, air conditioning, electrical lighting, sprinkler and fire alarm systems, and building permanent fixtures which are incorporated into the overall building valuation and cost estimating calculations. These fixtures may include wall lockers, chalkboards, clock system, public address system, carpeting, cabinetry, window blinds, etc.

The valuation of furniture and equipment involves unit pricing based on documentation or quotations available from suppliers and manufacturers at retail cost new, plus freight and installation; installation is considered to be mechanically complete. In many instances, replacement value is established for generic items "at average" for the property type based on the appraiser's assessment of observed quality.

Applicable to this appraisal, individual items of equipment with a Replacement Insurable Value exceeding \$1,000.00 have been specifically identified and recorded in the report. Items less than \$1,000.00 at Replacement Insurable Value and minor items may be group classified and valued by category totals for insurance purposes only. For identification purposes, all assets have been consecutively numbered in the Item I.D. Number field of the report.

The costing and depreciation analysis applies to assets exceeding the \$5,000.00 Unit Acquisition Cost threshold. Depreciation has been calculated as of June 30, 2012 on a straight line current basis, utilizing the half-year convention with no consideration given to salvage value. **All changes, additions and/or deletions relative to the 2013 report should be recorded from the date of this appraisal, June 20, 2012, through and including June 30, 2013.**

Certain property assets have been included in this appraisal and may not have been physically inspected but are recorded in the report based on furnished listings assumed to be current and reliable. In certain instances valuation provisions have been included for general property classifications based on furnished "count" estimates, student enrollment and averages appropriate for the level of instruction. Such items include related student consumable supplies, textbooks, library books, maintenance supplies and the like. Musical instruments, athletic uniforms and AV software have been included at owner's list and value. Licensed vehicles were not appraised but have been recorded at acquisition costs provided by the district.

This appraisal does not include non-exhaustible infrastructure outside of buildings, landscaping, additional value due to historical relevance, foodstuffs, valuable papers, artwork, trophies, stage sets and props, intangible assets, and properties of third parties.

For descriptions that exceed this length, please refer to the printed hard copy of your report.**

Based upon the foregoing investigation, analysis and methodology employed, it is our opinion that the aggregate values for all assets under appraisal are as follows:

If the basis of fire coverage is Reproduction Cost, the figures shown in Column 3 of the Summary report reflect the Cost of Reproduction New less exclusions. If the property coverage is based upon Sound Value (Actual Cash Value), the values shown in Column 6 represent the depreciated value less exclusions. Should the Exclusion Clause be deleted from the policy by endorsement, the values reflected in Column 1 and Column 4 apply. We suggest that the values be reviewed with your insurance agent or broker promptly upon receipt of this appraisal.

The Summary of Values report lists several data elements unique to each building structure. Most of these elements are self-explanatory, such as construction year, square footage, stories and occupancy. ELIGIBILITY

The ineligibility period starts on the Monday and remains in effect until the athlete has accumulated less than four points on a future eligibility weekly check.

Proposed Changes to Eligibility Policy (Changes in Bold Print)

ELIGIBILITY

Ineligible athletes will not be allowed to participate in any contest during the week of ineligibility. (Monday through Sunday) and will be prohibited from wearing the team uniform during that time. Athletes are permitted to practice and attend contests during the time of ineligibility. The ineligibility period starts on the Monday and remains in effect until the athlete has accumulated less than four points on a future eligibility weekly check.

SEMESTER ELIGIBILITY

Semester eligibility is based on a pass system. In this system, the student-athlete must pass 6 classes in order to be eligible for athletics in the following semester. If a student-athlete is deemed ineligible, they will not be allowed to be on or part of any athletic program until their eligibility is re-established at the end of the next semester by passing six classes.

Rationale for Changes

Changing Report Date from Thursday to Wednesday

By running the grade report earlier in the week, (Wednesday instead of Thursday) the Athletic Office will have more time to communicate with coaches and players regarding their athletic status for the next week.

Changing Semester Requirements

Central High School previously used the Illinois High School Association requirements (By-law 3.020) for semester eligibility which required each student to pass 20 credit hours (4 classes) per semester. The IHSA has changed their eligibility policy to the following;

Illinois High School Association By-law 3.020 –Scholastic Standing

Requires students to be doing passing work in 25 credit hours (5 classes) of high school work per week. (By-law 3.021)

Requires students, except for incoming freshmen, to have received credit for passing work in 25 credit hours (5 classes) of high school work during the previous semester. (By-law 3.022)

Conclusion

Central's new policy will require student-athletes to pass 6 classes per semester as compared to 5 classes per semester required by the IHSA. Therefore, Central High Schools eligibility policy will be more stringent than the Illinois High School Association By-law 3.020, for both weekly and semester eligibility checks.
