In accordance with requirements from the State Board of Education, I am requesting Board action on the following:

“If a school district offers an Advanced Placement computer science course to high school students, then the school board must designate that course as equivalent to a high school mathematics course and must denote on the student’s transcript that the Advanced Placement computer science course qualifies as a mathematics-based, quantitative course for students.”

Course (1115: AP Computer Science A) is currently offered through the CTE department and we are recommending that it be moved to be offered under the mathematics department as well. Currently the prerequisite for this course is the recommendation for completion of Algebra 2 and Introduction to Computer Programming. This recommendation will not change. Upon approval, we will be publishing this course in the 2016-2017 Central High School Curriculum Guide under both CTE and Mathematics, however, it will state that this course will be given mathematics credit.

Re: Request for Approval of Planning and Conduction of the 2017 GAPP Exchange Cycle which involves a Trip to Germany

1) What does GAPP stand for?

GAPP stands for *German American Partnership Program*.



2) And what is GAPP?

GAPP is a school-to-school exchange program that pairs an American school with a German school to give students from both countries the opportunity to visit each other's schools and to experience each other's cultures by sharing in the lives of their families and communities.

3) Who endorses GAPP?

The GAP-Program is endorsed both by the German government (Foreign Office) and by the U.S. Department of State.

4) What happens during a GAPP exchange?

There are two parts to a GAPP-exchange: Trip and Hosting. For us in 2017, this would mean that would mean a trip to Germany in the summer of 2017 with CHS students going to Germany for 21 days. The second part is German students coming to CHS in return in the fall of 2017, being hosted by the CHS students who previously enjoyed the hospitality of the German students. Besides staying for two weeks with the partner school, there is also a shorter travel portion of about 4 days that is only done by the visiting school. For the 2017 exchange, Frau Bliss is looking into the possibility of traveling with the students to Bavaria.

5) Have we done this before?

Over the past 16 years, the German department of CHS has participated at least eight times in a GAPP exchange between *Central High School* and the *Ferdinand-Sauerbruch-Gymnasium*. This exchange has now been in place for about 20 years. It was started by Kate Tamms.

6) Where in Germany is our partner school located?

Our partner school is the *Ferdinand-Sauerbruch-Gymnasium in Großröhrsdorf* (near the city of Dresden in the East German state of Saxony. (See map on page 4)

7) What will be the tentative travel dates for the 2017 GAPP exchange?

The tentative travel dates for our group would be June 10 – June 30, 2015. This would require our group to leave slightly before all of the emergency days are used. (Instead of 5 emergency days for students, we would have only four. We cannot really leave any later due to

the start of the summer break at our partner school in Saxony. Part of the GAPP requirement is to spend at least 2 weeks at the partner school.)

8) What is planned for the Germany trip in 2017?

- Flight from Chicago to Dresden (via Munich or Frankfurt am Main)
- 15 days with host families, attending school at the *Ferdinand-Sauerbruch Gymnasium*
- During the family stay portion in Großröhrsdorf, CHS students would attend classes. However, our partner school will also plan a program that encompasses traveling to nearby cities (*Dresden, Bautzen*), sites like a fortress, and hiking in “*Saxony Switzerland*”,
- 4 days of CHS group travel in Bavaria, with possibilities of seeing sites in Munich, Nuremberg, Salzburg, or one of the castles of King Ludwig II. The train would be the main means of transportation.
- Return flight from Munich.
- If we find Bavaria too expensive for the travel portion, we could alternatively do the trip portion in the Rhine area with departure from Frankfurt. This has been done multiple times in the past.

9) How can students benefit from participating in the exchange program?

- Students can form long lasting international friendships that may involve entire families and might go well beyond their years at high school
- Students can dramatically increase their ability to hear and speak German
- A lot of students have seen an increase in personal confidence and maturity after mastering this experience and consider such a trip an “eye-opening-experience”.
- Through an experience like this, students learn to live our former mission of becoming “*responsible contributors to our ever changing global society*” and our current mission of “*changing the world*”.

10) How can the entire district benefit from the experience?

Students participating directly in the exchange are not the only ones benefitting from the exchange. As part of the GAP-requirement, the German students have prepared presentations (in English) on Germany related topics that can be given in any class where it is requested by a teacher. In the past, the German guests have even visited other schools in the district and met with classes of the middle and elementary schools that they were invited to. The benefits of the program therefore can expand to the entire district. Also, our students are very popular guests in English classes in Germany where they will have to report on life in the USA.

11) Who is Central's sponsor for the GAPP program and who else will chaperone the trip?

Central's designated sponsor of the GAPP exchange is Mrs. Anette Bliss (CHS German Teacher and Foreign Language Department Chair). Mrs. Bliss (a native of Germany with dual

citizenship) traveled with CHS students to Germany in 2004; 2006; 2011; 2013; and 2015. The second chaperone is as of yet not fully determined. If Central's second German teacher is not available, Mrs. Cathy Mullahy (currently CHS Teacher and Department Chair for Career/Tech Education) agreed to step in. Mrs. Mullahy traveled with students to Germany in 2006, 2011 and 2013 and has been to the country several times on her own due to family ties.

12) Who else is involved in the planning of the trip?

Frau Bliss usually works together with ISE (International Student Experiences) to work on the details of the trip involving monetary aspects (plane tickets; train tickets; hotel reservations, etc.). ISE is a Minnesota based non-profit organization that is specialized in student travel.

13) What are the costs of the trip for the students?

The final costs of the trip are still being negotiated. The costs for the 2015 trip were \$ 3,450 per student. The cost of the trip depend on the group size and the itinerary. Past experience has shown that each year the trips are more expensive.

14) What else is relevant for the Board to be aware of?

Besides approval for the described exchange and trip, Frau Bliss seeks permission that the return flight is conducted with a single chaperone. Rationale: A late departure would allow Frau Bliss the possibility to spend time with her family in Germany. This has been past practice in all of the prior exchanges. The group has always returned with the second chaperone only.

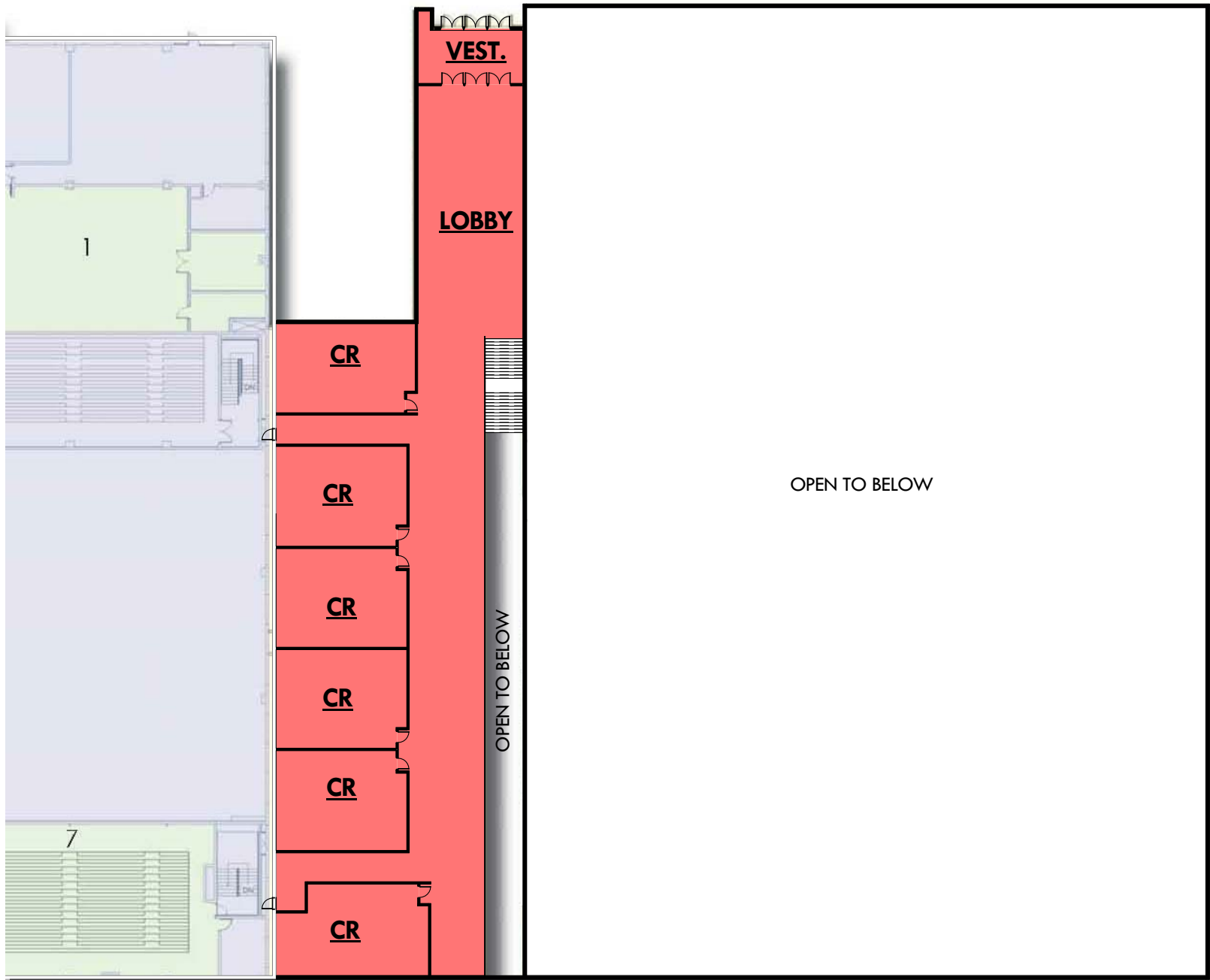

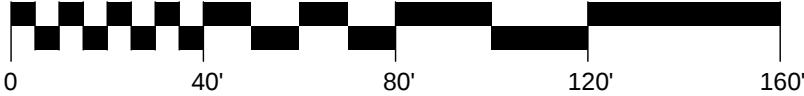


SECOND FLOOR PLAN - 160 M TRACK OPTION

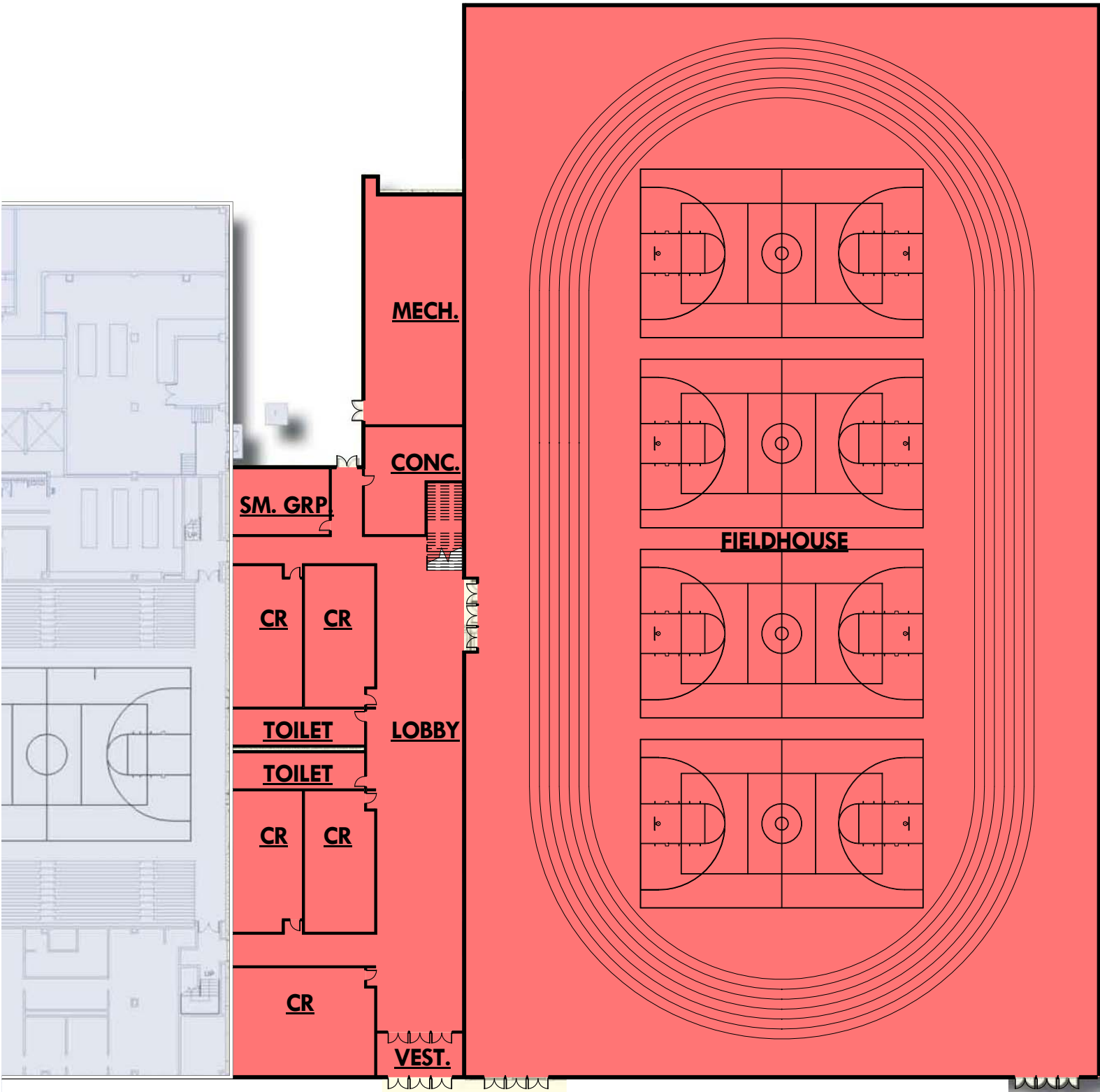

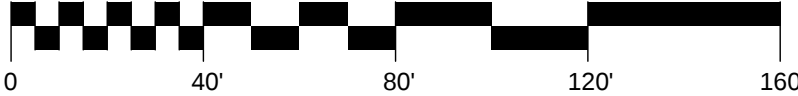

FIRST FLOOR PLAN - 200 M TRACK OPTION



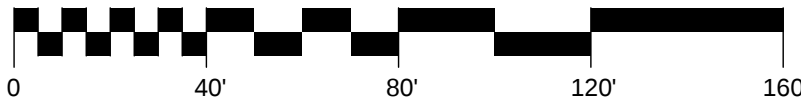

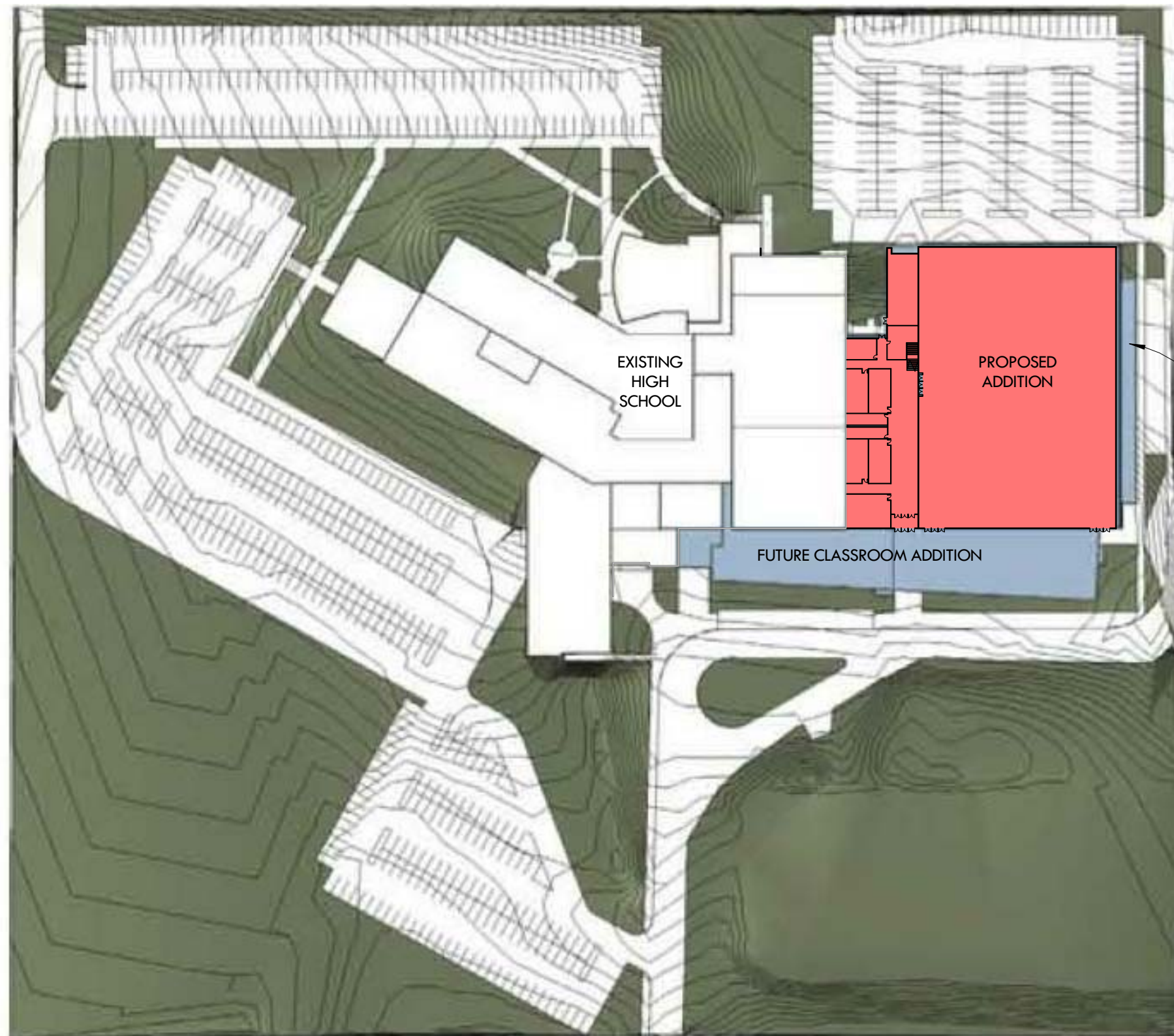

PROPOSED HIGH SCHOOL ADDITION

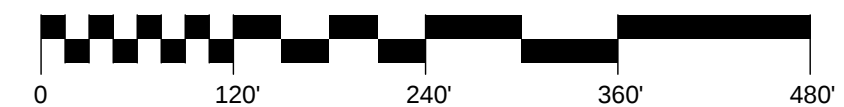


SITE PLAN - 160 M TRACK OPTION

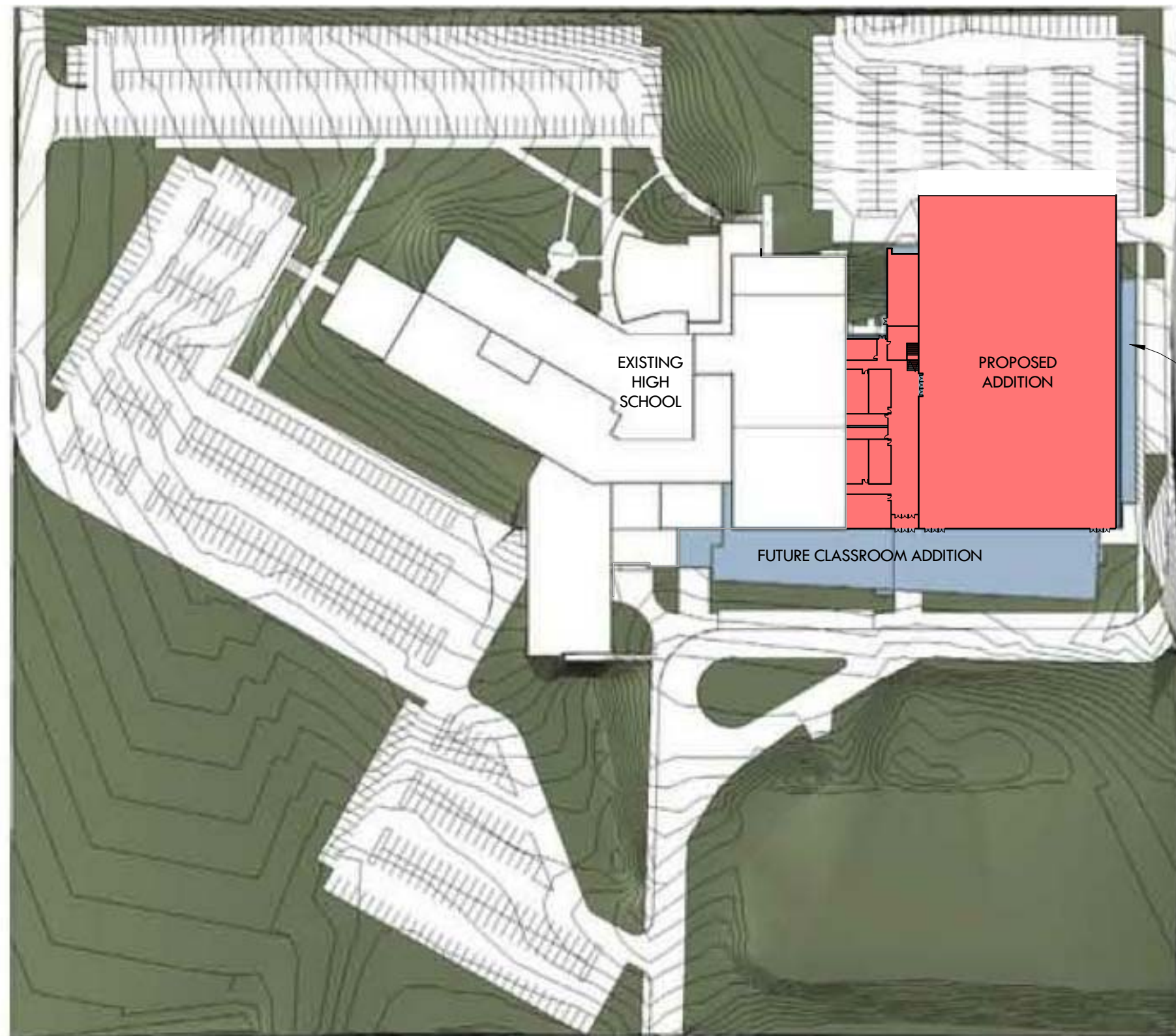

ATI Holdings, LLC dba ATI Physical Therapy, (hereinafter referred to as "Contractor").
WITNESSETH:

WHEREAS, the School, desires to have certain athletic training services, pre-game taping, game training supervision and medical assistance services performed in connection with athletic programs;

WHEREAS, Contractor has agreed to perform such services on behalf of School under terms and conditions as set forth in this Agreement.

NOW, THEREFORE, the parties, intending to be legally bound, and in consideration of the mutual covenants and agreements herein contained, do hereby agree as follows:

1. Description of Services. Contractor agrees to furnish all labor services as set forth more fully in Schedule A entitled "Services" hereby referenced and incorporated herein and to attend those events set forth in a Schedule B entitled "Compensation and Attendance Schedule" hereby referenced and incorporated herein.
2. Home Games. The parties understand and agree that it is the primary responsibility of Contractor to attend athletic events throughout the school year as determined by the athletic director. In the event there are two home athletic events scheduled at the same time, the Athletic Directors for School will dictate whether Contractor shall divide his/her time between the athletic events or whether the Contractor shall only attend one of the events.
3. Site of Services and School Support of Programs. The School shall provide appropriate space for the conduct of any sports medicine program including, but not limited to, appropriate equipment for the development of preventative programs and an appropriate level of sports medicine supplies for the use of its students. The School shall be solely responsible for determining the times of practice and for scheduling all athletic events. The School shall facilitate communications and schedule changes between School, coaches and Contractor. The School shall submit to the Contractor within fourteen (14) calendar days all school holiday practice/game schedules. The School agrees to provide appropriate support for the development of a sports medicine program and the Services to be provided in connection with its sports medicine program and athletic practices and events and shall designate an individual(s) (athletic director(s)) to directly monitor and evaluate compliance of the Contractor. The School shall be responsible providing access to all emergency phone locations.
4. Compensation. School will pay to Contractor, for the contemplated performance of Services hereunder, sums as set forth fully in the attached Schedule B "Compensation and Attendance Schedule" incorporated herein.
5. Term. This agreement shall be in full force and effect from August 11th, 2014 through and including June 11th, 2017 unless terminated earlier by either party upon at least (30) calendar days prior written notice to the other party of its intention to terminate.
6. Exclusivity. School agrees that it has not authorized and during the Term of this Agreement, will



not authorize or permit, the endorsement or promotion of any services or products directly or indirectly competitive with ATI Physical Therapy services.

7. Independent Contractor. It is hereby understood and agreed that Contractor, in performing this Agreement, is acting in the capacity of an independent contractor, and that Contractor is not an agent, servant, partner, nor employee of School. Contractor will have control over the work to be performed, and shall be solely responsible to pay its own federal and local taxes, salary, social security payments, and any and all other payments incurred by Contractor in the performance of this Agreement, as well as perform all necessary legal requirements pertaining to employment. None of the benefits provided by School to its employees, including but not limited to workers' compensation insurance, disability insurance, medical insurance, and employment insurance are available from School to Contractor and/or any and all of Contractor's agents, servants, and employees. Contractor has no authority hereunder to assume or create any obligation or responsibility, express or implied, on behalf or in the name of School or to bind School in any way whatsoever.
8. Insurance. Contractor shall be responsible for providing general liability, professional liability insurance, and workers' compensation insurance for its athletic trainers and its Services. The limits of liability for ATI Physical Therapy's general liability and professional liability insurance policies shall be no less than \$1,000,000.00 per occurrence, \$3,000,000.00 per annual aggregate and workers' compensation coverage in accordance with applicable federal and State statutory requirements. The School shall be responsible for providing general liability insurance including, premises liability insurance, and professional liability insurance for the activities of its employees. The parties shall provide evidence to each other's satisfaction that such insurance is in force. The parties shall maintain such insurance coverage during the term of this Agreement. Appropriate certificates evidencing such insurance shall be provided upon request.
9. Indemnification. "Each party (in such case, an "Indemnifying Party") agrees to indemnify and hold harmless the other party (in such case, an "Indemnified Party") and the Indemnified Party's directors, members, managers, officers, employees, subcontractors, agents, representatives, volunteers, successors and assigns from any and all claims, demands, causes of action, losses and damages arising out of or relating to any alleged acts or omissions of the Indemnifying Party in undertaking the Indemnifying Party's duties under this Agreement.
10. Force Majeure. Neither party shall be liable for any delay, failure or inability to perform its obligations (except the obligation to make payments) under this Agreement due to any cause beyond its reasonable control including, but not limited to, Acts of God, civil disturbances, accidents, equipment breakdowns, utility failures, and unavailability of personnel due to disability, leaves or other reasons.
11. Notices. All notices under this Agreement shall be made in writing and shall be deemed to have been given if personally delivered or transmitted by facsimile during regular business hours, or mailed by certified mail, postage pre-paid, return receipt requested, to the other party at its last known address, and, if sent to ATI Physical Therapy, addressed to the attention of the Sports Medicine Director.
12. Assignment. ATI Physical Therapy shall have the right to subcontract any of the Services to qualified and duly certified personnel and ATI Physical Therapy shall remain solely liable for the oversight and performance of such personnel.
13. Non-Solicitation. School agrees that during the Term and for a period of twelve (12) months after termination of the Agreement, School shall not without prior written approval of Contractor directly or indirectly, take any action that constitutes, results or may reasonably be expected to result in soliciting, inducing or encouraging any Contractor employee (presently or affiliated with Contractor in the then most recent twelve (12) month period) to curtail or terminate such person's affiliation or employment, or taking any action that results in, or might reasonably be expected to result in any employee ceasing to perform services for Contractor.



Nothing herein shall limit School's rights to post opportunities in publications or on-line websites of general or trade circulation, or to engage, hire or recruit any person who responds to such a posting.

14. Severability. In the event that any provision of this Agreement, or application of such provision to persons or circumstances is held to be invalid, illegal, or unenforceable pursuant to judicial decree or decision, the remainder of this Agreement or the application of such provisions to persons or circumstances other than those to which it is held invalid, will not be affected thereby, and shall be construed as if such invalid provisions had never been contained herein and shall remain valid and enforceable according to its terms.
15. Entire Agreement. This Agreement supersedes and replaces all prior agreements between the parties with respect to the Agreement's subject matter. This Agreement may not be amended or rescinded except by the mutual written consent of authorized representatives of the parties. This Agreement shall be governed by state law in the state in which services are rendered, without regard to rules of conflicts of law. The parties irrevocably waive their rights to a jury trial.

Schedule A

Services

ATI Physical Therapy, with the approval of the School, shall designate an individual to provide the physical therapy services described in this Agreement while serving as a head athletic trainer to the School ("Services"). The Services shall consist of:

- (a) Assistance in the coordination of the sports medicine program at the School.
- (b) Advising the School on supplies and training equipment needed for the sports medicine program.
- (c) Assisting the School faculty and athletic coaching staff in the design and implementation of a student sports medicine program.
- (d) Assisting the School faculty and athletic coaching staff in the design and implementation of a continuing education program for the School's athletic coaching staff.
- (e) Providing conditioning and flexibility training suggestions to the School coaching staff under the direction of a licensed physician to be provided through the School.
- (f) Assistance in monitoring athletic injuries and assistance in developing an injury prevention training program under the direction of a licensed physician to be provided through the School.
- (g) Coordinating and providing injury follow-up and evaluation to assist the treating physicians of students.
- (h) Attendance at the School's practices, games and other functions as set forth on the attached Schedule B, unless the School has scheduled two or more events at the same time. In such instance, ATI Physical Therapy's athletic trainer, in conjunction with the School's athletic director, shall determine which athletic events are to be covered. The parties acknowledge that from time Schedule A may be modified by mutual written consent of parties as needed.



Compensation and Attendance Schedule

Contractor will provide Certified Athletic Trainer coverage for the school terms of August 11th, 2014 through and including June 11th, 2017. School will be given one athletic trainer for approximately 40 hours per week throughout the school year. All of the expenses of ATI Physical Therapy's athletic trainer are included at no additional charge, except when the School requests the athletic trainer to participate in an out-of-town athletic event requiring travel or overnight lodging. In such instances, the School shall pay the direct costs of such additional expenses as they are incurred by or on behalf of the athletic trainer. In the event that the School desires ATI Physical Therapy's athletic trainer to cover other School sporting events (those not indicated on Schedule B), ATI Physical Therapy and the School will attempt to mutually agree on the coverage of the event and the additional fee for such coverage. ATI Physical Therapy's athletic trainer will only cover state sanctioned events. If affiliate is not a member of a state association, ATI Physical Therapy's athletic trainer will only cover school sanctioned events of practices. All events or practices covered are to be mutually agreed upon by the athletic trainer and the athletic director.

Upon School agreement:

School will provide ATI Physical Therapy with an opportunity to display signage and banners at each of the athletic events in prominent locations and allow ATI Physical Therapy to place information regarding ATI Physical Therapy services and various programs in the School and at the site of the athletic events. Allow ATI Physical Therapy to display the School name and logo and that it is the "Preferred Sports Medicine Affiliate" for the School on ATI Physical Therapy marketing and advertising materials including, but not limited to, the website used by ATI Physical Therapy in its business, marketing brochures, posters and other marketing collateral. Placement of ATI logo and text link on the School's official website with an announcement that ATI Physical Therapy is the "Official Sports Medicine Providers" for the organization. School will comply with a minimum of one (1) PA announcement (script written by ATI Physical Therapy) during all Home games (with announcer present), and pre-game announcement stating Sports Medicine services are provided by ATI Physical Therapy.

Fall:

Coverage for all levels at all home contests for the following sports:

Boys Football, Boys/Girls Cross Country, Boys Soccer, Girls Volleyball, Girls Swimming and Diving and any IHSA tournament hosted by School.

Winter:

Coverage will be given until 6:30p.m., or until the last home contest ends. Coverage for all levels at all home contests for the following sports:

Boys/Girls Basketball, Boys wrestling, Girls gymnastics, Boys Swimming and Diving, and any IHSA tournament hosted by School.

Spring:

Coverage will be given until 6:30 p.m., or until the last home contest ends. Coverage for all levels at all home contests for the following sports:

Boys Baseball, Girls Softball, Boys/Girls Track and Field, Girls Soccer, Boys Volleyball, Girls Badminton, Boys/Girls Water Polo, and any IHSA tournament hosted by School.

Summer:

Coverage during the month of June and July will be determined based upon mutual agreement between school and contractor.

HIGH SCHOOL OUT-REACH PROGRAM

Agreement made this 22nd of June, 2012 by and between ATI Holdings, LLC dba ATI Physical Therapy and Burlington High School.

- I. ATI Physical Therapy agrees to provide Burlington High School with the following:
 - A. A Nationally Certified Athletic Trainer, Illinois State Licensed, who shall provide the following services:
 - 1. Provide coverage of home athletic events. This will include games and practices at all levels as deemed necessary by the Athletic Director.
 - 2. Evaluation and treatment of athletic injuries as deemed necessary.
 - 3. Establish a record system of injuries and pertinent medical information.
 - 4. Assist in organizing a Training Room Facility.
 - 5. Conduct a Student Trainer Program wherever feasible.
 - 6. Upon request, consult with coaches regarding appropriate conditioning programs, injury prevention programs and treatment of athletic injuries.
 - 7. Provide rehabilitation to injured athletes per recommendation of a physician.
 - 8. Consult with the Athletic Director concerning supply and equipment purchase.
 - 9. Provide consultations during the school day as necessary, upon previous arrangement.
 - 10. Coverage of away athletic competitions upon prior arrangement between the athletic trainer and Athletic Director.
 - B. ATI Physical Therapy shall provide liability insurance with limits of \$1,000,000/\$3,000,000 and shall provide written proof of coverage.
- II. Burlington High School shall provide adequate space, equipment and supplies for provision of services.
- III. Burlington High School shall provide a stipend of \$22,000.00 to be paid to ATI Physical Therapy in two installments, \$11,000.00 on September 15 and \$11,000.00 on February 15, in each year of the contract.

- IV. Burlington High School will permit ATI Physical Therapy to display banners in all sports venues that state athletic training services are provided by ATI Physical Therapy.
- V. This proposal shall be subject for renewal and updating on a yearly basis.
- VI. Coverage will commence August 6, 2012 and terminate June 6, 2014.
