4. Action Items

- 4.1 Consent Agenda –Business Manager Pflug reviewed revenues and expenditures. Revenues are currently at 43.41% compared to 36.13% a year ago. Expenditures are at 34.78% as compared to 36.14% a year ago. The District received impact fees totaling \$191,750.53 for 15 new home starts. Transition fees received totaled \$9,305.02. Bills Payable are typical for the month and include two payments for (2) bond certificates and one (1) payment for a debt certificate. The Board will discuss and act on the 2020 Tax Levy.
- 4.2 Approve 2020 Tax Levy – Business Manager Pflug presented the information related to the 2020 tentative tax levy. The District is requesting \$45,855,000 for next year's operating costs. It is anticipated that we will receive approximately \$45,577,000. Total district EAV and new construction came in higher than expected and we anticipate a \$0.05 decrease in the tax rate. At this time, we anticipate the total tax rate will be \$6.76.
- 4.3 Approve the Donation from the Central District 301 Foundation for the Holiday Baskets – The Central Education Foundation donated \$1,000. to be used for the holiday food baskets. Any money not spent on the project will support the PKMS food pantry.
- 4.4 Northern Kane County Regional Vocational System (EFE110) Intergovernmental Agreement among participating School Districts – the agreement was updated to show Central 301 as the administrative and fiscal agent of the cooperative.
- 4.5 Approve Veterinarian Affiliation Agreements – Approval was granted for the following agreements: Four Leg Pets, Fox Valley Wildlife Center, Warrentville Grove Animal Hospital.

5. Information Items

- 5.1 In Person/Remote Learning Status Report – Dr. Mongan shared the middle school Encore newsletter along with a video of the middle school band performing a virtual concert. The number of students shifting remote/hybrid is flat. Schedules are in process and will be available before the students return from winter break. The Board received an email from a parent asking that Dr.

Mongan review the D & F data from remote students only. Dr. Mongan presented the data from quarter one for high school students. The data was broken down several different ways: demographic, course type, students who have remote and hybrid classes, content area, students who are remote only and students who are hybrid. The data shows that the students who are remote only are not performing as well as students attending in person. This is a priority that is being addressed by the administrative team. The grading system needs to be looked at. Are we grading based on what the student has learned, or is it based on completion of assignments? Dr. Mongan will be working on quarter two grades hoping that grades increase. Dr. Stirn noted how well the district is doing with the hybrid schedule. The number of COVID related cases remain low and the district has not seen the spike in cases from the Thanksgiving holiday.

5.2 Buildings and Grounds Update – Director Polowy reported that his staff is working hard, coming in on weekends to keep the buildings clean. Director Polowy also reviewed the November cleaning/custodial work orders. Tickets are typically closed the same day they are received.

5.3 2021-2022 Draft School Calendar - Dr. Stirn presented the draft calendar for 2021-2022. The draft is similar to the 2020-2021 calendar, except parent teacher conferences are the first Thursday and Friday in November, rather than the week of Thanksgiving. Member Nolan asked that we look at October 7 and 8 for parent teacher conferences. Dr. Stirn will bring a revised draft to next month's meeting.

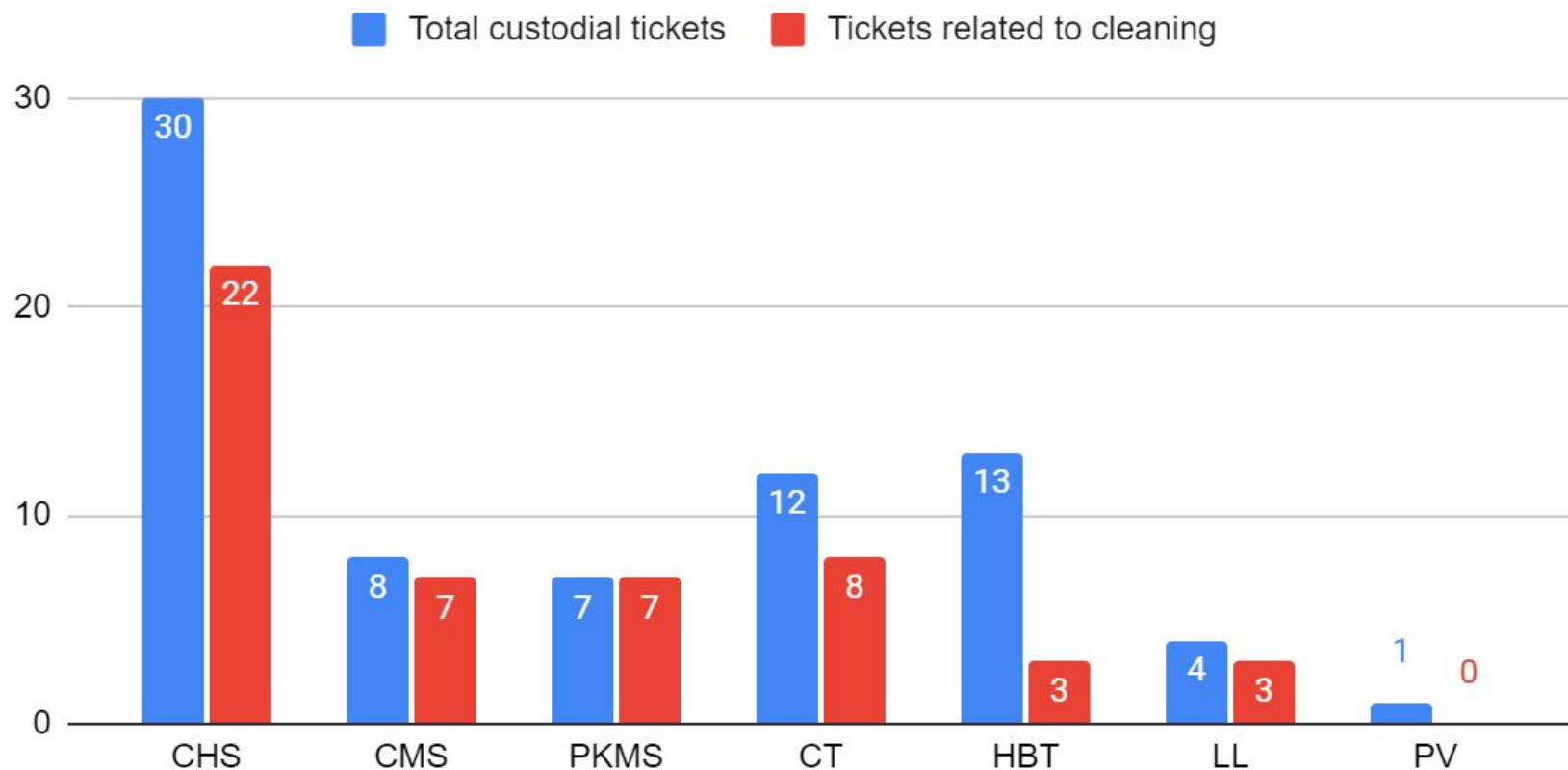

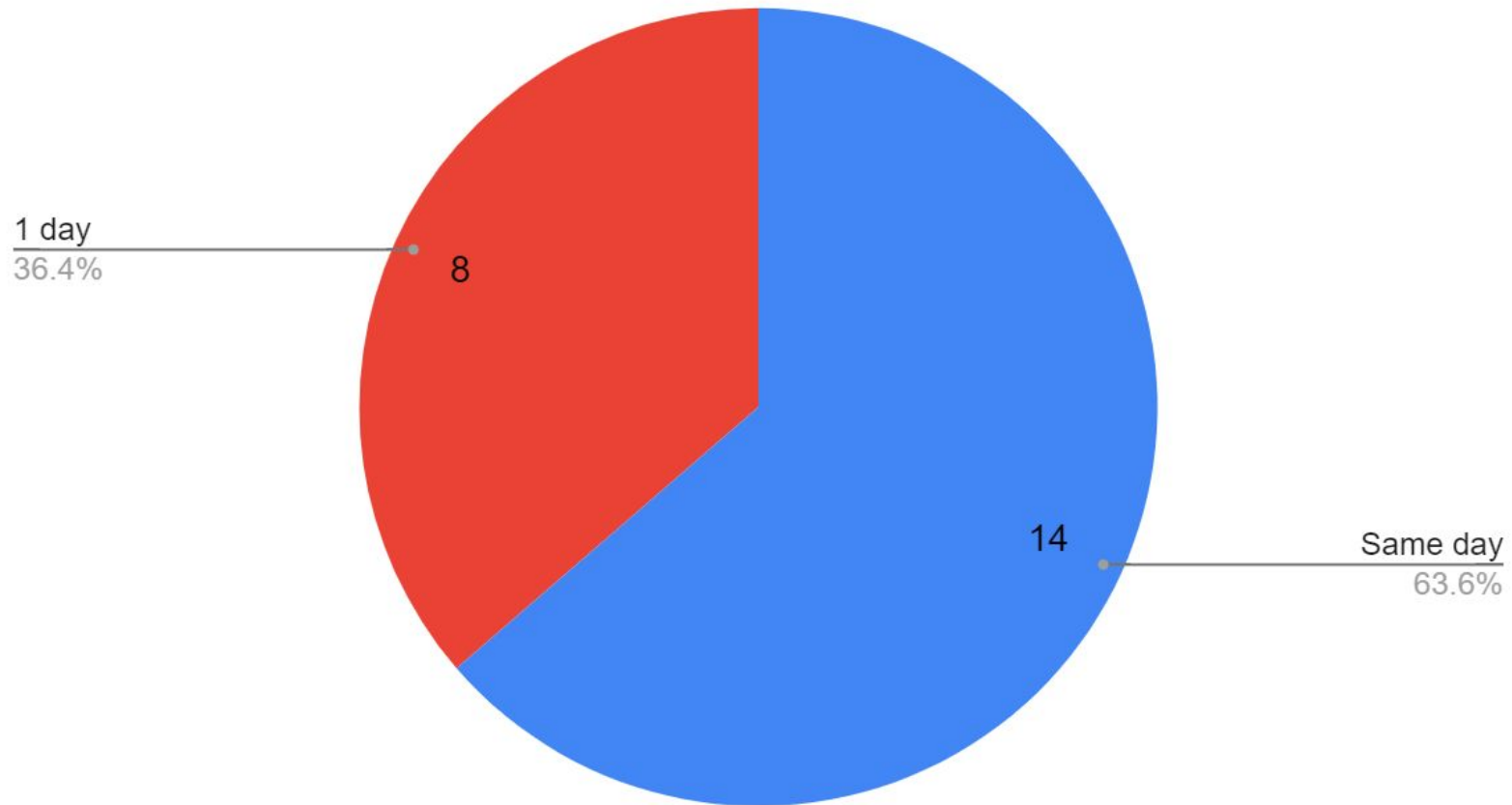

Total Custodial Tickets and Tickets Related to Cleaning

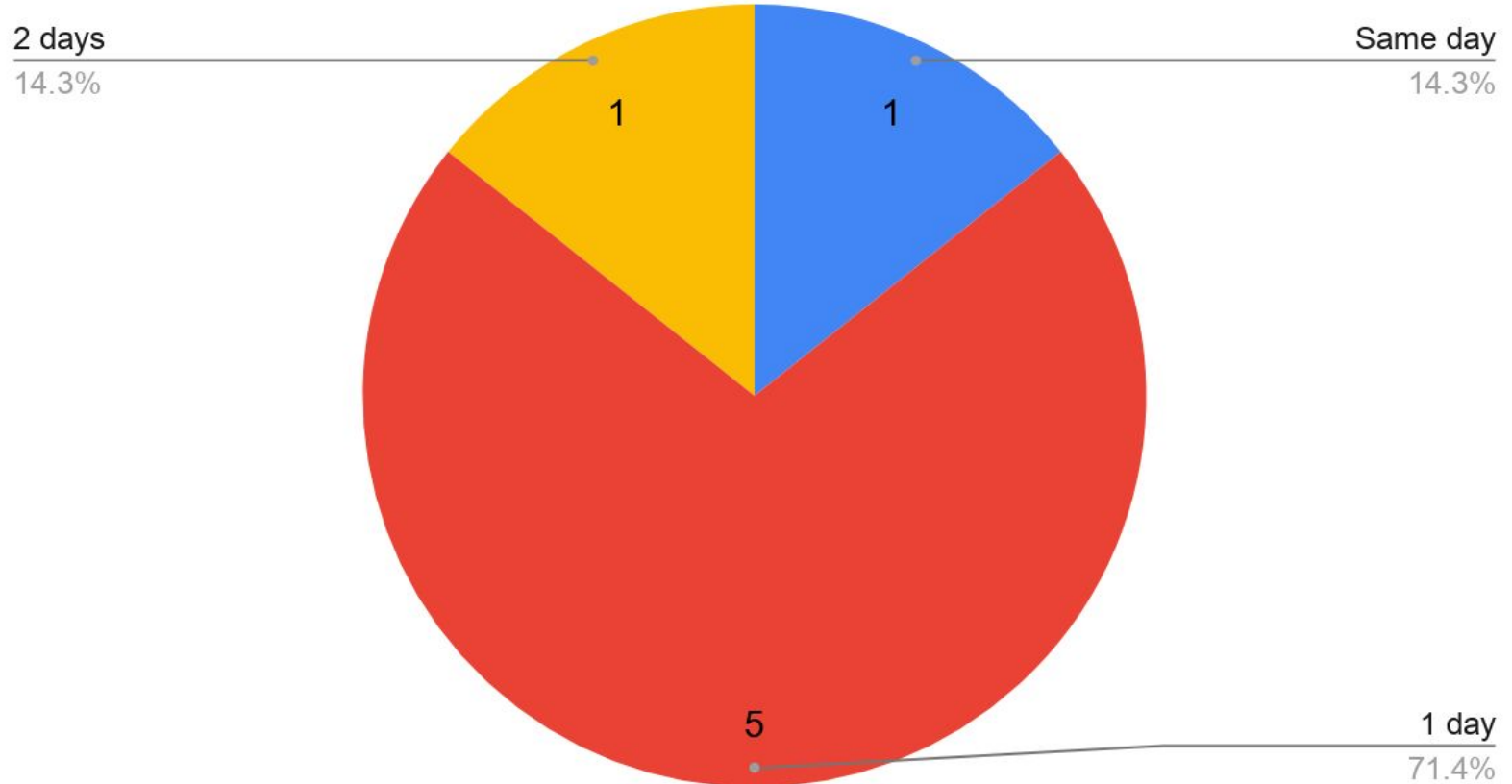

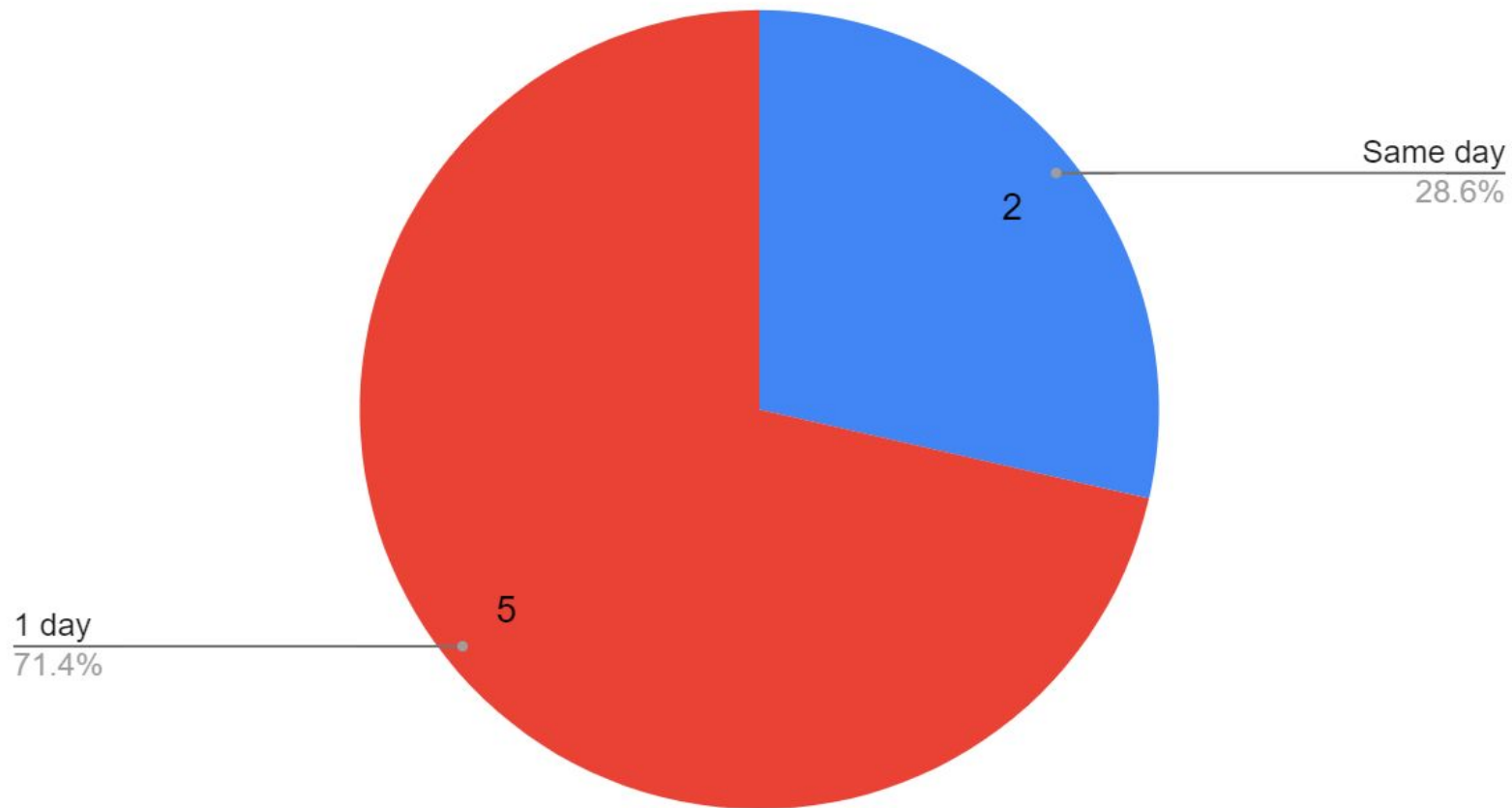
CHS Custodial Ticket Completion Times



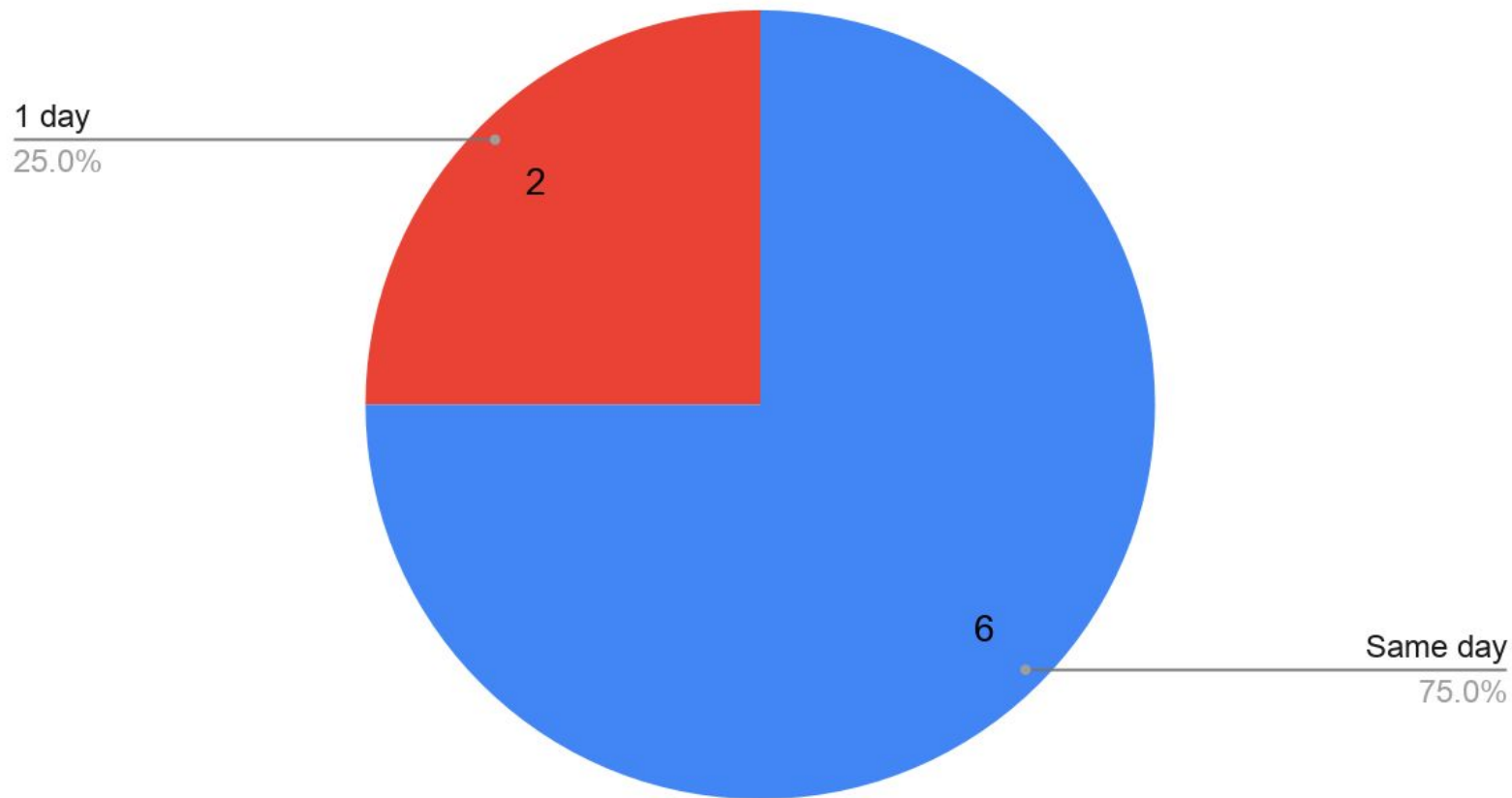
CMS Custodial Ticket Completion Times



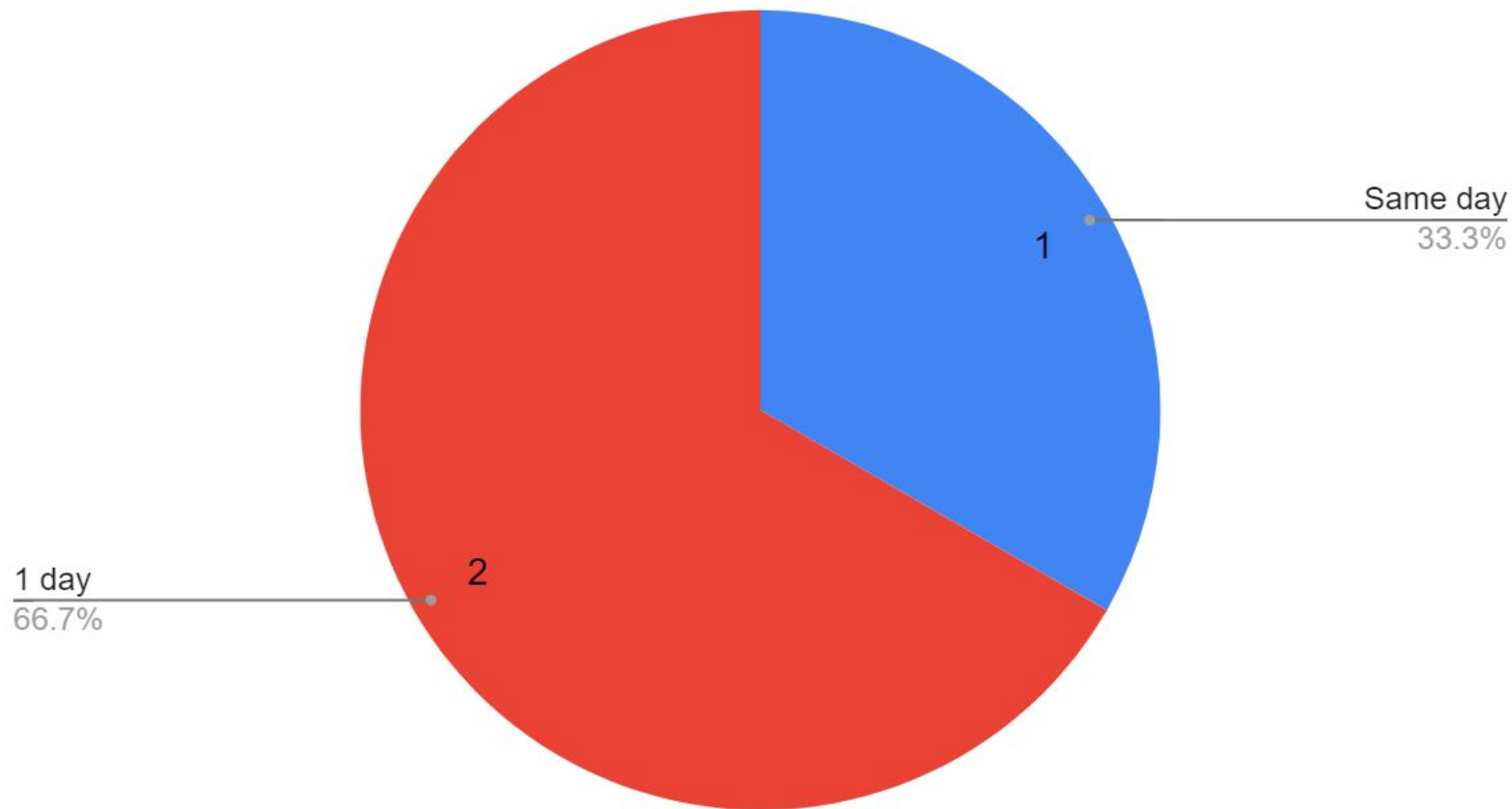
PKMS Custodial Ticket Completion Times



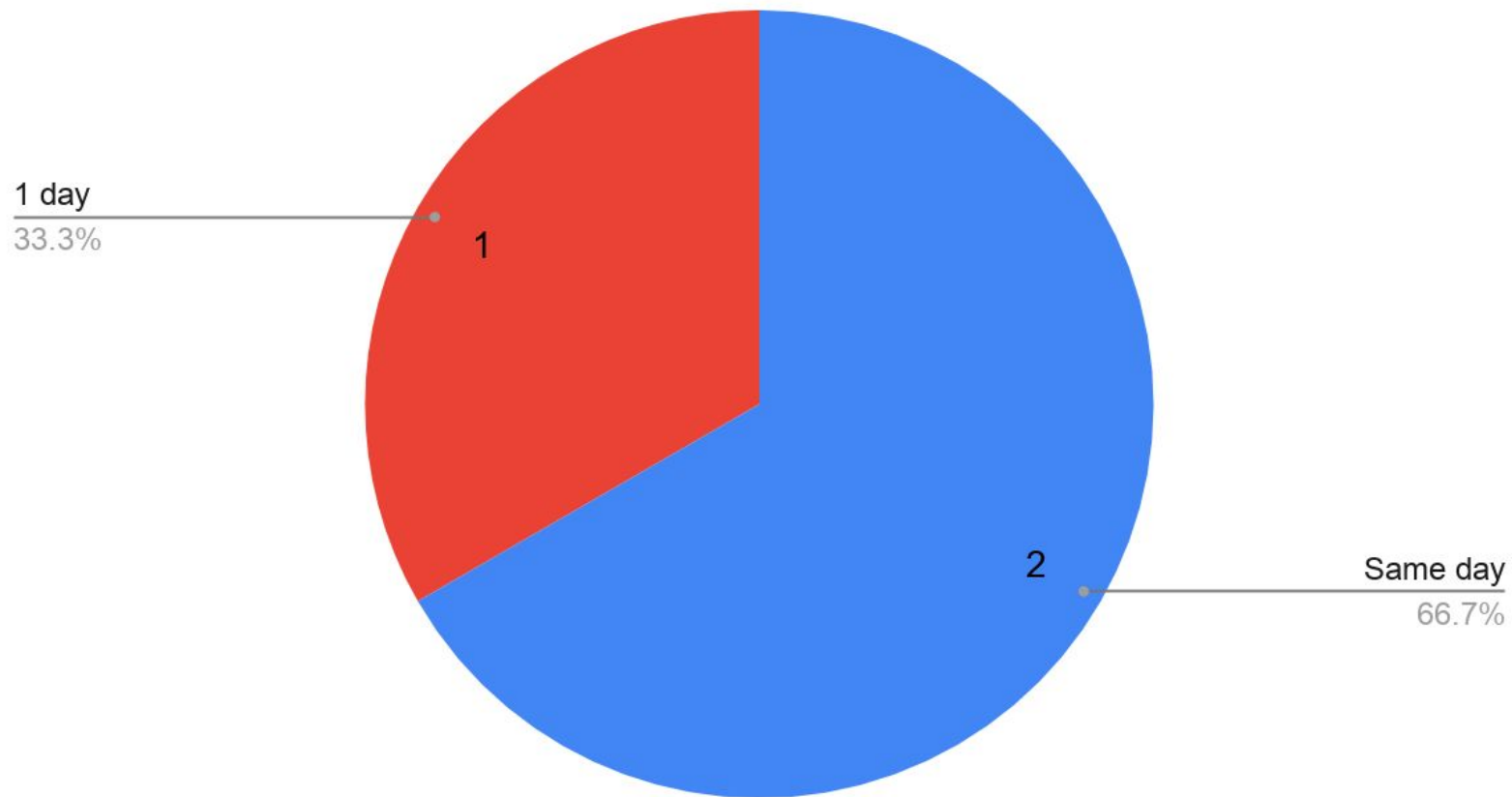
CT Custodial Ticket Completion Times



HBT Custodial Ticket Completion Times



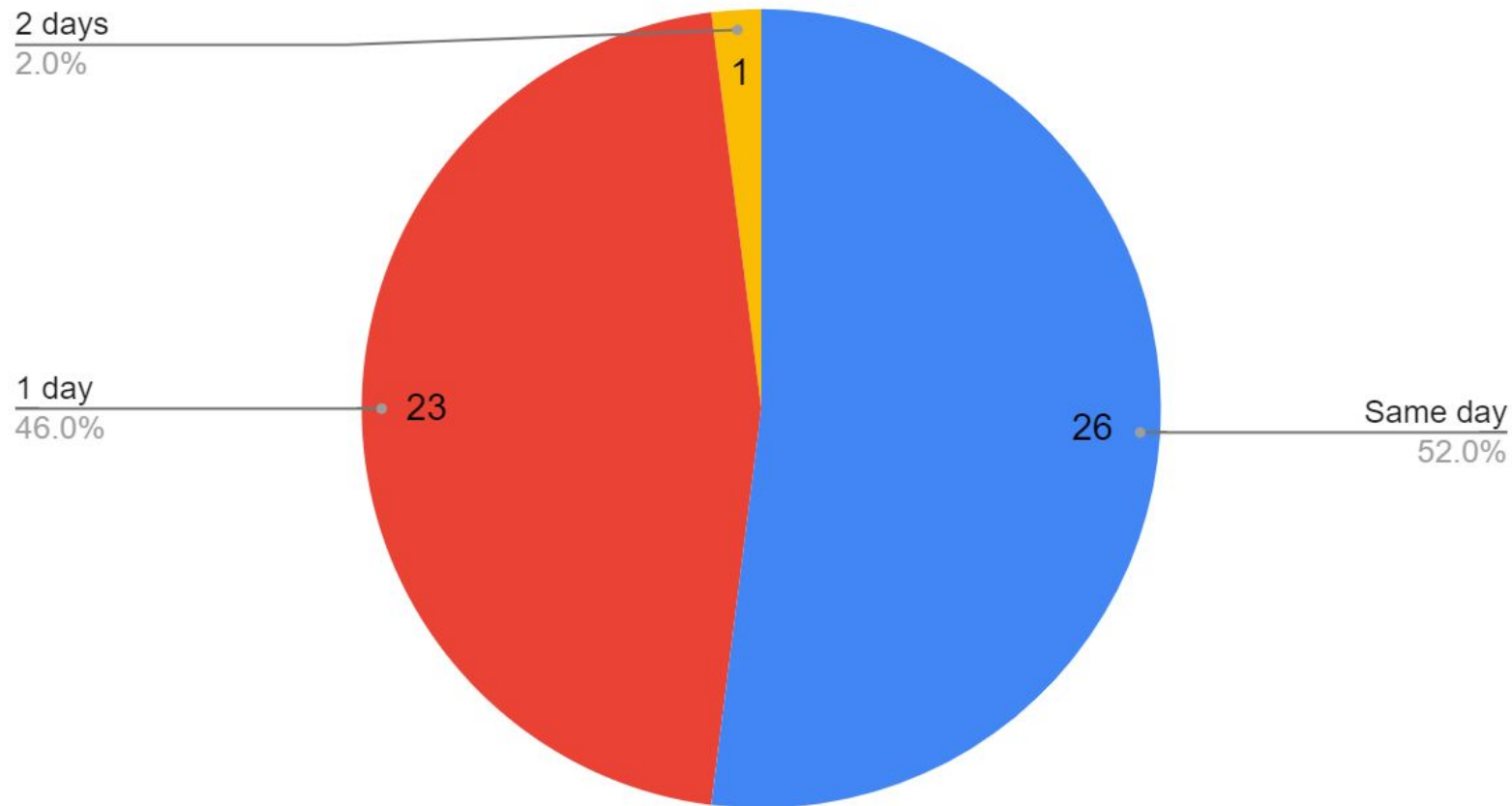
LL Custodial Ticket Completion Times

RE: 2021 – 2022 School Calendar

The superintendents who serve on the board for the Mid-Valley Special Education Cooperative met to review calendars for the 2021 – 2022 school year. I also consulted with Athletic Director Diversey to ensure that our winter and spring break align with the Fox Valley Athletic Conference for holiday competitions.

I am recommending that we adopt this draft calendar with the first day of student attendance on Wednesday, August 11th for 1st-12th grade and Monday, August 16th for preschool and kindergarten. The last day of student attendance and the last teacher workday will be Friday, May 20th. The calendar has five emergency days. Up to five emergency days must be made up. There are 86 student attendance days in the first semester and 88 student attendance days in the second semester. Additionally, professional development days are built into the second semester of the school year to be used for assessment writing.

The calendar also meets the requirements set forth by the Illinois School Code.
