Central District #301 is proud to present the current 2022-2023 State Seal of Biliteracy Award Winners & State Commendation toward Biliteracy Award Winners.

The State Seal of Biliteracy is a recognition given to graduating high school students who have demonstrated a high level of proficiency in English and in reading, writing, listening and speaking in another language(s). The Seal is affixed to the diploma and designated on the transcript.

The State Commendation toward Biliteracy is a recognition given to graduating high school students who have demonstrated significant progress towards achieving a high level of proficiency in English and in reading, writing, listening, and speaking in another language.

Students may apply for the Seal or Commendation during any year in high school, but Seals and Commendations will only be awarded at graduation, if their scores are verified. Participation for the Seal is open to all Central 301 high school students, including students who learn another language outside of school.

Illinois public universities will accept the State Seal of Biliteracy as equivalent to two (2) years of foreign language credit if a student's high school transcript indicates that he or she received the State Seal of Biliteracy. Students also can earn college credit, distinguish themselves on resumes and college applications, earn scholarships and help to continue their understanding of meeting advanced language goals.

3.A Recognition of Visitors – President Gorman and Dr. Stirn welcomed guests and thanked guests attending remotely.

3.B Public Comments – Public comment was heard regarding community members' concerns over the use of COVID funds, the Culture Blast event, the possibility of a new building, and library books.

3.C Athletics and Activities Recognition - Activities and Athletics Director Juske informed the Board of several student teams who recently won competitions including the math team, SkillsUSA, and FFA.

4. Action Items

4.A Consent Agenda– Business Manager Pflug reviewed the revenues and expenditures. The district received \$36,518.05 for 6 new home starts in February. There were no transition fees. The bills payable report for 301 and Northern Kane are normal for March.

4.B Approve Baseball Spring Break Overnight Trip – Athletics and Activities Director Juske shared this trip provides our baseball team the opportunity for turf practice. The softball team will also be participating in a similar trip and will be presented to the Board for approval next month.

4.C Approve ACES State Overnight Trip – Athletics and Activities Director Juske shared this is the first opportunity for our ACES team to travel to state for the competition since COVID. The team won in their division in the sectional competition at NIU.

4.D Approve IHSA Membership Renewal – This is an annual renewal that allows us to continue our partnership with the IHSA for high school athletics for the 2023-2024 school year.

- 4.E Approve Fox Valley Career Center Joint Agreement – Dr. Stirn shared that this agreement has been updated due to changes in Illinois School Code Part 256 and to allow Districts without students participating to be non-voting members and not pay any tuition costs. Continued membership would allow student participation in the future.
- 4.F Approve Contract with Eriksson Engineering – Facilities Director Dan Polowy shared that we did an RFQ and interviewed three civil engineering firms before choosing to partner with Eriksson Engineering for future construction projects.
- 5. Information Items
 - 5.A Enrollment Report – We have 134 more students than last year at this time and continue to see an approximate year over year growth of 3%. We have been growing at an average rate of 3% annually since the 1970s. Live birth data is monitored by zip code to project Kindergarten enrollment. We have been the top large unit district in the state for consistent growth.
 - 5.B Mechanical, Electrical, Plumbing (MEP) Engineer Contract – Facilities Director Dan Polowy informed the Board that in the past our construction firm provided MEP services in-house, but they no longer do. We interviewed three firms and will bring a recommendation to the Board in April. These firms can also support student learning in this field.
 - 5.C Committee Reports
 - 1. CCC - Curriculum Directors Birkmeier and Buchs shared updates regarding high school PE course changes and a proposal to change some fine arts courses. They also continued the conversation about grading practices.
 - 2. DEI - Curriculum Directors Birkmeier and Buchs and MTSS Coordinator Nolan shared an overview of Kane County Institute Day and the Culture Blast held earlier this month. Both events were well received and they estimate approximately 1000 people attended the Culture Blast event.
- 6. Freedom of Information Act
 - 6.A Kelli Cameron – Ms. Cameron requested a number of items related to the term “backpacks”. We denied the request as it was voluminous. Ms. Cameron may resubmit if desired.

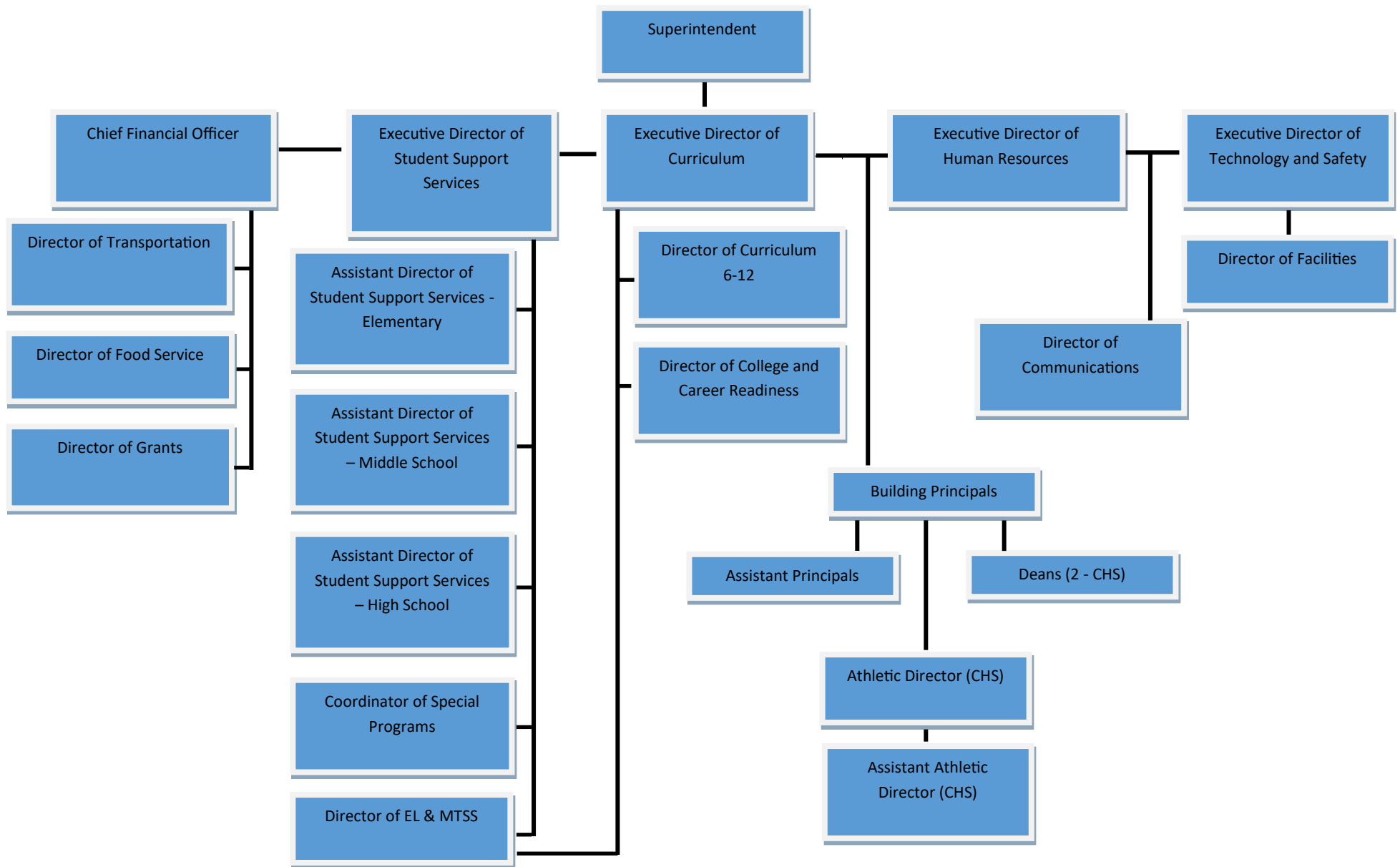
Chain of Command

Our Math Team Coach Catherine Kowalski is requesting to take the Math Team State Qualifiers down to state for competition.

The Math Team competition is a high school competition organized by the Illinois Council of Teachers of Mathematics (ICTM). The ICTM is a community of PreK through Post-Graduate educators that promotes equitable, high-quality mathematics teaching and learning. The purpose of the ICTM State Math Contest is to recognize outstanding mathematical achievement, encourage independent study, stimulate interest in mathematics, and provide a wholesome meeting ground for students and teachers of mathematics through academic competition. Students competed at the FVC Math Competition in early February in which multiple teams from CHS placed in the top 3. Students also competed at the regional competition held at Rock Valley College in late February. Here, our Algebra I team, and Freshmen/Sophomore 8-person team both placed first, qualifying those teams for state. We additionally had two individuals score in the top 5 for their respective individual tests, also qualifying them for state. **AGREEMENT FOR THE PROVISION OF
PROFESSIONAL SERVICES ("AGREEMENT FOR SERVICES")
BETWEEN THE BOARD OF EDUCATION OF CENTRAL COMMUNITY UNIT SCHOOL DISTRICT
301, KANE COUNTY, ILLINOIS ("OWNER")
AND
IMEG CORP. ("ENGINEER")**

1. Definitions

Contract Documents shall include, but are not limited to, this Agreement for Services, any Engineer drawings, as well as any additional drawings, specifications, addenda, General Conditions (as defined in Section 2.1) and other similar Project documents.

Services shall mean the services required of the Engineer under the Contract Documents.

The Project shall mean the project detailed in the individual Project Authorization Exhibits attached to this Agreement.

2. The Services

2.1 Professional Services. The Engineer shall provide the services detailed herein, as may be amended in the applicable Project Authorization Exhibit. The Engineer shall provide administration of the Contract for construction in accordance with this Agreement, the Contract Documents, and AIA Document A201-2017 General Conditions of the Contract for Construction, as amended by Owner ("General Conditions"). The term "Architect" in the General Conditions, or any other Contract Document, shall mean "Engineer". The Engineer acknowledges that it has been engaged to provide professional services because of its character, expertise, experience, and qualifications in dealing with projects of similar size and scope. The Engineer shall exercise skill and care consistent with the expertise, experience and qualifications of professionals practicing in the same or similar locality under the same or similar circumstances. Additionally, the Engineer represents that it has all licenses required by law to perform the services under this Agreement.

2.1.1 The Engineer, as a representative of the Owner, shall visit the site at intervals appropriate to the stage of the Contractor's operations to (1) become familiar with and to keep the Owner informed about the progress and quality of the portion of the work completed, (2) advise the Owner about observed defects and deficiencies in the work, and (3) determine if the work is being performed in a manner indicating that the work, when fully completed, will be in accordance with the Contract Documents. The Engineer shall neither have control over nor charge of, nor be responsible for, the construction means, methods, techniques, sequences, or procedures, or for safety precautions and programs in connection with the work, because these are solely the Contractor's rights and responsibilities.

2.1.2 The Engineer shall report to the Owner known deviations from the Contract Documents and from the most recent construction schedule submitted by the Contractor. The Engineer shall be responsible for the Engineer's negligent acts or omissions, but shall not be responsible for the acts or omissions of the Owner's consultants, Contractor, Subcontractors, or their agents or employees, or of any other persons or entities performing portions of the work.

2.1.3. The Engineer shall review and certify amounts due the Contractors and shall issue certificates in such amounts based upon the Engineer's observations of the Project. The Certificate of Payment shall constitute a representation to the Owner that, based upon the Engineer's evaluation of the work and the data comprising the Contractor's Application for Payment, that the work has progressed to the point indicated and that, to the best of the Engineer's knowledge, information and belief, the quality of the work is in accordance with the Contract Documents, that the Contractor has submitted proper lien waivers covering the work that is the subject of the payment application and the Contractor is entitled to payment in the amount certified.

2.1.4 The Engineer shall review and approve or take other appropriate action upon a Contractor's submittals such as Shop Drawings, Product Data and Samples for the purpose of checking for conformance with the information given and the design concept expressed in the Contract Documents. The Engineer's action shall be taken

with such reasonable promptness as to not cause a delay in the work or in the activities of the Owner, Contractor, or separate contractors, while allowing sufficient time in the Engineer's professional judgment to permit adequate review.

2.1.5 The Engineer shall review and sign or take other appropriate action on Change Orders and Construction Change Directives for the Owner's approval.

2.1.6 The Engineer, shall visit the Project to observe the progress of the work and determine the date or dates of Substantial Completion and the date of final completion. The Engineer shall forward to the Owner warranties and similar submittals required by the Contract Documents. The Engineer shall issue a final Project Certificate for Payment upon compliance with the requirements of the Contract Documents.

2.1.7 When observing the progress of the work to determine the date or dates of Substantial Completion, the Engineer shall prepare a list of incomplete or unsatisfactory items and a schedule for their completion ("Punch List") and shall provide a copy thereof to the Contractor and the Owner. The Engineer shall monitor the Contractor's completion of the Punch-List items and shall keep the Owner apprised of the status thereof. The Engineer shall notify the Owner of the completion of the Punch-List.

2.2 **Consultants and Agents.** The Engineer shall exercise reasonable care to engage additional engineers, consultants, agents, employees, and officers who shall possess the experience, skill, knowledge and character necessary to qualify them individually for the particular duties they perform and who shall perform all Services in conformity with the standards of reasonable care and skill with respect to professional services they are rendering. Said consultants shall carry professional liability insurance. The Engineer assumes full responsibility for the acts, errors and omissions of its consultants.

2.3 **Description of Services.** The Engineer shall perform the Services required in this Agreement and set forth on the applicable Project Authorization Exhibit attached hereto and incorporated herein.

3. Drawings

The Owner shall be supplied with a final copy of the drawings and specifications generated by the Engineer for the Project and shall be permitted to use the drawings and specifications without restriction. The Owner shall not hold the Engineer liable for the Owner's use of the drawings and specifications other than in connection with the Project. Upon completion of the Project, the engineer shall provide the Owner with a complete set of As-Built drawings.

4. Permits

The Engineer shall assist the Owner in obtaining all permits, licenses, approvals, and inspections necessary to commence and complete the Projects. The Owner, however, shall be responsible for the actual cost of said permits, licenses, approvals, and inspections. Engineer's responsibilities under this Section include the completing and filing of necessary documents to obtain the permits, licenses, and approvals required hereunder.

5. Termination

This Agreement may be terminated by the Engineer upon not less than seven days' written notice should the Owner fail to substantially perform in accordance with the terms of this Agreement through no fault of the Engineer. This Agreement may be terminated by the Owner with or without cause upon not less than seven days' written notice.

6. Payment

6.1 **Engineer's Fee.** The Engineer's compensation shall be computed as detailed in the applicable Project Authorization Exhibit A.

6.2 **Requests for Payment.** Engineer shall submit to Owner for its approval a request for payment ("Request for Payment") in form and substance satisfactory to Owner. Each Request for Payment shall set forth the amount due for services rendered, a detailed breakdown of the amount and the sum of all prior payments. The Request for Payment for the Engineer's services shall not exceed the dollar

amount attributable to the percentage of work completed by the Engineer at the time of submission of the Request for Payment. The Engineer shall furnish with each Request for Payment waivers of lien for itself in form and substance satisfactory to Owner and any other such forms as required by Owner, to assure an effective waiver of mechanic and materialmen liens in compliance with the laws of the State of Illinois. Owner shall review each such Request for Payment and make such exceptions as Owner reasonably deems necessary or appropriate under the circumstances then existing. Any reimbursable expenses to be billed to the Owner shall be billed at cost. The Engineer shall only bill the Owner for reimbursable expenses that are reasonably required for the completion of the Project and are normal and customary in the industry.

- 6.3 Prompt Payment Act.** Payments by the Owner shall be made in accordance with the Illinois *Local Government Prompt Payment Act*, 50 ILCS 505/1 *et seq.* For purposes of calculating the Engineer's fee and compensation, the construction cost shall not include additions by change order to the construction cost as a result of errors by the Engineer or the Engineer's consultants.

7. Indemnification

The Engineer agrees to indemnify and hold harmless the Owner, its individual Board members, agents, consultants, and employees (collectively, "Indemnitees"), from and against all damages, losses, and expenses, including reasonable attorneys' fees, caused by the negligent performance of the Services under this Agreement.

Engineer agrees to assume the entire liability for all personal injury claims suffered by its own employees allegedly injured on the Project; to waive any limitation of liability defense based upon the *Workers' Compensation Act*, court interpretations of said Act or otherwise; and to contribute to, indemnify and defend Owner and its individual Board members, agents, employees and consultants from and against such loss, expense, damage or injury, including reasonable attorneys' fees, that the Indemnitees may sustain as a result of such claims, except to the extent that Illinois law prohibits indemnity for the Indemnitees' own negligence.

8. Insurance

8.1 The Engineer shall provide professional liability insurance coverage beginning with the commencement of the performance of Services by Engineer until the date of completion of the Engineer's services in the amount of at least \$10,000,000 per claim and in the aggregate. Further, the Engineer shall also procure and maintain at its own cost and expense (1) comprehensive general liability on an occurrence basis to insure all loss (including, but not limited to, attorney's fees and costs), claims, demands, or actions for damage to property, or bodily and personal injury to or death of any one or more persons in the minimum amount of \$1,000,000 per occurrence and \$2,000,000 in the aggregate, (2) umbrella or excessive liability coverage in a minimum amount of \$4,000,000 per occurrence and in the aggregate, (3) worker's compensation coverage in the minimum statutory amounts, and (4) comprehensive auto liability insurance, including hired and non-owned vehicles, in the amount of \$1,000,000 per occurrence and in the aggregate for bodily injury and property damage. The Engineer shall ensure that the insurance required under this Agreement provides coverage over the obligations of the Engineer in Section 7. The Engineer shall name the Indemnitees as additional insureds on all insurance policies required under this Agreement on a primary and noncontributory basis, with the exception of the professional liability insurance and the worker's compensation insurance. The insurance required of the Engineer, with the exception of the professional liability insurance, shall be primary. The excess or umbrella insurance required hereunder shall follow the underlying policy in all respects. The insurance requirements set forth herein are minimum contractual obligations and shall not preclude the Owner from accessing insurance limits above said stated minimums.

8.2 Certificate of Insurance Requirements. Engineer shall provide Owner with a certificate of insurance evidencing the insurance required under this Agreement prior to commencing the Services. The certificates of insurance and all insurance policies required to be obtained by the Engineer shall provide that coverages afforded under the policies will not be canceled, reduced or allowed to expire without at least thirty (30) days prior written notice given to the Owner for reasons other than nonpayment of premium and at least ten (10) days notice of cancellation for nonpayment of premium. If any of the insurance coverages are required to remain in force after final payment, all additional certificates evidencing continuation of such coverage shall be submitted with the final application for

payment. Upon demand of Owner, Engineer shall provide Owner with full copies of the insurance policies, including but not limited to endorsements, thereto, required under this Agreement.

9. Owner Shall Not Waive Any Rights of Subrogation

Notwithstanding any other provision in any Contract Document, the Owner shall not, in any manner, be deemed or intended to have waived any right of subrogation which either it or its insurance company may have against the Engineer.

10. Owner Shall Not Waive Any Rights By Making Any Payment

Notwithstanding any other provision in any Contract Document, the Owner shall not, in any manner, be deemed or intended to have waived any claim by making a final payment or a progress pay of any amount.

11. Insurance Requirements Cannot Be Waived by Owner

Under no circumstances shall the Owner be deemed to have waived any of the insurance requirements of this Contract by any action or omission.

12. Notice of Personal Injury or Property Damage

Engineer shall notify Owner, in writing, of any actual or possible claim for personal injury or property damage relating to the work, or of any occurrence which might give rise to such a claim, promptly upon obtaining first knowledge of same.

13. Additional Services

Any additional service for which the Owner is to compensate the Engineer must be authorized in writing by the Owner before the work is commenced, and an estimate of the cost or a method of determining the cost must be submitted by the Engineer prior to the authority being granted for such service by the Owner. Notwithstanding any provisions in this Agreement to the contrary, the Engineer shall not be entitled to payment for additional services involved in:

- (a) Revision of Project documents to secure the approval of the Owner for the basic work unless said Project documents have been previously approved by the Owner;
- (b) Revisions of or additions to the Project documents required because of errors or omissions of the Engineer;
- (c) Alternates which are included in the Project documents upon which bids are taken but for which no contract is awarded and which shall not have required drawing revisions on the Project documents;
- (d) Revision of Contract Documents to bring the applicable portion of the Project within the budget, as prepared by the Engineer and agreed to by the Owner.

14. Authorizations

Any authorization to be made by the Owner as referred to herein must be in writing by duly authorized representatives of the Owner in order to be binding upon the Owner.

15. Compliance with Laws

The Engineer shall perform the Services in compliance with all applicable laws, ordinances rules, regulations and codes, including but not limited to the *Illinois Prevailing Wage Act*, 820 ILCS 130/1 *et seq.* The Engineer agrees to fully comply with all requirements of federal and state law, including, but not limited to, the requirements of the *Illinois Human Rights Act*, 775 ILCS 5/1-101 *et seq.* and the provision of sexual harassment policies and procedures pursuant to Section 2-105 of that Act. The Engineer further agrees to comply with all federal Equal Employment Opportunity Laws,

including, but not limited to, the *Americans With Disabilities Act*, 42 U.S.C. Section 12101 *et seq.*, and rules and regulations promulgated thereunder. The *Illinois Employment of Illinois Workers on Public Works Act*, 30 ILCS 570/0.01 *et. Seq.*, and the *Steel Products Procurement Act*, 30 ILCS 565/1 *et seq.*, shall prevail on this Project to the extent such Acts are applicable and enforceable. The Engineer understands that smoking is prohibited on school district property pursuant to State and federal law and shall not allow any of its employees, consultants, or agents to smoke on Owner's property. Engineer acknowledges that, under Illinois law, the presence of sex offenders is prohibited on school district property except in limited circumstances with notice to and approval of Owner. As such, Engineer represents and warrants to Owner that none of Engineer's, or any of its agents' and consultants' employees are prohibited from being present on the Owner's property as a result of being a convicted sex offender or otherwise.

It is the understanding of the Parties that no employees of the Engineer performing the Services under this Contract will have direct, daily contact with pupils of Owner. If any individual performing any Services will have direct, daily contact with students, or if otherwise requested by the Owner, Engineer must immediately obtain criminal background investigations of any of Engineer's employees who are or will be performing work in or around a building when students are or will be present to ascertain whether such employees have been convicted of any of the offenses enumerated in 105 ILCS 5/10-21.9. Such criminal background checks will be performed at Engineer's or expense and at no cost to Owner, by change order or otherwise. The Owner will notify the Engineer if the Owner determines that any individual is not eligible to be present on the Owner's property in connection with the Project. Due to restrictions on disclosure of background check information, the Owner may not specify to Engineer the reasons for a determination of ineligibility. Furthermore, to the extent required by 105 ILCS 5/24-5 or any other law, rule or regulation, Engineer shall provide to the Owner, at Engineer's expense, evidence of Engineer's employees' physical fitness to perform their duties and freedom from communicable disease.

Engineer agrees to comply with all rules, regulations and orders related to mitigating the spread of any infectious disease, specifically including but not limited to the spread of COVID-19. Moreover, Engineer shall also comply with any and all rules, regulations, policies, and requests of Owner relating to mitigating the spread of any infectious disease, specifically including but not limited to, the spread of COVID-19.

16. Non-Discrimination Clause

The Engineer agrees to fully comply with the requirement of the *Illinois Human Rights Act*, 775 ILCS 5/1-101 *et seq.*, including, but not limited to, the provision of sexual harassment policies and procedures pursuant to Section 2-105 of the Act. The Engineer further agrees to comply with all federal Equal Employment Opportunity Laws, including, but not limited to, the *Americans With Disabilities Act*, 42 U.S.C. Section 12101 *et seq.*, and rules and regulations promulgated thereunder.

The following provisions are included in this Agreement pursuant to the requirements of the regulations of the Illinois Department of Human Rights, Title 44, Part 750, of the Illinois Administrative Code, and Engineer shall be required to comply with these provisions only if and to the extent they are applicable under the law.

As required by Illinois law, in the event of the Engineer's non-compliance with the provisions of this Equal Employment Opportunity Clause, the Illinois Human Rights Act or the Rules and Regulations of the Illinois Department of Human Rights ("Department"), the Engineer may be declared ineligible for future contracts or subcontracts with the State of Illinois or any of its political subdivisions or municipal corporations, and the contract may be canceled or voided in whole or in part, and such other sanctions or penalties may be imposed or remedies invoked as provided by statute or regulation. During the performance of this contract, the Engineer agrees as follows:

- (a) That it will not discriminate against any employee or applicant for employment because of race, color, religion, creed, sex, marital status, national origin or ancestry, age, citizenship, marital status, physical or mental handicap or disability, military status, or an unfavorable discharge from military service or arrest record status; and further that it will examine all job classifications to determine if minority persons or women are underutilized and will take appropriate affirmative action to rectify any such underutilization.
- (b) That, if it hires additional employees in order to perform this contract or any portion thereof, it will determine the availability (in accordance with the Department's Rules) of minorities and women in the

area(s) from which it may reasonably recruit, and it will hire for each job classification for which employees are hired in such a way that minorities and women are not underutilized.

- (c) That, in all solicitations or advertisements for employees placed by it or on its behalf, it will state that all applicants will be afforded equal opportunity without discrimination because of race, color, religion, sex, marital status, national origin or ancestry, age, physical or mental handicap unrelated to ability, or an unfavorable discharge from military service.
- (d) That it will send to each labor organization or representative of workers with which it has or is bound by a collective bargaining or other agreement or understanding, a notice advising such labor organization or representative of the Engineer's obligations under the Illinois Human Rights Act and the Department's Rules. If any such labor organization or representative fails or refuses to cooperate with the Engineer in its efforts to comply with such Act and Rules, the Engineer will promptly so notify the Department and the contracting agency and will recruit employees from other sources when necessary to fulfill its obligations thereunder.
- (e) That it will submit reports as required by the Department's Rules, furnish all relevant information as may from time to time be requested by the Department or the contracting agency, and in all respects comply with the Illinois Human Rights Act and the Department's Rules.
- (f) That it will permit access to all relevant books, records, accounts and work sites by personnel of the contracting agency and the Department for purposes of investigation to ascertain compliance with the Illinois Human Rights Act and the Department's Rules.
- (g) That it will include verbatim or by reference the provisions of this clause in every subcontract it awards under which any portion of the contract obligations are undertaken or assumed, so that such provisions will be binding upon such subcontractor. In the same manner as with other provisions of this contract, the Engineer will be liable for compliance with applicable provisions of this clause by such subcontractors; and further it will promptly notify the contracting agency and the Department in the event any subcontractor fails or refuses to comply therewith. In addition, the Engineer will not utilize any subcontractor declared by the Illinois Human Rights Commission to be ineligible for contracts or subcontracts with the State of Illinois or any of its political subdivisions or municipal corporations.

17. No Waiver

No failure of either the Engineer or the Owner to exercise any power given in this Agreement or to insist upon strict compliance by the other party with any obligation hereunder and no custom or practice of the Owner or the Engineer at variance with the terms hereof shall constitute a waiver of the right of either party to demand exact compliance with the terms of this Agreement.

18. Notice

Any written notices provided for in this Agreement and copies of all correspondence shall be transmitted to Superintendent of the District and the Engineer at the following addresses:

19. Complete Understanding

This Agreement shall constitute the complete understanding of the parties. This Agreement supersedes all prior agreements entered into by the Parties.

20. Authority to Execute.

Each signatory hereto represents and warrants that he or she has the requisite authority to execute this Agreement and to bind his or her entity to the terms and conditions hereof.

21. Assignment.

Engineer shall not assign or otherwise transfer any of its rights or obligations, under this Agreement without prior written consent of the Owner, which may be withheld in Owner's sole discretion.

22. Bidding Certification.

By entering into this Agreement with the Owner, the Engineer certifies that it is not barred from bidding on or entering into this Agreement as a result of a conviction for either bid-rigging or bid rotating under Article 33E of the *Criminal Code of 2012* (720 ILCS 5/33E) or by any other law or rule or regulation. The Engineer acknowledges that the Owner may declare this Agreement void if it determines that foregoing certification to be false.

23. Conflict of Terms.

To the extent that any of the terms and conditions contained in this Agreement conflict with the terms and conditions of the Project Authorization Exhibit, the term or condition of the Project Authorization Exhibit shall prevail. To the extent that any of the terms and conditions contained in this Agreement conflict with the terms and conditions of any other document comprising this Agreement, the term or condition that requires the greater quality, quantity or service shall control.

24. FOIA Compliance.

The Owner is subject to the Freedom of Information Act, 5 ILCS 140/1, et seq. ("FOIA"), and any and all information submitted by the Engineer to the Owner is subject to disclosure to third parties in accordance with FOIA. If the Engineer requests that the Owner withhold any submitted information as trade secrets, commercial information, or financial information from disclosure to a third party in response to a Freedom of Information Act request, the Engineer must notify the Owner of such request at the time such information is submitted to the Owner, along with a statement that disclosure of such information will cause competitive harm to the Engineer, as provided by FOIA Section 7(1)(g), 5 ILCS 140/7(1)(g). Any content not so marked by the Engineer at the time of submission to the Owner will be presumed to be open to public inspection. The Engineer may be required to substantiate the basis for its claims at a later time. Notwithstanding timely notice received from the Engineer in accordance with Section 7(1)(g), the Owner reserves the right, in its sole discretion and subject only to applicable law, to withhold or release the subject information in response to a FOIA request. The Engineer waives any rights it may have, or claim to have, to challenge, protest, enjoin or otherwise assert a claim relating to, connected with or arising from any FOIA request. As a potential provider of a governmental function on behalf of the Owner, the Engineer agrees to cooperate with the Owner in responding to any FOIA request, including by timely providing any documents requested by the Owner that directly relate to the governmental function that the Engineer has been engaged to perform on behalf of the Owner.

RE: Mid-Valley Special Education Cooperative Classroom Use Agreement

The Mid-Valley Special Education Cooperative Classroom Use Agreement is an annual resolution to allow the lease of two classrooms at Central Middle School for the Educational and Life Skills Program and the New Pathways Program at a rate of \$4,872.00 for each classroom. The agreement also includes the lease of a New Pathways Program classroom at Central High School at a rate of \$7,494.00. The rate is based on \$6.00 per square foot for the 2023-2024 school year. We are currently in discussions with Mid-Valley about potentially hosting one additional elementary classroom for the 2023-2024 school year. Central, along with Batavia, Geneva, Kaneland, and St. Charles school districts form the Mid-Valley Special Education Cooperative. This partnership allows Central to meet the needs of certain special education student populations that would be cost prohibitive to meet in a standalone district program.

CLASSROOM USE AGREEMENT

This Classroom Use Agreement (“Agreement”) is made and entered into this 1st day of July, 2023, by and between the Board of Education of School District No. 301 (“hereinafter referred to as the ‘District’”) and Mid-Valley Special Education Cooperative, a special education joint agreement (“hereinafter referred to as “Mid-Valley”).

WHEREAS, District has declared that the classroom(s) identified on Exhibit A are unnecessary for school purposes and will not be needed by the District during the proposed term of this Agreement; and

WHEREAS, the District has determined that the proposed use of the classroom(s) identified on Exhibit A serves the interest of the community and that it is the best interest of the District to enter into this Agreement; and

WHEREAS, Mid-Valley has a need for additional classroom space to serve the needs of the special education students educated through the Mid-Valley Special Education Cooperative;

NOW, THEREFORE, in consideration of the mutual covenants and agreements contained herein, the parties agree as follows:

1. **Authority.** This lease is being entered into pursuant to the provisions of the *School Code*. The District hereby represents and warrants that it has full authority to enter into this Agreement and be bound by its terms.

2. **Classroom Use.** For the period of July 1, 2023 through June 30, 2024, the District leases to Mid-Valley and Mid-Valley hereby leases from the District classrooms as per Exhibit A.

3. **Term.** This Agreement shall remain in full force and effect from July 1, 2023 through June 30, 2024.

4. **Responsibilities of the District.**

1. The District shall provide all services and utilities including custodial and maintenance services and supplies that may be necessary to maintain the classrooms identified on Exhibit A in normal, habitable condition for classroom instructional purposes and delivery of related services.
2. The District shall ensure that the MVSEC classrooms are furnished in a manner consistent with other classrooms in the school which may include desks and chairs for students and teachers, tables, book cases, file cabinets, storage cabinets, and window coverings.
3. The District shall ensure that the classrooms are provided in a manner consistent with other classrooms in the school, including customary audio visual equipment, computer hardware and software, internet access, copy machine facilities and telephone lines and usage to support the instructional activities and delivery of related services in the classrooms identified above.
4. The District shall provide administrative assistance in emergencies and guidance on general building policies and procedures necessary to support the instructional activities and delivery of related services in the classrooms identified above.
5. The District shall provide all other supports and services, set forth in the Principal's Guide for Hosting a Mid-Valley Program, attached hereto, and incorporated herein as Exhibit B.
6. The District shall keep in force at all times during the Agreement general liability broad form insurance, occurrence based insurance including property damage, bodily injury, personal injury, contractual liability and other usual broad form liability endorsements.

5. **Responsibilities of Mid-Valley**

1. Mid-Valley shall pay to the District the sum of \$17,238.00 per year in installments as follows: One half in January, 2024; One half in June, 2024.
2. Mid-Valley shall employ the certified staff, substitute staff, paraprofessionals and related services professionals necessary to provide the special education and related services to the students placed in the classrooms.
3. Mid-Valley shall assume the responsibilities set forth in the Principal's Guide for Hosting a Mid-Valley Program attached hereto and incorporated herein as Exhibit B.
4. Mid-Valley shall maintain Illinois Worker's Compensation and Occupational Disease Act coverage as well as Employer Liability Coverage for all Mid-Valley employees assigned to work in the classrooms identified above.

6. **Indemnification.** To the fullest extent permitted by law, Mid-Valley shall indemnify and hold harmless the District from and against all claims, damages, losses and expenses for personal injury or property damage, including but not limited to attorney's fees (including the expenses of investigation, settlement and/or litigation) arising out of or resulting from Mid-Valley's negligent, reckless or willful misconduct. Mid-Valley's indemnification and hold harmless obligation shall survive the termination of this Agreement. To the fullest extent permitted by law, the District shall indemnify and hold harmless Mid-Valley from and against all claims, damages, losses and expenses for personal injury or property damage, including but not limited to attorney's fees (including the expenses of investigation, settlement and/or litigation) arising out of or resulting from the District's negligent, reckless or willful misconduct. The District's indemnification and hold harmless obligation shall survive the termination of this Agreement.

7. **Notice.** All notices and demands required hereunder shall be in writing and shall be deemed to have been given or made when delivered personally when mailed by registered or certified mail, postage prepaid, return receipt requested addressed as follows:

8. **Modification.** The terms of this Agreement may be modified only by written mutual agreement by the parties.

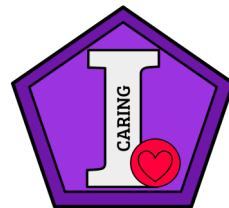

Cougar Pride– REBOOT

In my tenure at Country Trails we have always had a Cougar Pride Program. Carl the Cougar is painted on our walls. Daily, we still recite our Cougar Pledge, “I am a Cougar. I show pride in all I do. I care about myself, I care about others, and I care about this school.”

Small posters hang in common areas of the school– representing what showing PRIDE in that area looks like. Students were recognized sporadically with Cougar Pride Tickets but with little purpose.

When we came back from COVID full time every adult in the building realized our students were hurting. Of course there were educational gaps that we were focused on closing but students also forgot how to “do school.” At the elementary level some students had never been to a formal setting like a daycare or camp due to restrictions.

Our SEL committee set forth to revamp and reboot our program, a crucial task to help heal the building and teach our students the values of being a friend, teammate, and community member in every community they belong to. We wanted to really strive for student and staff participation and buy-in. We wanted to create excitement and motivate students to display their positive character. Our results have been beyond our wildest dreams.

Cougar Pride House System

To begin the year, students randomly drew into the 5 houses each representing a color and attribute of “PRIDE.” Every staff member also selected a house to help mentor and guide the students.

PTO helped purchase a school shirt for every student and staff member of CT. On Wednesdays, the students wear their house colors showing their Cougar Pride.

We wanted to get away from our past traditions of grade vs grade or class vs class. We wanted to build new communities within our school where students across all grade levels had an opportunity to make new friends and form buddies with the older role models.

Social Emotional Learning (SEL)

We also utilized our house system to split up and learn valuable SEL lessons. Near the end of each month, students get together with others across the grade level who are in their house color for an SEL lesson. During this time, every student at CT is participating in a lesson about a character trait that we are challenging students to display during the next month. Some of the character traits that we have targeted in our monthly lessons include: responsible choices, fairness, friendship, respect, caring and perseverance.

Cougar Pride Incentives

Every day students’ positive actions earn them Cougar Pride tickets from staff members. The students put their tickets into buckets located outside the main hall. There are specific tickets students can earn for showing their positive behavior in the lunchroom and on the busses (these are known as the “Hot Spots”).

Each Tuesday night, tickets are counted and random tickets are drawn from each house, grade level lunch, and bus buckets to identify weekly winners.

The students’ names are read over the morning announcements on Wednesday mornings. Winning in the lunchroom or bus rewards the entire house 5 additional points. At the end of the month the house with the most Cougar Pride tickets “takes over” the school.

We hang banners in their colors in the halls. Each teacher places a decal of that House’s color and sigil (symbol) outside their classroom door.

The 5 house winners from each week for a given month are then invited to have “Breakfast with the Principal” where I celebrate them being role models in the school for showing their Cougar Pride.
