**BOE Meeting**

1. Meeting Call to Order - President Wasson called the meeting to order at 6:01 p.m.

1.A Roll Call - **President Wasson called the meeting to order and roll call was taken. 6:02 p.m**

2.. Public Open Forum

2.A Recognition of Visitors – President Wasson welcomed visitors.

2.B Public Comments - President Wasson asks that everyone keep to three minutes when speaking and reminds everyone that the Board does not engage in discussion or respond to questions at this time but encourages the community to use the district channels to communicate with the board.

A member of the community criticized the district's proposed levy and asked the Board not to pass it. He also recommended using the district's operating fund balances to cover expenses instead.

A member of the audience shared information on Birth to Five Illinois a non profit company of which she is the Family Community Engagement Specialist. She shared information on how the company assists Kane County and shared the

website [www.birthtofiveil.com](http://www.birthtofiveil.com) asking that administrators seek it out and read their reports.

A community member addressed the board regarding the district's response to the presence of federal agents near Country Trails and Prairie Knolls schools. He also asked the Board of Education to review Policy 4:170 concerning safety and to improve prompt communication with parents.

The Board President Ryan Wasson took this opportunity to commend the administration's calmness and professionalism in responding to what he termed a "perceived threat," noting that panic and fear are significant threats to students. President Wasson also stated that discussing specific safety protocols in an open meeting would be counterintuitive to security.

A community member shared she felt the district did a good job last week with the presence of federal agents. She also liked the idea of listening tours with board members and superintendents meeting with the community.

- 2.C Audit report for Central 301 and Northern Kane County Vocational System- Charyden Juergensen from Eccezion gave a presentation on the Audit report for Central 301 and the Northern Kane County Regional Vocational System received an **unmodified opinion**, meaning the financial statements were free from material misstatement. No deficiencies or concerns were found regarding internal controls.

7. **Superintendent Search** - President Wasson shares that the Superintendent search is on schedule with the original timeline.

B. Approve Tentative Tax Levy

The Board recommended the Tentative Levy in the amount of 60,910,000.00. Since the request is below the 5% increase threshold, a truth in taxation hearing is not required.

- The anticipated **total tax rate is projected to decrease** from 5.87 to 4.94 This significant decrease is primarily attributed to the falling off of payments for the 2013 series bonds.
- The district plans to **under-levy certain funds** (IMRF, social security, and tort) to utilize existing fund balances.

4. Presentations-

- A. Central District 301 Summer internship presentation 2025 - The presentation given by Nancy Coleman, from the Alignment Collaborative for Education, Todd Stern and Terry Stroh Program Specialists of the Northern Kane EFE Program, highlighted the success of the 2025 summer internship program. The program served 3,418 students with resume building workshops. Students presented to the board sharing the things they have learned and are excited about in the EFE program.
- B. Presentation on Girls Flag Football - Mike Sutter Athletic Director, presented a proposal to adopt Girls Flag Football as an IHSA sport starting in the 2026-2027 school year. Central 301 is currently the only district in the Fox Valley Conference that does not have a Girls Flag Football program. The proposal for Girls Flag Football will return as a formal action item for the December Board meeting.
- C. CEF Elective Survey Result - Stephen Buchs, 9-12 Curriculum Director and Dee Hemphill, President of The Central Education Foundation (CEF) presented results from a survey conducted with high school students and parents regarding potential new elective curriculum. The top three areas of interest for students were: Culinary Arts (over 60% of students), Fitness and Personal Training, and Digital Marketing/Graphic Design. Parents also ranked Culinary Arts and Digital Marketing/Graphic Design highly, alongside Wood Shop or Welding. The district is reviewing the data to determine feasible short and long-term goals, acknowledging that the CEF Foundation is prepared to help fund new program initiatives.
- D. 24-25 Achievement Presentation - The annual achievement presentation reviewed the district's performance based on the state's new testing system and "right-sized" benchmarks. The district received four exemplary and three commendable summative designations for its schools. Central 301 ranks number one among surrounding peer districts in ELA proficiency (78.2%). Because the state moved proficiency benchmarks, current test scores are a new baseline and cannot be directly compared to prior years' data.

- E. Facilities Update - Dan Poloway, Facilities Director shared updates in regards to the architects conducting facility assessments. The updated budget for the track project will be presented in December. During the upcoming holiday break, the staff will be performing capital projects such as flooring, painting and HVAC.

The Board discussed and supported establishing "Listening Tours" involving board members and the superintendent. These tours are intended to give the community an alternative, face-to-face outlet for engagement and to share accurate information, countering the spread of misinformation often found on social media. The timing is considered ideal because of the upcoming announcement of a new superintendent to the community.
- B. Language Requirements 2028-2029 MS/HS Schedule options  
The board continued the discussion regarding the state's impending two-year foreign language graduation requirement and potential schedule changes. A specific recommendation was made to move forward minimally by focusing on adopting an additional period for grades 6, 7, and 8 as soon as possible. This change is intended to provide middle school students with more elective and career exploratory options, which aligns with community interest and prepares them for future career decisions. This will be brought back for discussion at the December meeting.

- The Revenue and Expenditure Summary Reports are included in the board packet. Revenues are currently at 39.36% compared to 38.66% a year ago. Expenditures are trending at 38.32% as compared to 39.46% a year ago.
- The district received impact fees for \$66,750.79 for 13 home starts for October. No transition fees came in this month.
- The bills payable reports for both Central 301 and Northern Kane are typical for the month of December. Included this month for Central 301 is a payment for bonds totaling \$2,061,850 to Amalgamated Bank of Chicago.
- Tonight, the board will discuss and act on a resolution regarding the final aggregate tax levy for the tax year 2025.
- Central's FY25 audit is now complete. There were no changes from last month's report out from Eccezion's Audit Partner, Cheryden Juergensen. Copies of the audit report will be distributed to board members, Kane County Regional Office of Education, Kane County Tax Extension Office and are posted to our website.

Enclosed is the 2025 tax levy resolution to be approved by the Board. The levy figures have not changed from what was presented at our November 17th board meeting. The levy request calls for an approximate 4.99% increase in the operating funds over last year’s extension, but we anticipate an estimated 6.93% decrease in actual dollars received. Our bond payments will decrease from \$9,418,950 to \$1,942,050 due to 2013’s bond debt being paid off. Total EAV is projected to be approximately \$1,268,500,000 and new construction is projected at \$24,200,000. With these assumptions we are anticipating our Total School Tax Rate to decrease from \$5.87 to \$4.95 for this levy year.

A Truth in Taxation public hearing was not required this year. Cash balances from the Treasurer’s report as of November 30, 2025, fund balance reserves from the Audit/AFR as of June 30, 2025 and the operating funds expenditures three-year average are listed below:

We are recommending that we approve this final aggregate tax levy for 2025.

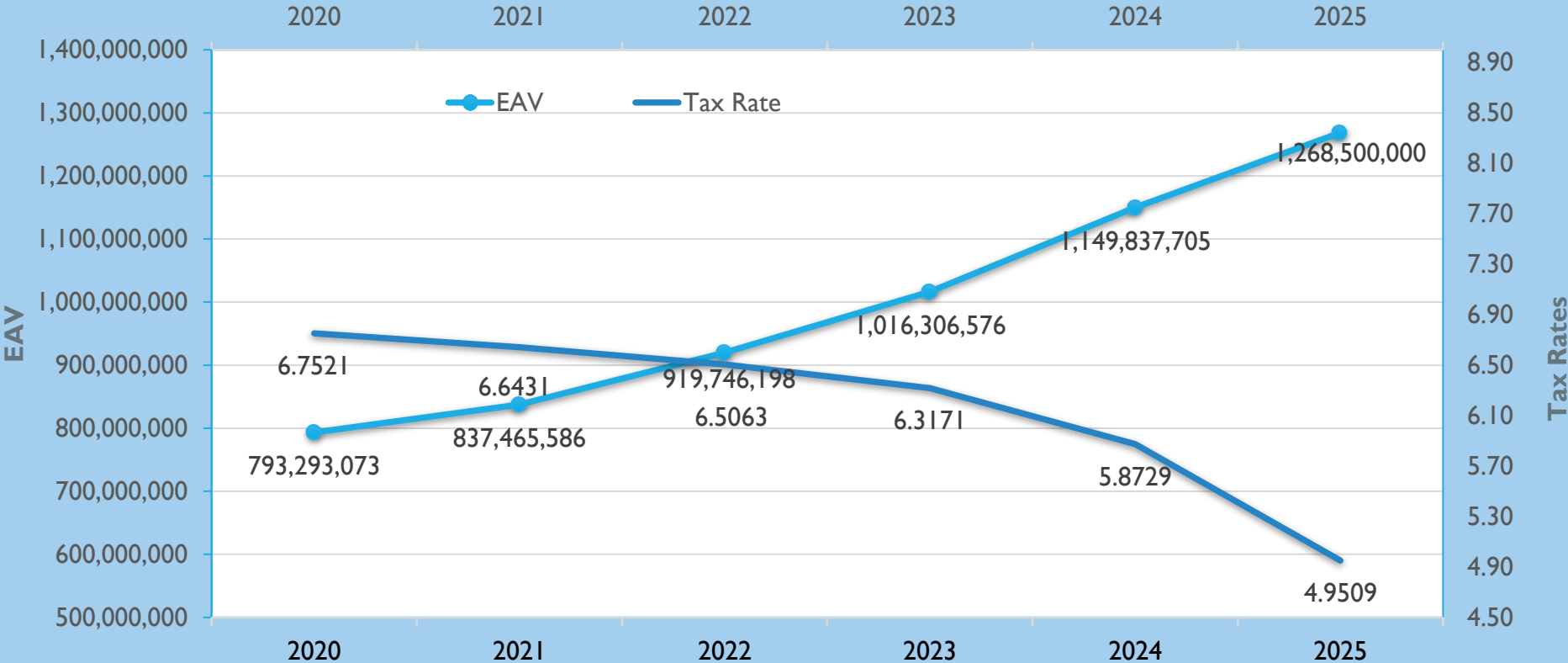

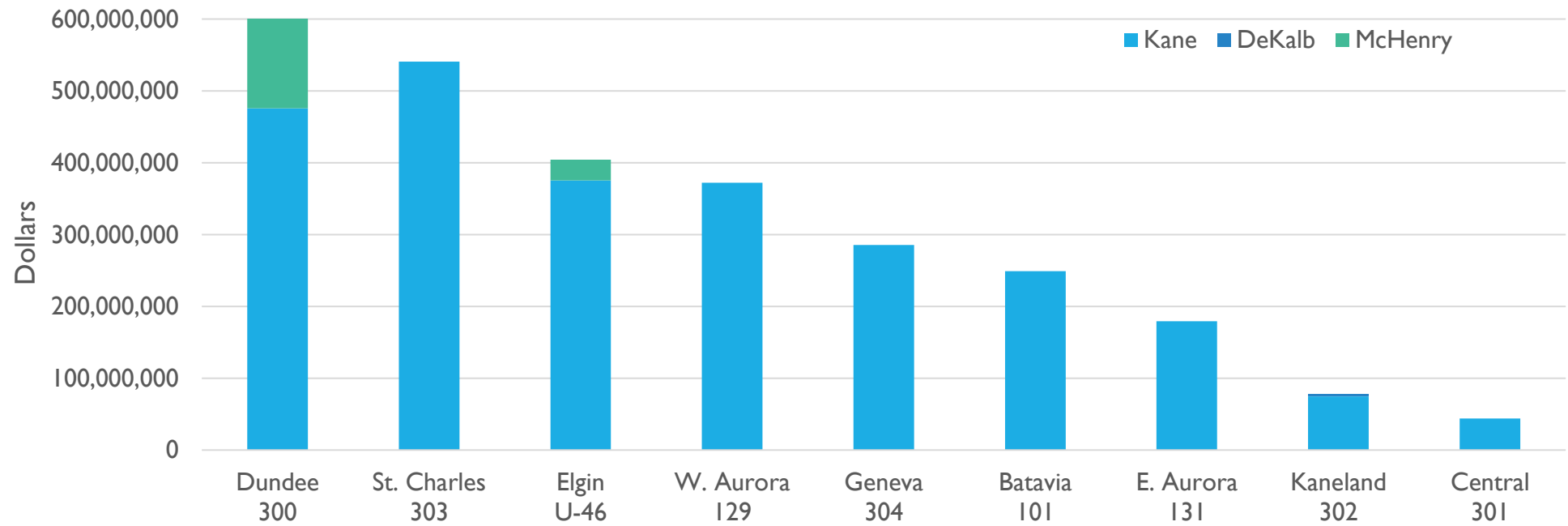

### **Purpose:**

The Purpose of this Memorandum is to recommend that Central School District 301 introduce Girls' Flag Football as a competitive sport beginning in the 2026 - 2027 school year, aligning with the Illinois High School Association's (IHSA) continued expansion of the sport.

### **Background:**

Girls' Flag Football has seen rapid growth statewide and nationally. The IHSA has recognized this momentum by supporting and organizing girls' flag football competitions, including postseason opportunities and official partnerships with athletic organizations. Many Illinois districts have already established programs or pilot teams, and participation continues to rise each year.
