### BACKGROUND:

This item was placed on the agenda at the request of Mr. Paul Panos, with the support of BOE President David Furie, BOE Vice President Leonard Lockhart, BOE Secretary Ayana Taylor and board members Jill Canter, Jeremy Halek, and Darleen Klase (as of 8:40 AM on 8/28/23).

Per Mr. Panos' reason for the request: Since the presentation to the Board on this issue last year, even an engineering study has not yet been authorized by the Town Council for a long term solution, or even a short term solution.

The BoE facilities people have done cleaning and the Town facilities people have done air testing. But the mold has reappeared, especially with the wet summer we have been having.

The Board needs to discuss what can be done immediately for the current school year to mitigate the OE mold problem to some degree, such as purchase or rent several more dehumidifiers, authorize deep cleaning, authorize investigation for mold that is hidden behind ceiling tiles, etc. We may have some questions of the facilities people.

This may require Board action.
