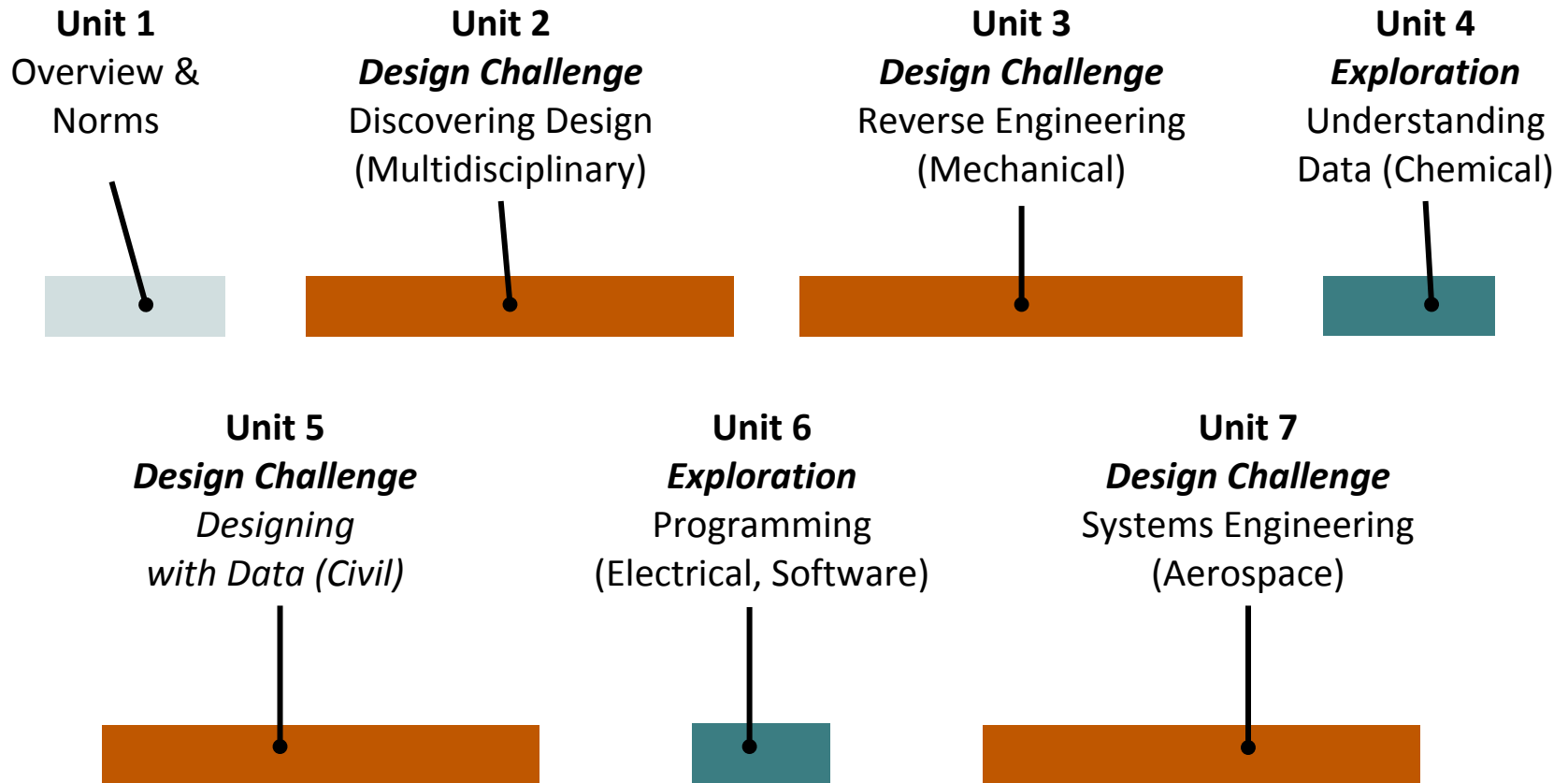

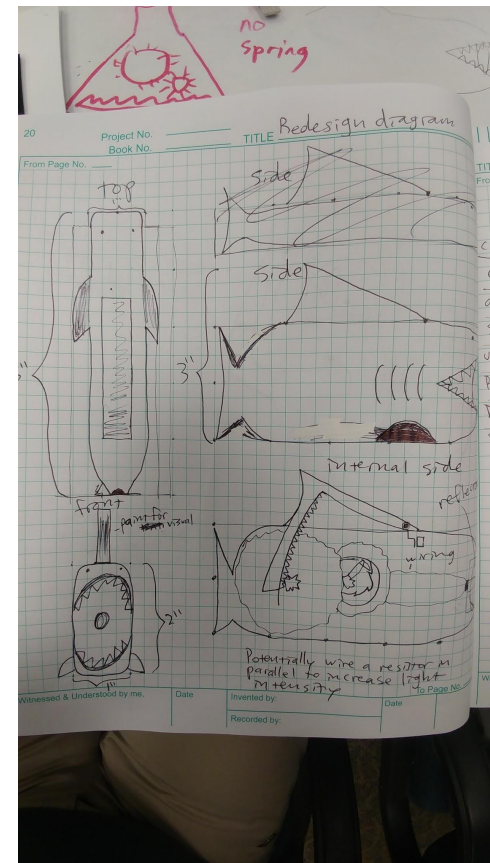
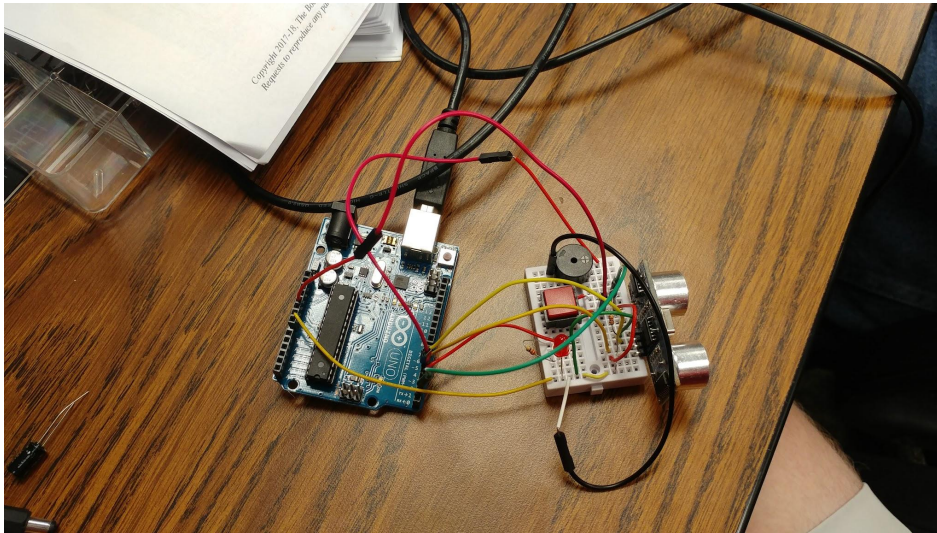

New Texas Laws Regarding Public Education

- SB 463 by Sen. Seliger
 - Extends IGCs for 2 more years (Sept. 2019)
 - Creates a path to graduation for students subject to earlier assessment programs.
 - Alternative assessments
 - Work, military or life experiences
 - Decisions are final and cannot be appealed
 - Requires THECB to conduct follow-up studies of IGC graduates

Laws (Cont'd)

- HB 657 by Rep. Bernal
 - Parental notice by Sept. 1 of ARD options if student does not pass state assessment.
 - ARD meeting must be held before retesting a student in special education who fails STAAR.
 - ARD committee may promote a student if sufficient progress is made on goals in IEP.
 - District is not compelled to provide additional retest opportunities to a promoted student.

Laws (Cont'd)

- HB 1886 by Rep. Miller
 - Licensed dyslexia therapist at each ESC
 - Revisions to individual transition planning for students with disabilities (most in SY 18-19).
 - Dyslexia screening or testing mandatory at end of KG & 1st grade each year (SY 17-18).
 - TEA must post list of dyslexia-related training opportunities to its web site each year.
 - At least one opportunity must be online

Laws (Cont'd)

- SB 826 by Sen. Taylor
 - Gives students flexibility in high school English, Math course sequencing.
- SB 671 by Sen. Campbell
 - Foreign language credit for successful completion of dual language immersion program in elementary school.

Laws (Cont'd)

- HB 3593 by Rep. Bernal
 - Districts may offer a course for local credit in cybersecurity.
 - SBOE to approve courses in cybersecurity for graduation credit.
 - Five tech apps courses to be identified as a cybersecurity pathway within STEM endorsement.
 - Computer coding can substitute for up to 2 foreign language credits for graduation.

Laws (Cont'd)

- HB 674 by Johnson & Garcia: Relating to the suspension of a student younger than third grade.
- SB 179 by Menendez: Relating to student harassment, bullying, cyberbullying, injury to or death of a minor. “David’s Law”

Laws (Cont'd)

- SB 825 by Ch. Taylor
 - Districts *may* (no longer shall) administer “preliminary college preparation” tests to students in 8th and/or 10th grades at state cost.
- SB 1843 by Sen. Campbell
 - Districts and charters must give 10th-12th grade students an opportunity to take ASVAB and consult with a recruiter.
 - Certain exceptions provided... but you'll be on list published on TEA's web site.

Laws (Cont'd)

- SB 1005 by Sen. Campbell
 - Commissioner not required to maintain TAKS after Sept. 1, 2017.
 - Commissioner sets cut points on SAT, ACT, EOC or TSIA diagnostic tests.
 - Students subject to pre-STEAR graduation exam requirements can retake TAKS or any of the above tests.
 - Districts determine which assessment(s) can qualify the students for HS diploma.

Laws (Cont'd)

- SB 1152 by Sen. Menendez:
 - Excused absences to pursue enlistment if student is at least 17, uses no more than 4 days for this purpose, and district verifies.

HB 22 by Ch. Huberty (A-F Accountability Ratings)

- 3 domains
- One-year delay in assigning A-F ratings to campuses (not districts)
- Differentiates between “D” and “F”
- Concept of Local Accountability System

Attendance Leveling and Zone Planning-Parameters

OPTIMIZE SPACE

- Efficient and equitable use of current and future school facilities to reduce overcrowding and address growth.

BALANCING

- Create zones that addresses growth, while also maintaining a principle to achieve balance in funding and program equity. Consideration will also be given to the socioeconomic make-up of each attendance zone.

NEIGHBORHOOD UNITY

- Every reasonable effort will be made to keep subdivisions and neighborhoods together.

CONTIGUOUS BOUNDARIES

- will be considered to prevent isolation of areas from surrounding neighborhoods



Attendance Leveling and Zone Planning-Parameters

NATURAL LINES

- To the extent possible, natural boundary lines and geographic demarks shall be utilized in leveling and creating new attendance zones.

GROWTH

- All reasonable efforts will be utilized to address existing and future development so that lines do not have to be re-drawn between scheduled campus openings and with an eye towards rational “feeder patterns.” A goal is re-drawn attendance zones should be designed to serve the district for the next 3-5 years.
- FEEDER PATTERN ALIGNMENT- All reasonable efforts will be made to keep students together as they travel through elementary and middle school.

FAMILY IMPACT

- All reasonable efforts will be made to consider the impact that changing attendance zones will have on families. Appropriate and reasonable “Grandfathering” options shall be considered in transitioning to new attendance zones..

TRANSPORTATION COSTS

- All efforts in rezoning shall include consideration and impact to routing efficiencies.

Concerning SB 693 Relating to Three-Point Seatbelts on Buses that Transport
Schoolchildren

STATE OF TEXAS §

WHEREAS, the Texas Legislature has enacted legislation, namely SB 693, requiring that “a bus operated by or contracted for use by a school district for the transportation of schoolchildren shall be equipped with a three-point seat belt for each passenger, including the operator”; and

WHEREAS, SB 693 specifically requires three-point seat belts on buses purchased which are model year 2018 or later; and

WHEREAS, the legislature allocated no funding for the equipping of school buses with seat belts; and

WHEREAS, the legislation only allows local school boards to opt out of the requirement if it “determines that the district’s budget does not permit the district to purchase a bus that is equipped with the seatbelts required”; and

WHEREAS, school buses are by far the safest mode of transportation to and from school; and

WHEREAS, school buses have an excellent safety record and research has shown that seat belts are not effective in most school bus crashes; and

WHEREAS, seat belts prevent students from exiting a bus quickly in the event of a fire or a water evacuation and a bus driver cannot possibly help every student to escape from seat belts in the event of a fire or if the bus is sinking in a body of water; and

WHEREAS, the legislation does not mandate the use of seat belts, only the equipping of buses with seat belts. The fact that buses are equipped with seat belts does not mean that they will be used or that they will be used properly; and

WHEREAS, seat belts could be used as weapons if a dispute were to occur between students; and

WHEREAS, because a school bus is large and weighs tons, collision impact is absorbed and the crash force is far less than that felt in an automobile; and

WHEREAS, students on a school bus are protected because they are above the impact zone if a crash occurs; and

WHEREAS, the National Highway Traffic Safety Administration has not recommended the installation of three-point seat belts on large school buses due to research that they have conducted; now, therefore, be it

RESOLVED, that the Medina Valley ISD Board of Trustees has determined that purchasing school buses with seat belts will put students in more danger than purchasing school buses without seat belts due to the reasons listed above; and, be it further

RESOLVED, that purchasing new school buses with seat belts would have the potential to cause a long-term financial strain on the District.

PROPOSED POLICY

The District shall support the general wellness of all students by implementing measurable goals to promote sound nutrition and student health and to reduce childhood obesity.

[See EHAA for information regarding the District's coordinated school health program.]

Development, Implementation, and Review of Guidelines and Goals

The local school health advisory council (SHAC), on behalf of the District, shall review and consider evidence-based strategies and techniques and shall develop nutrition guidelines and wellness goals as required by law. In the development, implementation, and review of these guidelines and goals, the SHAC shall permit participation by parents, students, representatives of the District's food service provider, physical education teachers, school health professionals, members of the Board, school administrators, and members of the public.

[See BDF for required membership of the SHAC.]

Wellness Plan

The SHAC shall develop a wellness plan to implement the District's nutrition guidelines and wellness goals. The wellness plan shall, at a minimum, address:

1. Strategies for soliciting involvement by and input from persons interested in the wellness plan and policy;
2. Objectives, benchmarks, and activities for implementing the wellness goals;
3. Methods for measuring implementation of the wellness goals;
4. The District's standards for foods and beverages provided, but not sold, to students during the school day on a school campus; and
5. The manner of communicating to the public applicable information about the District's wellness policy and plan.

The SHAC shall review and revise the plan on a regular basis and recommend revisions to the wellness policy when necessary.

Nutrition Guidelines

Foods and Beverages Sold

The District's nutrition guidelines for reimbursable school meals and all other foods and beverages sold or marketed to students during the school day shall be designed to promote student health and reduce childhood obesity and shall be at least as restrictive as federal regulations and guidance, except when the District allows an exemption for fundraising activities as authorized by state and federal rules. [See CO and FJ]

The District shall establish standards for all foods and beverages provided, but not sold, to students during the school day. These standards shall be addressed in the District's wellness plan.

Wellness Goals

Nutrition Promotion
and Education

The District shall implement, in accordance with law, a coordinated school health program with a nutrition education component. [See EHAA] The District's nutrition promotion activities shall encourage participation in the National School Lunch Program, the School Breakfast Program, and any other supplemental food and nutrition programs offered by the District.

The District establishes the following goals for nutrition promotion:

1. The District's food service staff, teachers, and other District personnel shall consistently promote healthy nutrition messages in cafeterias, classrooms, and other appropriate settings.
2. The District shall share educational nutrition information with families and the general public to promote healthy nutrition choices and positively influence the health of students.

The District establishes the following goals for nutrition education:

1. The District shall deliver nutrition education that fosters the adoption and maintenance of healthy eating behaviors.
2. The District shall make nutrition education a District-wide priority and shall integrate nutrition education into other areas of the curriculum, as appropriate.

Physical Activity

The District shall implement, in accordance with law, a coordinated health program with physical education and physical activity components and shall offer at least the required amount of physical activity for all grades. [See BDF, EHAA, EHAB, and EHAC]

The District establishes the following goals for physical activity:

1. The District shall provide an environment that fosters safe, enjoyable, and developmentally appropriate fitness activities for all students, including those who are not participating in physical education classes or competitive sports.
2. The District shall make appropriate training and other activities available to District employees in order to promote enjoyable, lifelong physical activity for District employees and students.
3. The District shall encourage parents to support their children's participation, to be active role models, and to include physical activity in family events.

4. The District shall encourage students, parents, staff, and community members to use the District's recreational facilities, such as tracks, playgrounds, and the like, that are available outside of the school day. [See GKD]

Other School-Based
Activities

The District establishes the following goals to create an environment conducive to healthful eating and physical activity and to promote and express a consistent wellness message through other school-based activities:

1. The District shall allow sufficient time for students to eat meals in cafeteria facilities that are clean, safe, and comfortable.
2. The District shall promote wellness for students and their families at suitable District and campus activities.
3. The District shall promote employee wellness activities and involvement at suitable District and campus activities.

Implementation

The executive director of curriculum, instruction, and assessment shall oversee the implementation of this policy and the development and implementation of the wellness plan and appropriate administrative procedures.

Evaluation

The District shall comply with federal requirements for evaluating this policy and the wellness plan.

Public Notification

The District shall annually inform and update the public about the content and implementation of the wellness policy, including posting on its website copies of the wellness policy, the wellness plan, and the required implementation assessment.

Records Retention

The District shall retain all the required records associated with the wellness policy, in accordance with law and the District's records management program. [See CPC and FFA(LEGAL)]

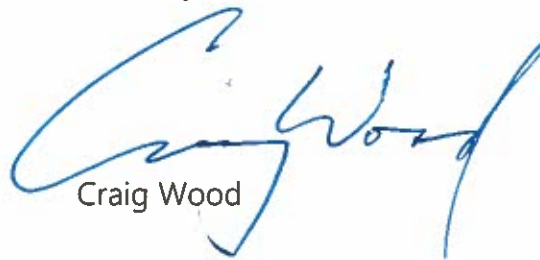

**LEGAL SERVICES RETAINER AGREEMENT
FOR MEDINA VALLEY INDEPENDENT SCHOOL DISTRICT**

The Medina Valley Independent School District (hereinafter "District"), acting by and through the authorized Trustee or Employee whose signature appears below, hereby retains the law firm of Walsh Gallegos Treviño Russo & Kyle P.C. (hereinafter "Law Firm"), to provide the services to the District set forth below.

1. Telephone Consultation: The Law Firm shall provide telephone consultation at no charge to the District's Board President, Superintendent, Special Education Director, or designee pertaining to questions arising out of the general operation of the District. The District shall have access to a statewide toll-free telephone number for calls to the Law Firm.
2. Additional Legal Work: The District shall be entitled to reduced hourly rates for additional legal work over and above general telephone consultation. Examples of such additional legal work are research, opinion letters, and legal advice or representation in adversarial matters. Expenses incurred by the Law Firm in providing such additional legal work shall be charged.
3. Publications: The Law Firm shall provide at no charge the monthly publication This Just In, dealing with special education law issues, and the bi-monthly general school law publication Time Out with Walsh Gallegos, both published by the Law Firm.
4. E-mail Updates: The Law Firm shall send periodic e-mail updates to designated District personnel and trustees relating to developments in school law. The content and publication schedule of such updates shall be determined solely by the Law Firm.
5. Retainer Term and Cost: There shall be a fee of \$1,000.00 for this Retainer Agreement due upon execution and annually thereafter on the anniversary of the execution date below. This Retainer Agreement shall remain in effect until notice of cancellation is received.
6. Compliance with HB 89: The Law Firm does not boycott Israel and will not boycott Israel during the term of this contract.
7. Scope of Attorney-Client Relationship: This Retainer Agreement establishes a limited attorney-client relationship only between the Law Firm and the District. The relationship exists only as to the consultations and additional legal work that are initiated by the District and accepted by the Law Firm pursuant to this Agreement. The Retainer Agreement does not impose any duty upon the Law Firm to provide advice or work to the District regarding legal matters absent a request by the District's Board President, Superintendent, Special

Education Director, or designee for such advice or work on a matter. The Law Firm and the District acknowledge and represent that this Agreement does not establish an attorney-client relationship between the Law Firm and any individual Trustees or Employees of the District. If a lawsuit or other adversarial matter is brought against the District and/or any Trustee or Employee of the District, the Law Firm may require the execution of one or more separate Letters of Engagement prior to undertaking an attorney-client relationship in the matter.

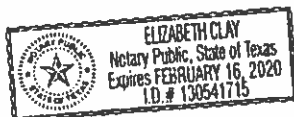

~REGULAR SEASON~

Swimming & Diving Regulations

An official starting date and final swimming and diving meet have not been set by the Legislative Council. A starting date should be set by school administration.

- No student representing a participant school shall participate in more than eight meets during the school year, excluding one district meet, the regional meet and the state meet. Each meet a school team enters counts as one meet for each participating individual.
- School week: A student or team representing a member school shall participate in no more than one scrimmage, contest, or meet per school week. School week is defined as beginning at 12:01 am on the first instructional day of a calendar week and ends at the close of instruction on the last instructional day of the calendar week, excluding holidays.
- Meets, which are limited to three or fewer schools, do not count as a meet for teams or participants, provided there is no loss of school time.
- It is considered a school meet if a student is wearing or using school equipment, being transported by the school or is being directed in the meet by a school district coach.

Rules. The swimming and diving rules are available in the current National Federation Swimming and Diving Rules Book and shall be enforced in all League meets. Rulebooks can be purchased from the National Federation, Box 361246, Indianapolis, IN 46236-5324; 1-800-776-3462 or www.nfhs.org.

Events for District, Regional, and State.

Boys and girls events for district, regional and state meets shall be as follows:

- 200 Yard Medley Relay
- 100 Yard Freestyle
- 200 Yard Freestyle
- 500 Yard Freestyle
- 200 Yard Individual Medley
- 200 Yard Freestyle Relay
- 50 Yard Freestyle
- 1 Meter Diving
- 100 Yard Breaststroke
- 100 Yard Butterfly
- 400 Yard Freestyle Relay

Entry Limitations.

A competitor shall be permitted to enter 2 individuals and / or 2 relay events; or 4 events, no more than 2 of which may be individual (3 relays and 1 individual is permissible). Only eligible students are allowed to compete at UIL member school hosted meets.

- Exhibition heats and unattached athletes are not allowed at any UIL swimming and diving competition.
- When more than one relay entry per school is allowed, A & B team members must remain the same for prelims and finals. A & B relays are not allowed to switch their membership from one relay to another.

Divisions. There shall be the following two divisions in the respective 5A and 6A conferences: a) boys; b) girls.

Classifications.

- Districts Meets. District swimming and diving chairmen shall be responsible for organizing the district meets.
- Regional and State Meets. There will be two classifications for regional and state meets.
 - Conference 5A and below schools
 - Conference 6A

Section 1290: SWIMMING PLAN

- (a) ATHLETIC PURPOSES, CODES, PLAN APPLICABLE. Rules in Sections 1200-1209 also apply to the Swimming Plan.
- (b) DIVISIONS. There shall be two divisions for high school boys and two divisions for high school girls, Conferences 6A and 5A and below.
- (c) ENTRIES.
 - (1) Girls', Boys' Team Restrictions. No girls' team shall compete against a boys' team and vice versa.
 - (2) District Entry. Each school shall submit the official entry files with qualifying times to the meet director on or before the fifth day prior to the district meet unless other arrangements have been authorized by the District Executive Committee.
 - (3) Regional Entry. It shall be the responsibility of the district director to submit the district report to the regional director by midnight of the final day of the district meet
 - (4) State Entry. It shall be the responsibility of the regional director to submit the regional report to the UIL office by midnight of the final day of the regional meet.
 - (5) Relay Events. In relay events, qualification is by school. Schools may change personnel on relay teams prior to the next UIL qualifying meet according to National Federation regulations.
- (d) SUBSTITUTION IN INDIVIDUAL EVENTS. After the entry deadline, there shall be no substitution allowed in the individual events according to National Federation Rules. If the individual place winner cannot compete in the next higher meet, the next place winner may be certified if time allows.
- (e) QUALIFICATIONS.
 - (1) Regional Meet Qualifications. It shall be the responsibility of the district director to submit the district report to the regional meet director by midnight of the day of the district meet. The regional director may contact alternate qualifiers to replace individual school entries who are scratched, if time permits.

- (2) **State Meet Qualifications.** It shall be the responsibility of the regional meet director to submit the regional report to the state meet director by midnight of the day of the regional meet. The UIL office shall contact additional qualifiers to the state meet after individual school entries are received.
- (f) **NUMBER OF MEETS.**
 - (1) **Number of Meets.** No student representing a member school shall participate in more than eight meets during the school year, excluding one district meet, the regional meet and the state meet. Each meet a school team enters counts as one meet for each participating individual. Students are considered to be representing their school if they are wearing and/or using school equipment or being directed or transported by a school employee. Meets, which are limited to three or fewer schools, do not count as a meet for participants, provided there is no loss of school time.
 - (2) **School Week Limitation.** No student representing a member school shall participate in more than one meet per school week (the first instructional day of the week through the last school day). **Exceptions:** The regional and state meet and district varsity meets postponed by weather or public disaster, may also be scheduled during the school week.
- (g) **CONSOLATION FINALS.** There shall be no consolation finals in district meets. See *Swimming Manual* for scoring.
- (h) **CHAMPIONSHIP STRUCTURE.**
 - (1) **District Meets.** District meets shall be held in districts with more than six individuals or relays in any event.
 - (2) **Qualifiers to Regional.** Top six individuals and relays shall qualify from district to regional.
 - (3) **Qualifiers to State.** The first place and second place in each of eight regional swimming meets and the next eight swimmers with the best regional final times overall will advance to the state meet.
 - (4) **Diving.** In diving, three divers will qualify at each of eight regional meets.
 - (5) **Timing.** Swimmers shall have been electronically timed unless the UIL office grants an exception.
 - (6) **Ties.** If ties occur for positions to the state competition, the times of the competitors from the regional preliminary competition will be considered first with the competitor with the fastest preliminary time advancing to the state meet. If a tie should still exist, then decision as to which qualifier will advance will be made by a coin toss.

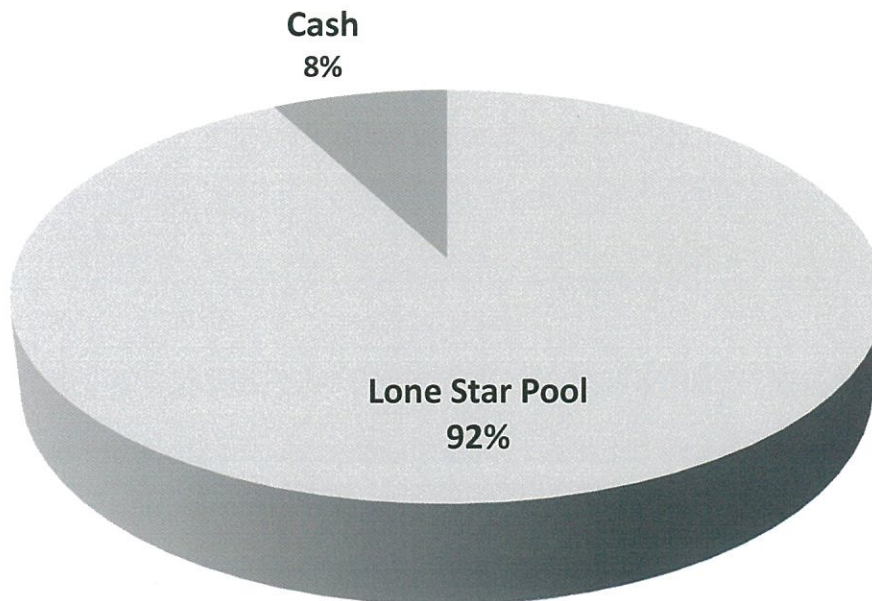
