WHEREAS, on February 12, 2021, the Governor of Texas issued a disaster declaration in all 254 counties in the State of Texas in response to the severe winter storm that impacted Texas;

WHEREAS, on February 20, 2021, the President of the United States issued a disaster declaration for 77 counties in the State of Texas, including Bell County, in response to the severe winter storm that impacted Texas;

WHEREAS, the recent severe winter storm resulted in the closure of all schools and facilities in the La Vega Independent School District ("La Vega ISD") on February 17, 2021, through February 19, 2021, due to dangerous travel conditions, power and water outages, and for the safety of students and staff and the community as a whole;

WHEREAS, District facilities sustained damage due to the severe winter storm, the extent of which is unknown to some degree at this time;

WHEREAS, Board Policy CH (Local) currently delegates to the Superintendent the authority to make budgeted purchases for goods or services, but any single budgeted purchase of goods or services that costs \$50,000 or more, requires Board approval before the transaction may take place;

WHEREAS, the Board of Trustees recognizes it may be necessary in the coming days or weeks to make unbudgeted purchases of goods or services in excess of \$50,000 to remedy damage caused by this extreme winter weather event; and,

WHEREAS, the Board of Trustees recognizes the value in authorizing the Superintendent to make unbudgeted purchased in excess of \$50,000 to efficiently remedy damage caused by this extreme winter weather event; and

WHEREAS, because of the damage to school facilities caused by this extreme winter weather event, compliance with Policy CH (Legal), CH (Local), Texas Education Code, Section 44.031(a), will result in delays that will prevent or substantially impair the conduct of classes or other essential school activities;

#### Now therefore be it resolved by the Board that:

- 1. All of the above-referenced paragraphs are incorporated into and made part of this resolution; and
- 2. The Board authorizes the Superintendent, in consultation with the Board President, to make unbudgeted purchases for goods and services to remedy damage caused by this extreme winter weather event, above \$50,000; and

- 3. Such purchases will be reported to the Board of Trustees at the next meeting of the Board of Trustees after the purchase; and
- 4. The Superintendent will direct the appropriate staff to amend the budget when appropriate and necessary to address the purchase; and
- 5. This spending authorization to address damage caused by the recent extreme winter weather event will remain effective until the last day of the 2020-2021 school year, unless extended by the Board of Trustees by Board action at a later date; and
- 6. The Board determines that, for the duration of the Declarations of Disaster by the Governor of Texas and the President of the United States, the delay posed by the procurement methods required by Texas Education Code, Section 44.031 would prevent or substantially impair the conduct of classes or other essential school functions; and
- 7. The Board finds that to the extent possible, the term of any contracts awarded pursuant to Texas Education Code Section 44.031(h) shall not extend longer than reasonably necessary to respond to the Declarations of Disaster; and
- 8. The Board finds that the District's best interests are served by delegating authority to the Superintendent to procure, negotiate and contract for goods and services required to repair damage to school facilities caused by the extreme winter weather event, subject to compliance with the scope set forth in this resolution; and:
- 9. The suspension of the requirements of CH (Legal), CH (Local), and Texas Education Code, Section 44.031(a) is solely for the duration of the Declarations of Disaster, temporary and limited, and shall not extend longer than reasonably necessary to respond to and repair the damage caused by the recent extreme winter weather event.

Background Information: Coach Hyde, Mr. Gooden, and Mr. Garrett met with Hellas Construction regarding the current condition of the track surface. It was determined that portions of the track had deteriorated to a point that it is now deemed a safety hazard. The track was installed in 2009 and has lasted long past its warranty stage Track surfaces generally last 8-10 years, and we are on year 12. As you know, the track repair has beer at the top of our projects list the past two years. We have postponed the repair in order to complete the addition to the High School as well as repair and replace roofs around the District. We cannot postpone any longer. We are scheduled to host four track meets this year as well as the normal use our track gets on a daily basis by physical education and athletic period classes.
Hellas advised us that they could temporarily patch the portions of the track that needed the mos attention in time for track season this year. They would provide that service free of charge. Then they could come back in this summer, remove the current surface, and replace it with a surface that will las another 11 years.
<u>Fiscal Implication:</u> The current bid is \$237,169 and that includes immediate repair of the safety hazard areas to get us through this year and full surface replacement beginning this summer
