Background Information:

After the passing of HB 1482, The LVISD District of Innovation Plan allows the district to have the flexibility to hire individuals who are knowledgeable in the area and equipped to effectively perform the duties of the position in question. An individual with experience in the content of an elective course (not core content) is eligible to teach a vocational skill or elective course through a local teaching certificate. The principal and HR department maintains documentation of credentials or life experience the teacher possesses that qualifies this individual to teach the proposed subject. LVISD will ensure that all individuals assigned to teach have the knowledge and resources necessary to be successful. The superintendent will report to the Board of Trustees following the assignment of a locally certified individual.
