### Background Information:

In a joint project between the county, the City of Waco, the City of Bellmead, and the City of Lacy-Lakeview, there will be a replacement of the current sewer line that starts in the City of Waco and runs through our school district out past the TSTC campus. The line was originally installed in the mid 1970's and is badly in need of replacement.

The specific impact to our District will occur when the line passes under Loop 340 and continues down Williams Road. The line will run in front of our Administration Building and continue down Williams Road in front of H.P. Miles. We have no authority to block the easement. The agreement merely protects the District by ensuring that any digging or demolition that needs to be done on or near our property will be restored at the same or better condition when the project is finished.

There is no definite timeline on the project. It will begin on the other side of the Brazos River and will work north east until it gets to our District.

**Permanent Easement Property:** Being a 40.01 feet wide easement, 1.178 acre of land, being part of the H.P. Miles School Subdivision to the City of Bellmead, McLennan County, Texas, according to the plat recorded in McLennan County Clerk's Document 2011007116 of the Deed Records of McLennan County, Texas and being more particularly described in the field notes attached as Exhibit A and shown on the survey plat/drawing attached as Exhibit B.

**Facilities:** Raw, reclaimed or re-use, and potable water lines and wastewater lines, drainage channels and lines (above or below ground), and all associated appurtenances to these water, wastewater, and drainage channels and lines.

**Easement Duration:** The duration of the Easement is perpetual, until all of the Facilities shall be abandoned. If abandoned, said easement shall cease and all rights herein granted shall terminate and revert to Grantor or Grantor's successors or assigns.

**Easement Purpose:** To install, construct, operate, use, maintain, repair, modify, upgrade, monitor, inspect, replace, make connections with, remove, and decommission/abandon in place the Facilities in, over, under, on, and across the Easement Property. The Easement is nonexclusive and irrevocable.

**Consideration:** The sum of Ten and No/100 Dollars (\$10) and other goods and valuable consideration, the receipt and sufficiency of which are acknowledged by Grantor. The consideration recited herein shall constitute payment in full for all damages, including costs, sustained by Grantor resulting from the easement and installation of the Facilities referred to herein.

**Permitted Encumbrances:** Any easements, liens, encumbrances, and other matters not subordinated to the Easement Property and of record in the Real Property Records of



the McLennan County, Texas that are valid, existing, and affect the Easement Property as of the Date the Easement is executed.

**Grant of Easement:** Grantor, for the Consideration, grants, sells, and conveys to Grantee and Grantee's heirs, successors, and assigns an easement in, over, under, on, and across the Easement Property for the Easement Purpose, together with all and singular the rights and appurtenances thereto in any way belonging (collectively, the "Easement"), to have and to hold the Easement to Grantee and Grantee's heirs, successors, and assigns forever. This Easement shall constitute a conveyance and covenant running with the land for the benefit of Grantee, its successors and assigns.

Grantor covenants that s/he/it is the owner of the above-described land, and that said land is free and clear from all encumbrances and liens. Grantor binds Grantor and Grantor's heirs, successors, and assigns to warrant and forever defend the title to the Easement in Grantee and Grantee's heirs, successors, and assigns against every person whomsoever lawfully claims the Easement or any part of the Easement, subject to the Permitted Encumbrances.

Grantee shall have such other rights as are necessary for the full enjoyment and use of the rights herein granted, including without limitation, to: (1) prevent excavation within the easement area; (2) prevent construction of any and all buildings, structures or other obstructions which, in the sole judgment of Grantee injure the Facilities or interfere with the construction, maintenance, inspection, operation, protection, use, repair, alteration, replacement, upgrading, relocation, or removal thereof; (3) trim or remove trees, shrubbery, or undergrowth within, but not limited to, said Easement area, to the extent in the sole judgment of Grantee, as may be necessary to prevent possible interference with the construction, maintenance, inspection, operation, protection, use, repair, alteration, replacement, upgrading, relocation, or removal of the Facilities; and (4) abandon in place any Facilities such that Grantee shall have no obligation or liability to Grantor or its successors or assigns to move or remove any such abandoned Facilities.

Grantor shall not make changes in grade, elevation, or contour of the land within the easement area as described above without prior written consent of Grantee. The installation, construction, operation, use, maintenance, repair, modification, upgrade or replacement of any structure, fence, building, retaining wall, detention or water quality control, rainwater harvesting system, tree, or other similar improvement in the Easement Property must be approved in writing in advance by the City.

Grantor recognizes that the general course of said lines and appurtenances to be constructed, or the metes and bounds as described herein, is based on preliminary surveys only, and Grantor hereby agrees that this easement and its general dimensions hereby granted shall apply to the actual location of said lines and appurtenances to be constructed when constructed.

**Temporary Construction Easement:**

Grantor further grants to Grantee an approximately 0.644 acre Temporary Construction Easement in, on, over, under, along, through, and across Grantor's property and shown on the survey plat/drawing attached as Exhibit B, for all of the purposes described in the above Easement Purpose, and including ingress, egress, and storing materials on the said Temporary Construction Easement during and throughout the period of construction of the Facilities. The Temporary Construction Easement will become effective upon execution of this document and will terminate no later than ninety (90) days after completion of the initial pipeline. The termination of this Temporary Construction Easement shall not, in any way, cancel, terminate, reduce, or diminish the Easement

Grantee agrees to record this document in the public records of McLennan County, Texas and supply Grantor with a copy of the recorded Perpetual Easement to the City of Waco within forty-five (45) days after execution of this Perpetual Easement to the City of Waco.
