The attached Job Description is for a new position.

La Vega Primary Campus-Phil Bancale Campus operates 2 separate PPCD (preschool program for children with disabilities) classrooms serving our most severe and profound students. The campus started the school year with 14 PPCD students and unable to fill a PPCD teacher vacancy. Since the start of the school year, LVPS-PBC has added 8 students to the classroom. Due to the inability to fill the vacancy and increasing numbers, the District is proposing to utilize two individuals that have obtained an Associates of Art Degree in Teaching/Early Childhood. The certification program provides an introduction into teaching students in early childhood through 12th grade. The degree is 60 credit hours and is generally used as a precursor to a Bachelor's degree. The Special Education Teacher Associate would create lesson plans and deliver instruction to a group of students under the supervision of a special education certified teacher.

The only change to the Pay scale is the addition of the new teacher associate teacher position (S-503).

1. Develop and implement lesson plans that fulfill the requirements of district's curriculum program and show written evidence of preparation as required. Prepare lessons that reflect accommodations for differences in individual student differences.

Plan and use appropriate instructional and learning strategies, activities, materials, equipment, and technology that reflect understanding of the learning styles and needs of students assigned and present subject matter according to guidelines established by Texas Education Agency, board policies, and administrative regulations.



3. Conduct assessment of student learning styles and use results to plan instructional activities.
4. Present subject matter effectively and according to guidelines established by IEP. Employ a variety of instructional techniques and media, including technology, to meet the needs and capabilities of each student assigned.
5. Work cooperatively with classroom teachers to modify curricula as needed for special education students according to guidelines established in Individual Education Plans (IEP).
6. Work with other members of staff to determine instructional goals, objectives, and methods according to district requirements.

Student Growth and Development

7. Conduct ongoing assessment of student achievement through formal and informal testing.
8. Provide or supervise personal care, medical care, and feeding of students.
9. Assume responsibility for extracurricular activities as assigned. Sponsor outside activities approved by the campus principal.
10. Consult district and outside resource people regarding education, social, medical, and personal needs of students.
11. Be a positive role model for students; support mission of school district.

Classroom Management and Organization

12. Create classroom environment conducive to learning and appropriate for the physical, social, and emotional development of students.
13. Manage student behavior and administer discipline, including intervening in crisis situations and physically restraining students as necessary according to IEP and in accordance with Student Code of Conduct and student handbook.
14. Take all necessary and reasonable precautions to protect students, equipment, materials, and facilities.
15. Compile, maintain, and file all reports, records, and other documents required.
16. Plan and assign the work of teacher aide(s) and volunteer(s) and oversee completion.

Communication

17. Establish and maintain a professional relationship and open communication with parents, students, colleagues, principals, and community members.

Professional Growth and Development

18. Participate in staff development activities to improve job-related skills.
19. Comply with state, district, and school regulations and policies for classroom teachers.
20. Attend and participate in faculty meetings and serve on staff committees as required.
21. Keep informed of and comply with federal, state, district, and school regulations and policies for special education teachers.

22. Follow district safety protocols and emergency procedures.

Resolution Authorizing the District to Join Litigation Against the Texas Education Agency Challenging Lack of Transparency in Calculation of School District Accountability Ratings

WHEREAS, the A–F Accountability System is a statewide rating system established by the Texas Education Agency (“TEA”) that evaluates the academic performance of Texas public schools and assigns letter grades A–F to districts and campuses;

WHEREAS, the TEA has substantially changed the accountability ratings system in a manner that will impact every school district and campus in the state, meaning that the ratings expected to be issued in Fall 2023 for the 2022–2023 school year will be based on a different set of rules than previous A–F ratings, and making it impossible to compare the ratings issued by the TEA in 2022 and 2023 side by side;

WHEREAS, in violation of state law, the TEA did not provide the La Vega Independent School District (the “District”) information regarding the changes to the A–F Accountability System prior to the start of the 2022–2023 school year and, indeed, still has not provided a full explanation of the rules and methodologies that are being used to determine district and campus ratings;

WHEREAS, the La Vega Independent School District’s Board of Trustees (the “Board”) understands that certain school districts throughout the state are planning to file a lawsuit against the TEA to challenge the lack of transparency in the criteria used as part of the A–F Accountability System and to prohibit the TEA from issuing performance ratings for the 2022–2023 school year that are based on measures, methods, and procedures that were not provided to school districts prior to the start of the 2022–2023 school year, in violation of state law; and,

WHEREAS, the District has been harmed by the lack of advance notice of the criteria and methods the TEA is applying as part of the A–F Accountability System for the 2022–2023 school year, because the District does not know the expectations set by the State of Texas for schools districts and has been unable to adjust to the TEA’s new accountability measures and allocate District resources in a manner required to meet state standards.

NOW, THEREFORE, BE IT RESOLVED THAT the Board authorizes the District administration to join the proposed litigation against the TEA as a plaintiff to challenge the TEA’s failure to provide the District advance notice of the accountability performance measures, methods, and procedures that are being applied as part of the A–F Accountability System for the 2022–2023 school year before the start of that school year, in violation of state law. The Board authorizes the District administration to engage legal counsel to represent the District in the lawsuit against the TEA.

Background Information:

Primary

La Vega Primary Campus-Phil Bancale Campus operates 2 separate PPCD (preschool program for children with disabilities) classrooms serving our most severe and profound students. The campus started the school year with 14 PPCD students and unable to fill a PPCD teacher vacancy. Since the start of the school year, LVPS-PBC has added 8 students to the classroom. Due to the inability to fill the vacancy and increasing numbers, the District is proposing to utilize two individuals that have obtained an Associate's Degree in Teaching/Early Childhood under the job description presented in Consent Agenda.

Elementary

La Vega Elementary School began the school year with 11 students being served in the self-contained classroom. To date, the class size has increased by 6 students, creating the need for additional staff. Utilizing a staffing calculator that factors in the disability and needs of the students (such as toileting, behavior, etc.) the classroom should have 3.1071 staffing units (teacher = 1; paraprofessional = .5). The classroom currently has 1 teacher and 3 paraprofessionals. Adding an additional paraprofessional would adequately staff the classroom.

Intermediate

La Vega Intermediate School-HP Miles Campus had 64 students receiving instructional special education services at the end of last school year. To date, LVIS-HPM currently has 85 students receiving instructional special education services. In order to sufficiently meet the needs of the students and provide services, the campus requires an additional paraprofessional.

Fiscal Implication:

The positions will be funded through federal special education funds and, based on current enrollment trends, will be sustainable moving forward.
