#### **COMMITTEE REPORTS**

**Operations –** Commissioner Hintz reported that the committee met on June 20<sup>th</sup> and they had another robust discussion on the ways that the district can continue to reduce our energy consumption. Some of the highlights will be staggering computer updating so that computers can be turned off during the summer, monitoring things like small refrigerators, computers, and coffee makers. The feasibility study has begun. Dr. Moreau met with DRA for a kick off meeting; data gathering has begun. There was a brief discussion regarding snow removal; it will remain in committee for continued discussion. The committee also discussed building rental fees.

**Finance** – Commissioner Vibert reported that the committee met earlier this evening. Currently we are still expecting to have a \$500,000 surplus; we are still waiting on a few items to be added in. We will have a final end of year exact figure at our August meeting. In Food Services we are still thinking that we will end the year with a \$3,500 deficit; which includes pension contributions. This was made possible with the Community Eligibility Program that is run at Hubbell and West Bristol's school. Special Education population continues to rise; we are now at 19% which is above the state average of 12-14%. As our population rises, so does the cost, and while the services are needed, it just is not funded properly.

#### **CHAIRMAN REPORT**

Chairman Wilson reminded commissioners that the next two BOE meetings are not at the beginning of the month, but rather at the middle of month (August 16<sup>th</sup> and September 13<sup>th</sup>). He shared information regarding the CABE Delegate Assembly and the Legislative Wrap-Up.

#### SUPERINTENDENT REPORT

#### **End of Year Report**

Dr. Solek presented an End of Year Report to the Board. Dr. Solek reported on various programs, accolades, initiatives and general Board business that took place throughout the year. Some of the topics covered were: School Performance Visits, Teacher Leadership Program, BOE Negotiations, BOE Student Representatives, BOE CABE Level I Award, Special Education Review, 17-18 Budget Process, Technology Integration, Staff Awards and District Accountability & Performance. Questions followed regarding attrition numbers reported.

#### Writing Initiative

Dr. Moreau presented the Bristol Central Writing Initiative. Dr. Moreau called Gale Dickau who was present in the audience to the podium. Last week the ESPN Media-Zone headline read: Adrian Wojnarowski Joins ESPN. Adrian Wojnarowski is a native of Bristol. He is a 1987 graduate of Bristol Central High School. He credits his early interest in writing and journalism to Gale Dickau, an English teacher of 50 years at the school. In connection with his new agreement, and working with Mrs. Dickau later this year, Wojnarowski will fund and launch "The Writing Initiative" at Bristol Central High School – a multifaceted, ongoing program to encourage students to write and help them develop and hone their skills, provide scholarships and develop teacher enrichment programs for educators teaching writing.

In Adrian's words, "Whatever I've been able to achieve in my professional career, it is largely due to the foundation and nurturing provided to me by Gale Dickau and the educators at Bristol Central. I am honored to help Mrs. Dickau and BCHS provide platforms to train and inspire the next generation of writers and storytellers. I am a proud alumnus and excited to be a part of the Rams community again."

The Writing Initiative will fund and promote the fostering, enhancement, and celebration of writing excellence at Bristol Central High School. Among its goals, The Writing Initiative plans to establish an open writing lab where students and staff may explore personal, academic, and creative writing; schedule individual consultations on college application essays; fund writing contest prizes; host author and speaker events including workshops and readings; explore ongoing professional development for teachers; endow summer writing scholarships for gifted and talented student writers; award college grants to students pursuing writing curricula; and grow student publications on multi-media platforms.

#### Information

Commissioner Caggiano requested an update on the furlough day that was mentioned at last month's meeting. Chairman Wilson reported that he met with the leader of the union and it was decided that with negations coming up in August that the topic would be better suited for that platform. There would not have been enough time for a decision and consensus by all bargaining unions to capture the kind of savings they are anticipating. We chose not to pursue the furlough day at this time, it will be a topic at negotiations.

#### **Liaison Reports**

Commissioner Vibert reported that she attended the Bristol Eastern Graduation where 316 students graduated; 85% of the students are pursuing formal post-secondary educational options. The remaining students are either seeking employment, already employed or undecided. The percentage of students graduating, going to college, to the military or a certification program is up 5% since 2014 and up 7% since 2012.

Commissioner Vibert also shared a Bristol Schools' fun fact: recent graduate student Lucas Moring has never missed a day of school in his entire educational career.

At South Side School, students are busy signing up for the summer reading program; their goal is to keep their title of highest summer reading school for the third consecutive year. They are hosting the book mobile every Thursday from 11:30-1:30 p.m. They have great events planned, families will be notified via social media and Blackboard Connect; all Board commissioners are encouraged to attend.

Commissioner Taylor reported on two fundraising events for Greene Hills School: Monday, July 17<sup>th</sup> and Monday, August 12th, they will hold a fundraiser at Rita's; celebrity scoopers will be there waiting on patrons.


